Profit Sharing 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### **1. Description of Plan**

The following description of The Peplinski Group, Inc. Profit Sharing 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of The Peplinski Group, Inc., Lake County Care Center, Inc., J & A Healthcare Systems, Inc., Peplinski Investment, Inc., Continuum of Clio, Inc. Ardan, Inc. Ardan Associates, Inc., DeBoer, Inc., Bridgman Care Operating, LLC, Gladwin Pines Operating, LLC, and Stratford Pines Operating, LLC (Companies) who have completed 60 days of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. The Plan trustees are responsible for oversight of the Plan. The Plan trustees determine the appropriateness of the Plan's investment offerings and monitor investment performance.

#### **Contributions**

Each year, participants may contribute a percentage of their pretax or post tax compensation, not to exceed Internal Revenue Code (IRC) limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For those participants who have completed one year of service, the Companies contribute a safe harbor match which is 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's plan year compensation, and an additional 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's plan year compensation but does not exceed 5% of the participant's plan year compensation. The company makes discretionary profit-sharing contributions to the plan each year. Participants are eligible for these contributions when they attain the age of 21 and complete one year of service.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan (continued)

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon in addition to the Companies' safe harbor matching contributions.

The following vesting schedule, based upon a participant's years of service, applies to any employer nonelective profit sharing contributions:

<u>Years of Continuous Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years or more	100%

A year of service for vesting purposes is a plan year in which an employee works over 1,000 hours.

#### Payment of Benefits

Upon termination of service due to death, disability, or retirement a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or optional installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### Forfeited/Unallocated Accounts

Forfeited/unallocated accounts totaled \$21,358 as of December 31, 2024, and \$22,186 as of December 31, 2023. These accounts may be used to pay for Plan expenses or to reduce future employer contributions. Plan expenses that were paid from forfeited/unallocated accounts totaled \$529 in 2024 and \$8,335 in 2023.

#### Plan Termination

Although they have not expressed any intent to do so, the Companies have the right to terminate the Plan at any time. In the event the Plan is terminated, all participant account balances become fully vested and nonforfeitable. In the event of a partial plan termination, only those who separate from service shall be fully vested.

### **2. Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded when received. The change in aggregate fair value and the cost of investments purchased, sold, and held is reflected in the statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments.

#### **Administrative Expenses**

The administrative expenses of the Plan are paid by either the Plan or the Companies, as provided in the Plan agreement. All such costs and expenses paid from the Plan shall, unless allocable to the accounts of particular participants, be charged to the accounts of all participants as provided in the Plan agreement.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated subsequent events through September 22, 2025 which is the date the financial statements were available to be issued.

### **3. Financial Data Certified by the Trustees (unaudited)**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the investment balances, investment income (loss), and net appreciation (depreciation) in fair value of investments included in the accompanying financial statements and supplemental schedule, was obtained from data that has been prepared and certified as complete and accurate by the custodian, Empower Annuity Insurance Company of American and Empower Trust Company, LLC in 2024 and 2023.

### **4. Fair Value Measurements**

The Plan follows authoritative guidance on fair value measurements, which provides a framework for measuring fair value under U.S. Generally Accepted Accounting Principles. These standards apply to all financial instruments that are being measured and reported on a fair value basis.

As defined in authoritative guidance, fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In determining fair value, the Plan uses various methods including market, income, and cost approaches. Based on these approaches, the Plan often utilizes certain assumptions that market participants would use in pricing the asset or liability, including assumptions about risk or the risks inherent in the inputs to the valuation technique. These inputs can be readily observable, market corroborated, or generally unobservable inputs. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs.

Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values. Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories.

The three levels of the fair value hierarchy are as follows:

- Level 1 inputs are unadjusted quoted prices in active markets for identical assets or liabilities. These markets must be accessible to the Plan at the measurement date.
- Level 2 inputs are observable, market-based inputs, other than Level 1 prices. Level 2 inputs may include quoted prices for similar assets or liabilities in active markets, quoted prices in inactive markets, interest rates and yield curves observable at commonly quoted intervals, credit risks, default rates, and inputs derived from, or corroborated by, observable market data.
- Level 3 inputs are unobservable inputs that reflect the Plan's assumptions about how market participants would value the Plan's assets and liabilities.

### 4. Fair Value Measurements (continued)

Mutual funds are stated at fair value determined by quoted market prices of the underlying securities as reported by the custodian of the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **5. Guaranteed Investment Contract with Insurance Company**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of American and Empower Trust Company, LLC (formerly Great-West Life & Annuity Insurance Company) holding \$1,278,843 as of December 31, 2024, and \$1,222,182 as of December 31, 2023. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate was 1.41% for the year ended December 31, 2024, and 1.23% for the year ended December 31, 2023.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events may include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) bankruptcy of the plan sponsor or other plan sponsor events that cause a significant withdrawal from the Plan, or (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA of 1974. The Plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

### **6. Income Tax Status**

The volume submitter plan sponsor has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the volume submitter plan document was in compliance with applicable requirements of the IRC. Although the Plan has been amended since the date of the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Generally, tax years from 2021 through the current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Parties-in-interest**

Certain Plan investments are shares of mutual funds and a guaranteed investment contract managed by Empower in 2024 and 2023. Empower was the custodian in 2024 and 2023 as defined by the Plan; therefore, these investments qualify as party-in-interest transactions. Watkins Ross as third-party administrator, Wells Fargo Advisors LLC as investment advisor, and Empower Advisory Group LLC as investment manager also qualify as party-in-interest transactions. The auditor is also considered a party-in-interest for audit services provided to the Plan.
