Opinion

NOTE 1 - Description of the Plan

The following description of the Alliance, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established March 1, 2010 to provide health and other benefits to eligible participants. The sponsoring employer, Alliance, Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, short-term disability benefits, life and accidental death and dismemberment benefits for eligible participants and their dependents. The Plan provides many of these benefits with third party insurance companies contracts and on a self-funded basis. The Plan carries a stop-loss insurance policy, in an effort to limit its exposure for self-insured benefits. The Plan also provides Health Reimbursement Arrangement (HRA) benefits. The HRA benefit is self-funded and allows employees to be reimbursed for certain out of pocket health benefits incurred by participants.

Eligible employees will receive an allocation to a separate retirement plan for the remainder of fringe in excess of \$4.00 for class levels I to III for 2024 and 2023, and \$0 and \$4.42 for class IV for 2024 and 2023, respectively. These retirement contributions are reported as contribution income and then deducted as an expense.

Eligibility rules under the Plan require all employees hired as active employees to receive coverage the first of the month following two months of continuous employment on a fringe contract. Benefits terminate on the last day of the month in which a participant's employment terminates.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Benefit Claims Incurred, But Not Reported

The obligation for benefit claims, incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, but reported to and paid by the Plan after December 31. The estimate was calculated using available claims experience data and projected future claims.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Health Care Reimbursement Arrangement (HRA) Benefits

The Plan provides a Limited-Scope HRA for employees in Classes I, II, and III for dental and vision expenses up to an annual maximum from \$100 to \$300 based on class level; and HRA benefits to Class IV employees for eligible expenses up to an annual maximum of \$250 and \$1,000 for 2024 and 2023, respectively. Participants should refer to the Summary Plan Description for a complete description of the plan's provisions. Included in the accompany statement of net assets are amounts available to provided HRA benefits as of December 31, 2024 and 2023, totaled \$14,954 and \$31,415, respectively.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through July 30, 2025, the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustees believe that the Trust does not have any net taxable income for the tax years ended 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. received commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$27,676 and \$19,773 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 5 - Excess Loss Indemnity Policy

The Plan has entered into an excess loss insurance arrangement in an effort to limit its exposure for self-insured benefits. The Plan maintained an insurance policy with Fidelity Security Life Insurance Company during the years ended December 31, 2024 and 2023. The policy contains two excess loss provisions. The first of which applies to individual participant claims, whereby when the claims paid on behalf of an eligible participant or dependent exceeds \$100,000, during a policy year, respectively, the insurance carrier will reimburse the plan for 100% of the excess. The second provision involves aggregate plan claims, whereby when the total aggregate claims paid on behalf of all eligible participants or dependents exceed a specified amount based on the number of eligible participants and rate factors ("funding factor"), the insurance carrier will reimburse the Plan 100% of the excess up to a maximum aggregate amount of \$1,000,000, less the amount reimbursed for individuals under the specific individual policy noted above.

The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants which are funded by the Plan up to the funding factor and thereafter by the excess loss carrier as noted above. Despite the Plan's utilization of their-party claims processors, ultimate responsibility of payments to providers and participants is retained by the Plan.
