Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Medlink Georgia, Inc. 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Medlink Georgia, Inc. 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note 1: Description of the Plan

The following description of Medlink Georgia, Inc. (the “Company” and “Plan”) provides only general information. Participants should refer to the Plan Document, Adoption Agreement, and Summary Plan Description for a more complete description of the Plan’s provisions, which are available from the plan administrator.

General

The Plan is a defined contribution 403(b) Plan covering all permanent, full-time employees of the Company. Employees are eligible to participate upon their date of hire. The Plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan includes an “Automatic Deferral” rate schedule starting with an automatic deferral rate of 4% for a new participant (unless the participant elects out of it). As of the beginning of a Plan year, unless the participant opts-out, the Company will withhold from a participant’s compensation each payroll period, the Automatic Deferral percentage that corresponds to the number of Plan year(s) (or partial plan years) to which the participant has been subject to the Automatic Deferral arrangement, including the current Plan year.

The Plan excludes those who become Company employees as a result of an asset or stock acquisition, merger, or other similar transaction. These employees will be excluded during the period beginning on the date of the transaction and ending on the last day of the first Plan Year beginning after the date of the transaction. Employees whose contribution would be \$200 or less are also excluded from the Deferral portion of the Plan.

The Plan’s trustee and custodian is Empower Retirement Services. The Plan’s record keeper and third-party administrator is ERISA Services, Inc.

Contributions

Each year, participants may elect to defer up to 100% of their annual compensation or the maximum amount allowed and adjusted annually by the Secretary of the Treasury, as defined by the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Company generally makes matching contributions equal to 50% of the first 8% of deferral contributions (excluding catch-up contributions). Participants become eligible for matching contributions after completing 90 days of service, with a maximum of \$3,600 per Plan year.

Effective January 1, 2024, the Plan was amended to allow a discretionary match. The employer match was temporarily suspended during the amendment review and resumed in October 2024 at a 20% rate, with all participants notified.

Participant Investment Account Options

Investment account options include various types of investment securities offered by the Plan. Each participant has the option of directing his or her contributions into any of these investment securities and may change their allocations daily.

Participant Accounts

Each participant’s account is credited with the participant’s deferral contribution and allocations of the Company’s matching contribution, the Plan’s investment earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately 100% vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. The non-vested balance is forfeited upon termination of service. A participant is vested in the Company's matching contributions as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. No loan in an amount less than \$1,000 will be granted to any participant. Loans can be made for a period not to exceed five years unless for the purpose of purchasing a primary residence. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. Loans from this Plan may be used for any purpose. A participant can have only one outstanding loan at a time. The loan shall bear a commercially reasonable rate of interest commensurate with the prevailing interest rate charged on similar loans under like circumstances by persons in the business of lending money. The interest rate shall remain fixed or variable throughout the duration of the loan based on the type of loan applied for by the participant. Participants will be deemed to have defaulted on their loans if they fail to remit payments in a timely manner as required under the Promissory Note, breach any of their obligations or duties under the Promissory Note, or terminate employment. Principal and interest is paid through payroll deductions.

Payment of Benefits

Hardship withdrawals may be requested for medical expenses, purchase of a principal residence, prevention of eviction from or foreclosure on a principal residence, pay for post-secondary education, payments for burial or funeral expenses, pay expenses for the repair or damage to a principal residence, or any other immediate and heavy financial need as determined based on Internal Revenue Service regulations.

Starting in the calendar year in which a participant reaches the age of 72, an election may be made to receive distributions calculated in the same manner as Minimum Required Distributions.

There are withdrawals available for those serving in the Military who have or been called to active service in the Military Reserves as listed in the Summary Plan Description.

Upon termination of service due to death, disability, or retirement, a participant is entitled to 100% of his account balance. Benefits will be paid either in one lump-sum or installment payments. For termination of service due to other reasons, a participant is entitled to the value of his vested account balance.

Forfeited Accounts

Forfeitures consist of unvested Company contributions in participants' accounts at the conclusion of their participation in the Plan. Forfeitures are held in the Plan and are used to reduce future Company matching contributions. At December 31, 2024 and 2023, there were \$0 and \$0 in forfeited non-vested accounts, respectively. During 2024 and 2023, Company matching contributions were reduced by \$37,040 and \$25,861, respectively, from forfeited non-vested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan at the Company's discretion.

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for plan benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

Note 4: Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets

The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases, where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 5: Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Participant loans are loans made to employees/participants of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Direct expenses paid to service providers during the years ended December 31, 2024 and 2023 were \$65,986 and \$69,405, respectively.

The Plan parties-in-interest included ERISA Servies who acted as the third-party administrator and Empower Retirement, who acted as plan record keeper and who provided investment advisory services during the years ended December 31, 2024 and 2023.

The Company provides certain administrative services at no cost to the Plan.

Note 6: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for plan benefits.

Note 7: Tax Status

The Plan operates under a 403(b) Volume Submitter Prototype Plan sponsored by ERISA Services, Inc. The Plan is designed to qualify under Section 403(b) of the Internal Revenue Code. The terms of the plan have been prepared to conform with the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b). The Plan was amended and restated effective January 1, 2021 whereas the Plan is utilizing the IRS determination letter dated May 1, 2018 presented to Ascensus, LLC for their Volume Submitter Prototype Plan. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company matching contributions.

Note 9: Subsequent Events

Management evaluated subsequent events for the Plan through September 3, 2025, the date the financial statements were available to be issued. No subsequent events were noted that would require disclosure or modification to the financial statements.
