### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Rawle & Henderson Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Rawle & Henderson Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### (1) Description of Plan

The following description of the Rawle & Henderson Retirement Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan with 401(k) salary deferral provisions, in accordance with the provisions of Sections 401(k) and (m) of the Internal Revenue Code (IRC), for the partners and those employees who have met certain service and age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. To be eligible for participation in the Plan, employees must have attained the age of 21. To be eligible for participation in discretionary contributions, employees must have completed two years of service. The plan administrator is responsible for oversight of the Plan. The Executive and Retirement Committees (the Committees) determine the appropriateness of the Plan's investment offerings and monitor investment performance.

#### ***Contributions***

Each year participants may contribute pretax annual compensation up to the limits determined by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan also permits Roth contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Rawle & Henderson, LLP (the Firm) matches 25% of the employees' voluntary contributions (to a maximum of \$500 per employee). Each year, the Firm may also make a discretionary profit sharing contribution. No discretionary profit sharing contribution was made for 2024.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and an allocation of the Firm's contributions and plan earnings or losses. Each participant's investment program is self-directed, subject to certain limitations established by the trustee, and all earnings or losses of such program accrue to the participant's account. Each participant's account is credited with an allocation of administrative expenses based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### (1) Description of Plan, Continued

##### *Vesting*

A participant's interest in all contributions, rollover amounts, and earnings thereon credited to his or her account is nonforfeitable and fully vested when contributed or credited.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a maximum amount equal to the lesser of \$50,000 (less outstanding loans) or 50% of the participant's vested account balance. Loan terms range from 1-5 years or longer for the purchase of a primary residence. The loans are collateralized by the balance in the participants' accounts and bear interest at fixed rates that are commensurate with local prevailing rates, as determined by the plan administrator. Interest rates on outstanding loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account, an annuity, or equal installments over a designated period. For termination of service due to other reasons, a participant may receive the value of the account as a lump-sum distribution.

#### (2) Summary of Significant Accounting Policies

##### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Contributions*

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

#### (2) Summary of Significant Accounting Policies, Continued

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committees determine the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon the terms of the plan document.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain administrative expenses incurred in the operation of the Plan are paid by the Firm and are not reflected in the accompanying financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

##### *Subsequent Events*

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

#### (3) Financial Information Certified by the Trustee

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ending December 31, 2024, was obtained by management and agreed to or derived from the information certified as complete and accurate by Newport Trust Company (Newport Trust), a qualified institution.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. These investments held by the Plan are open-end investments that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

*Brokerage accounts:* Valued at the closing price reported in the active market in which the stock, bond or mutual fund is traded. Participant directed brokerage accounts allow participants to invest in securities that are traded on active exchanges.

*Common trust fund:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as the practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be possible that the fund will sell the investment for an amount different than the reported NAV. Were the Plan to initiate a full redemption of the fund, the investment adviser reserves the right to temporarily withdrawal from the trust in order to ensure that the securities liquidations will be carried out in an orderly business manner.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### (5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of registered investment companies and units of a common trust fund managed by Newport Trust. Newport Trust is the trustee of the Plan and, therefore, transactions with Newport Trust qualify as party-in-interest transactions, which are exempt from prohibited transaction rules. In addition, certain plan investments are shares of registered investment companies managed by Fidelity Investments. Fidelity Investments is the custodian of the brokerage accounts (which are certified by Newport Trust). These investments and transactions therein with Fidelity Investments qualify as party-in-interest transactions which are also exempt from the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments.

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will remain 100% vested in their accounts.

#### (7) Tax Status

The Plan is based on Newport Group Inc.'s Non-Standardized Defined Contribution Pre-Approved Plan. Newport Group, Inc. has obtained an Opinion Letter from the IRS specifying that the Plan is designed in accordance with applicable sections of the IRC and is, therefore, exempt from federal income taxes. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (8) Risks and Uncertainties

The Plan provides for various investment options, which may invest in any combination of stocks and bonds, fixed income securities, registered investment companies and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.
