NOTE 1 — DESCRIPTION OF PLAN

The following description of the Peabody Investments Corp. (the Company, Plan Administrator or Plan Sponsor) Employee Retirement Account (the Plan) provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions. The Company is a wholly-owned subsidiary of Peabody Energy Corporation (Peabody).

General

The Plan is a defined contribution plan, and participation in the Plan is voluntary. All nonrepresented employees of the Company and certain of its participating subsidiaries and affiliated companies (collectively, the Employer) are eligible for participation on the date of their employment or at any time afterward. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Vanguard Group, Inc. is the custodian for the Plan and also provides recordkeeping services to the Plan. The Vanguard Fiduciary Trust Company (the Trustee) serves as the trustee. The Plan Administrator has established a Retirement Committee to determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

Each year participants may contribute on a pre-tax, traditional after-tax, or Roth after-tax basis any whole percentage from 1% to 60% of eligible compensation, as defined in the Plan. Plan participants meeting eligibility requirements of the Plan are automatically enrolled in the Plan after 30 days with their employee contribution at 6% of their compensation. In the calendar year that a participant is age 50 or older and each year thereafter, he or she is permitted to make catch-up contributions to the Plan. Participants may also roll over account balances from other qualified defined benefit or defined contribution plans.

The Employer matching contribution is 100% of the first 6% of eligible compensation.

The Peabody Investments Corp. Board has sole discretion to determine and authorize the Employer to pay a performance contribution into the accounts of eligible participants as of the end of the fiscal year. The Board authorized performance contributions of 3% of eligible compensation for the years ended December 31, 2024 and 2023, and the amounts of the performance contributions authorized were \$7,631,936 and \$7,635,282, respectively.

The Plan allows participants to invest and direct the investment of all contributions into various investment options offered by the Plan. Self-directed brokerage accounts were added as an option during 2024.

All contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Service (IRS).

Vesting

The amounts credited to the individual account of a participant who is an employee on January 1, 2019 or a participant first hired on or after January 1, 2019 shall be fully vested at all times and in all events. With respect to a participant who incurred a termination of employment prior to January 1, 2019, the vested portion of his or her individual account will be determined in accordance with the terms of the Plan on the date of his or her termination of employment.

Forfeited Accounts

Forfeited balances of terminated participants' nonvested accounts are used to reduce Employer contributions. During the years ended December 31, 2024 and 2023, the Plan used forfeitures of \$378,991 and \$0-, respectively, to reduce Employer contributions. As of December 31, 2024 and 2023, the balance of unallocated forfeitures was \$28,410 and \$304,075, respectively. Forfeitures are invested in the Vanguard Federal Money Market Fund.

Notes Receivable From Participants

Participants may borrow 50% of their vested account, up to \$50,000, reduced by the highest principal amount outstanding in the last 12 months, if applicable. Loans are not available from a participant's after-tax contribution, Employer contribution, special nonmatch Employer contribution, transition contribution or disability contribution accounts. Loans are secured by the balance in the participant's account and bear interest based on the prime interest rate on the first business day of the month in which the loan was made, plus an additional 1%.

Participants may select any repayment period between 12 and 60 months for general purpose loans. For loans used to acquire a principal residence, any repayment period between 12 and 120 months may be selected. Principal and interest are paid ratably through payroll deductions. A maximum of two loans may be outstanding at any time. Upon retirement or separation of employment, a participant's loan must be repaid before the participant can receive a final distribution from the Plan. If the loan is not repaid within the quarter following retirement or separation of employment, it is subtracted from the participant's total account balance and considered a taxable distribution from the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and Employer contributions, and plan realized and unrealized earnings or losses. The benefit to which a participant is entitled is the vested balance of the participant's account.

Payment of Benefits

Participants are eligible for distribution of their vested account balance upon termination of employment. Participants are eligible for distribution of their entire account balance upon death, disability, or termination of employment after normal retirement date. Participants may elect to receive their distribution as either a lump-sum payment or as installments in certain circumstances, as defined in the Plan. Participants may also elect to transfer their account balance into an individual retirement account or another qualified plan.

Participants who have attained the age of 59½ have the right to receive a partial or full distribution of their vested account balance. Other types of withdrawals are also permitted, as defined in the Plan.

Plan Termination

The Plan is voluntary on the part of the Employer. The Employer may terminate the Plan in whole or in part subject to the provisions of ERISA. Upon termination or complete discontinuance of all contributions to the Plan, participants' accounts become fully vested. Currently, the Employer has no intention to terminate or discontinue all contributions to the Plan.

Administrative Expenses

Significant administrative expenses of the Plan, including audit and trustee fees, are paid by the Employer. A fixed recordkeeping fee and certain transaction fees are charged directly to participants.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

Financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

The Plan Administrator defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further description of fair value measurements.

Contributions

Contributions from participants and the associated Employer contributions are recorded in the year in which the employee contributions are withheld from compensation.

Securities Transactions

Purchases and sales of securities are recorded on a trade-date basis. Realized gains (losses) are computed based on the average cost of securities sold. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Loan origination fees are deducted from loan proceeds and are not reflected as administrative expenses on the statements of changes in net assets available for benefits. If a participant ceases to make loan repayments and the Plan Administrator deems the note receivable to be a distribution, the note receivable balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit distributions are recorded when paid.

Subsequent Events

The Plan Administrator evaluated subsequent events for the Plan through August 15, 2025, the date the financial statements were available to be issued.

NOTE 3 — FAIR VALUE MEASUREMENTS

The Plan Administrator uses a three-level fair value hierarchy that categorizes investments measured at fair value based on the observability of the inputs utilized in the valuation. These levels include: Level 1, inputs are quoted prices in active markets for identical investments; Level 2, inputs are other than quoted prices included in Level 1 that are directly or indirectly observable through market-corroborated inputs; and Level 3, inputs are unobservable, or observable but cannot be market-corroborated, requiring the Plan Administrator to make assumptions about pricing by market participants.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan Administrator evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Levels 1, 2 or 3. Further, there were no Level 3 investments in the Plan as of or for the years ended December 31, 2024 and 2023.

A financial instrument's level within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Following is a description of the valuation techniques and inputs used for investments measured at fair value, including the general classification of such investments pursuant to the valuation hierarchy.

Mutual Funds - Plan investments include a wide variety of mutual fund types that can generally be classified as holding primarily equity securities, fixed income securities, or a combination of equity and fixed income securities aimed at certain target retirement dates. Shares of mutual funds, which are traded on a national securities exchange in active markets, are valued using daily publicly quoted net asset value (NAV) prices and accordingly classified within Level 1 of the valuation hierarchy. Mutual funds are not subject to liquidity redemption restrictions.

Common/Collective Trusts - Common/collective trusts are valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying investments less its liabilities and accordingly classified within Level 2 of the valuation hierarchy. The stable value common/collective trust invests in a fund in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value.

Self-Directed Brokerage Fund - Investments in the self-direct brokerage fund consist primarily of interest bearing cash accounts, mutual funds, and exchange-traded funds that are valued on the basis of readily determinable market prices and are therefore classified within Level 1 of the valuation hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The inputs or methodologies used for valuing investments are not necessarily an indication of the risk associated with investing in those investments.

NOTE 4 — INFORMATION CERTIFIED BY THE TRUSTEE

Information regarding investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years then ended, disclosed in the accompanying financial statements and supplemental schedule, was obtained or derived from data provided to the Plan Administrator and certified to as complete and accurate by Vanguard Fiduciary Trust Company, the trustee.

NOTE 5 — PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of mutual funds and units in common/collective trusts managed by an affiliate of its trustee, Vanguard Fiduciary Trust Company, a party-in-interest with respect to the Plan. These transactions are covered by an exemption from the "prohibited transaction" provisions of ERISA and the Internal Revenue Code of 1986 (the Code), as amended.

NOTE 6 — INCOME TAX STATUS

The Plan Administrator has adopted a pre-approved profit sharing plan, and therefore, can rely on the advisory letter issued by the Internal Revenue Service on June 30, 2020, which stated that the Plan is acceptable under section 401 of the Internal Revenue Code. Management believes that the Plan is operating in compliance with all the terms provided in the non-standardized plan agreement. The plan is subject to examination by the IRS for the statutory period.

NOTE 7 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to risks such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 — PLAN TRANSFERS

As a result of the termination of the Peabody Investments Corp. Retirement Plan (PIC Pension Plan) in 2023, the Plan was selected to be the Qualified Replacement Plan for residual PIC Pension Plan assets. In December 2023, the residual PIC Pension Plan assets of \$11,134,341 were transferred into the Plan and placed in an unallocated account invested in the Vanguard Federal Money Market Fund. Interest earned on the account was \$256,227 and \$27,177 during the year ended December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, the Plan transferred funds to the PIC Pension Plan in the amount of \$62,206 related to required benefit payments and plan expenses.

The Sponsor funded a portion of the 2024 and 2023 performance contributions of \$3,768,782 and \$7,635,282, respectively, from the unallocated account during 2025 and 2024.
