*Opinion*

We have audited the financial statements of Medical Extrusion Technologies, Inc. ## **NOTES TO FINANCIAL STATEMENTS**

### **1. DESCRIPTION OF PLAN**

The following description of the Medical Extrusion Technologies, Inc. Defined Benefit Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a traditional defined benefit plan and is intended to qualify as a tax-exempt defined pension plan under Code section 401(a). The plan is intended to cover all employees of Medical Extrusion Technologies, Inc., who are of the age of 21 or older and employed for at least two years of service. Note, one year of service is defined as 1,000 hours during the Plan Year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's Investment Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investments and monitors investment performance.

#### **Contributions**

For 2024, all contributions are made by the employer based on the defined pension formula and groups of participants.

#### **Vesting**

Participants are 100% vested in the pension benefits of the defined benefit plan at two years of service.

#### **Payment of Benefits**

On termination of service due to retirement, a participant will receive payment of his or her vested account balance based on the actuarial equivalent of the vested accrued benefit payable. If termination of service is due to death, the participant will receive the vested present value of the accrued benefit, plus any life insurance proceeds less the cash surrender value.

#### **Forfeited Accounts**

During 2024 and 2023, forfeited nonvested accounts totaled \$0 respectively.

### **2. SUMMARY OF ACCOUNTING POLICIES**

#### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("GAAP") and that is permitted by the Department of Labor. The modified cash basis of accounting differs from GAAP in that interest and dividend income is recorded when received, rather than when earned, and employer contributions are recognized when cash is paid to the Plan.

#### **Use of Estimates**

The preparation of financial statements requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of any contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### 2. SUMMARY OF ACCOUNTING POLICIES (CONTINUED)

#### Payments of Benefits

Benefits are recorded when paid.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded when received. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

#### Expenses

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in amounts reported on the statement of changes in net assets available for benefits as a deduction for fees.

### 3. FAIR VALUE MEASUREMENTS

The Plan's investments are recorded at fair value in the accompanying statement of net assets, except for the fully benefit-responsive investment contract, which is reported at contract value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Certain Plan investments are managed by the Trustee. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included on the statement of changes in net assets available for benefits – modified cash basis.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

### 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits - modified cash basis.

### 7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**8. TAX STATUS**
