Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Trabon Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Trabon Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan sponsored by Trabon Printing Company, Inc. and Kansas City Managed IT, L.L.C. (collectively, the "Company") that covers substantially all employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Capital Bank and Trust Company serves as the trustee and custodian for the Plan. The Retirement Plan Services Division of The Capital Group Companies, Inc. serves as recordkeeper. UBS Financial Services, Inc. is the Plan's investment advisor.

Eligibility – An individual is eligible to defer a portion of their salary to the Plan after three months of service, and to receive Company contributions once an employee has completed one year of service or 1,000 hours. Following eligibility, participants can enter the Plan on the first day of the month coinciding with or next following the satisfaction of the eligibility requirements. The Plan is not open to union or leased employees.

Contributions – Participants may contribute up to 100% of their annual compensation, subject to certain Internal Revenue Code ("IRC") limitations. Participants over age 50 are permitted to make catch-up contributions, as defined in the Plan.

The Company matched 100% of the participant's contribution, up to \$1,000. Additionally, the Plan permits the Company to make discretionary profit-sharing contributions. Profit sharing contributions are allocated to eligible participants based on a compensation ratio, as defined in the Plan document. In order to receive a profit-sharing contribution, a participant must have worked for one year with 1,000 hours and be employed on the last day of the Plan year. For 2024, there was no such contribution.

Participant Accounts – Each participant's account is credited with the participant's contribution, employer contributions, and allocations of Plan earnings, and is charged with the participant's withdrawals and distributions and Plan expenses, if applicable. Allocations are based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options – The Plan offers various mutual funds and a money market fund as investment options for participants.

Vesting – Participants' contributions are fully vested at all times. The Company contributions vest in 20% increments, with 20% vested after the second year, 40% vested after the third year, and increasing in 20% increments. After 6 years of service, Company contributions become fully vested. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of a participant whose account is not fully vested. Forfeiture amounts are used to pay any administrative expenses and to reduce employer contributions. During the Plan year ended December 31, 2024, \$5,655 in forfeitures was used to reduce employer contributions. There are \$5,610 and \$2,474 in forfeitures available at December 31, 2024 and 2023, respectively.

Payment of Benefits – Upon termination of service, a participant may elect to receive a distribution of all or any portion of their vested account balance in a single lump sum payment or a rollover into an IRA or other eligible retirement plan, as defined by the Plan document. For distributions greater than \$1,000 but not exceeding \$7,000, the account balance will be distributed to the participant or rolled over into an individual retirement account, unless otherwise directed by the participant.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan and permitted by the IRC. Hardship withdrawals are limited to accounts that are 100% vested, with a minimum distribution of \$1,000 participant's salary reduction contribution account.

Participants who have obtained the age of 59 ½ are allowed to receive a distribution of all or any portion of their fully vested contribution accounts, as defined by the Plan.

CARES Act – In March 2020, the Coronavirus Aid, Relief, and Economic Security ("CARES") Act was enacted to provide expanded access to retirement plan accounts during the COVID-19 pandemic. The CARES Act contained several provisions that temporarily impacted 401(k) plans, such as, the waiver of required minimum distributions, a new COVID-19-related hardship withdrawal option, increased loan limits, and a loan repayment deferral option. The Company incorporated these provisions into the Plan. These temporary CARES Act provisions expired at the end of 2020. The Plan will be amended to reflect these changes prior to the December 31, 2026, deadline.

Notes Receivable from Participants – Participants may borrow a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan payments are made through payroll deductions and must be repaid to the participant's segregated account within five years. Loans for a principal residence may be paid back over a longer term. The loans are secured by the balance in the participant's account and bear interest at the published prime rate, as determined by the *Wall Street Journal* on the day of the loan request, plus 1%.

Administrative Expenses – The majority of Plan fees and expenses, including investment management fees and expenses connected with providing administrative services by external service providers, are paid from Plan assets. Investment-related expenses are included in the net appreciation or depreciation of fair value of investments. The Company pays other maintenance fees associated with the Plan.

Revenue Sharing – A revenue sharing agreement is in place whereby fees earned by the mutual fund companies are shared with the recordkeeper based upon a percentage of assets under management. These amounts are used for the benefit of the Plan to pay administrative expenses and thereafter, to be allocated to participants as additional earnings. During 2024, \$11,173 was earned from revenue sharing.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is accrued when earned. Dividends are recorded on the ex-dividend date.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and money market fund are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Date of Management’s Review – Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds and a Money Market Fund – Valued at the closing price reported on the active market on which the individual securities are traded.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Capital Bank and Trust Company, the custodian of the Plan's assets, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Interest and dividend income
- Notes receivable from participants and related interest
- Net appreciation in fair value of investments
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and a money market fund managed by American Funds, an affiliated company of Capital Bank and Trust Company. Both Capital Bank and Trust Company and American Funds are subsidiaries of The Capital Group Companies, Inc. Therefore, these transactions qualify as party-in-interest. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments. The Plan made direct payments to the trustee of \$1,600 for the year ended December 31, 2024.

Notes receivable from participants are party-in-interest transactions.

7. TAX STATUS

The Company has adopted a Prototype Non-Standardized Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on June 30, 2020, stating that the prototype plan and related trust are designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
