Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beasley, Allen, Crow, Methvin, Portis & Miles, PC 401(K) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Beasley, Allen, Crow, Methvin, Portis & Miles, PC (the Company) 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted on January 1, 1986, and is a defined contribution plan as described in the Internal Revenue Code (IRC). The Plan's sponsor is the Company. The Plan provides for participant-directed investments. The Plan covers all employees of the Company who (i) elect to participate, (ii) have attained age 21 or older and (iii) have met the one year of service eligibility requirement. An employee may elect to participate in the Plan on the earlier of the first day of the Plan year or the first day of the seventh month following completion of eligibility requirements. The administration of the Plan is the responsibility of the administrator appointed by the Board of Directors of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants in the Plan may contribute up to 100% of their eligible compensation as pre-tax deferrals, as defined in the Plan, subject to IRC limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are immediately vested in their voluntary contributions plus actual earnings thereon, which are maintained in a separate account referred to as the "Employee Deferrals." An eligible employee may make a transfer to the Plan of benefits from a qualified retirement plan of another employer with certain restrictions. Such amounts plus earnings thereon are maintained in the participant's "Rollover" account and are immediately 100% vested. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a Safe Harbor nonelective safe harbor contribution equal to 3% of the Participant's compensation for the year. Additionally, the Company may make an annual discretionary, profit-sharing contribution in an amount determined at Plan year-end by the Company's Board of Directors. Employer contributions, profit-sharing contributions, and earnings thereon are maintained in a separate account referred to as the "Employer Account."

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions, as well as the Company's Safe Harbor nonelective contributions, plus actual earnings thereon. Vesting in the discretionary profit-sharing contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested in the discretionary profit-sharing contributions plus actual earnings thereon after six years of credited service. Effective July 2, 2021, for any participant who completes an hour of service after the effective date, such participant shall be fully vested in the discretionary profit-sharing contributions account.

Payment of Benefits

Upon retirement, the participant is entitled to a distribution equal to the value of the participant's vested account balance. The participant may receive payment under the Plan in the form of a qualified joint and survivor annuity or, with spousal consent (as applicable) in periodic installment payments, in a lump sum or a direct rollover to a qualified plan. A participant may elect to defer retirement until after age 65, in which case payment of the funds accumulated in his or her individual account is deferred to any subsequent date selected by the participant up to age 70 ½. The Plan also provides for distribution of vested benefits in the event of termination or resignation, financial hardship, disability or death in accordance with Plan provisions. Upon attainment of age 59 ½, participants are entitled to withdraw all or part of their vested account balances while they are still employed by the Company.

Forfeitures

When participants cease their participation in the Plan prior to full vesting, the nonvested amounts in their Employer Accounts become forfeitures in the Plan year in which the participants receive distributions of their entire vested account balances or, if their distributions are deferred to a later date, after five consecutive one-year breaks in service. Forfeitures are retained in the Plan and used to pay administrative expenses. Any remaining forfeitures are used to reduce future employer contributions. The amount of forfeitures and earnings thereon retained in the Plan as of December 31, 2024 and 2023, was \$417 and \$1,680, respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of contract value measurements and Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain fees related to trustee expenses are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported in the active market in which the individual mutual funds are traded.

Pooled separate accounts: The fair values of accumulated units held by the Plan in the pooled separate accounts are based on each account's daily net asset value (NAV), which is considered by Plan management to be the best approximation of fair value. Data for NAVs are distributed to Plan administrators and client investors and provide sufficient corroborative evidence to ascertain the relationship between each fund's NAV and the values of individual underlying holdings. The underlying holdings are primarily valued using market quotations or prices obtained from independent pricing sources. There are no unfunded commitments from participants in the Plan who invest in these accounts and no redemption restrictions on the pooled separate accounts.

5. GUARANTEED INVESTMENT CONTRACTS

The Plan has a traditional, fully benefit responsive Guaranteed Investment Contract with Empower Annuity Insurance Company of America (EAICA) that is reported at contract value. Contract value represents contributions made, plus interest at the contract rate, less funds used to pay participants' benefits and administrative expenses.

EAICA maintains the contributions to the Fixed Accounts in a general account. EAICA is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is determined on an annual basis by EAICA and is at least equal to the minimum guaranteed interest rate. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The group contract underlying the Fixed Accounts does not permit EAICA to terminate the agreements prior to the scheduled maturity date unless the Plan has been terminated. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include (1) transfers of assets from the account into a competing investment option, and (2) when total distributions and transfers in the account exceed certain limits. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with Plan participants is not probable.

6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are funds made available by Empower Trust Company, LLC and EAICA. Empower Trust Company, LLC and EAICA are the trustees as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for these trustee services were \$54,940 for the year ended December 31, 2024. Synovus Trust Company is the investment advisor for the Plan. Fees incurred by the Plan for these advisory services were \$91,593. The Company pays directly any other fees related to the Plan's operations.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

8. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed FIS Business Systems, recordkeeper for Empower Retirement, by an advisory letter dated June 30, 2020, that the Plan and related trust are designated in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter; the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions, including the IRS; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
