## Independent Auditor's Report

### Note 1 - Plan Description

The following description of Commercial - Curtis Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan benefiting all salaried employees of Commercial Steel Treating Corporation and all employees of Curtis Metal Finishing Company (collectively, the "Company"). Employees who have attained the age of 19 and have completed at least 60 days of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 100 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan provides for an automatic enrollment feature that includes an initial deferral contribution rate equal to 3 percent of eligible compensation. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain participant contributions (including participant note receivable repayments) in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and remitted lost earnings on the late contributions to the Plan in 2025.

The Plan provides for a safe harbor employer matching contribution equal to 100 percent of employee deferrals up to 3 percent of eligible compensation, plus an additional 50 percent of employee deferrals up to the next 2 percent of eligible compensation. Effective August 1, 2024, the Company temporarily suspended the safe harbor employer matching contribution. Effective January 1, 2025, the Company reinstated the safe harbor employer matching contribution.

The Plan provides for discretionary employer matching contributions. The discretionary matching contribution is calculated as a percentage of the participant's elected deferral for the year. The percentage is determined annually by the Company's board of directors and retirement committee members. The Plan also provides for a discretionary profit-sharing contribution. The discretionary profit-sharing contribution is an amount determined each year by the Company's board of directors and retirement committee members to be paid to all eligible participants from the Company's current or accumulated profits for the fiscal year. For the year ended December 31, 2024, the board and committee did not authorize any discretionary matching or profit-sharing contributions.

#### **Participant Accounts**

Participant accounts are credited with an allocation of the Company's employer contributions and forfeitures of terminated participants' nonvested accounts, as well as a participant's compensation deferrals. The Company's discretionary profit-sharing contributions and forfeitures are allocated to the eligible participants based on participants' compensation. Allocation of plan earnings to participant accounts is based on each participant's proportionate share of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### **Vesting**

Participants are immediately 100 percent vested in employee deferrals and safe harbor matching contributions to the Plan. Participants are not vested in employer profit-sharing contributions until completing three years of service, at which time they become 100 percent vested.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow from their accounts up to, generally, the lesser of 50 percent of their vested account balances or \$50,000. The notes receivable are secured by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates. Participant notes receivable are repaid through payroll deductions.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of age 60 in the form of a lump-sum amount equal to the vested balance of a participant's account.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

#### ***Forfeitures***

Forfeitures are created when participants terminate employment before becoming fully vested in profit-sharing contributions. Forfeitures are first utilized to reinstate previous forfeiture balances of former participants (participants who are reemployed by the Company before a five-year break in service). The remaining forfeitures, if any, are allocated among participants' accounts in the same manner as the Company's discretionary profit-sharing contribution for the current year.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Voya Retirement Insurance and Annuity Company or its affiliates. Voya Retirement Insurance and Annuity Company is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation***

The Plan's investments are stated at fair value except as noted below.

The pooled separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. The fully benefit-responsive unallocated contract is valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. See Note 4 for additional information.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 23, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Voya Retirement Insurance and Annuity Company (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

**Note 4 - Fair Value Measurements (Continued)**

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 5 - Investment Contracts**

The Plan has a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

**Note 5 - Investment Contracts (Continued)**

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest rate is applied to all contributions made to the product, regardless of the timing of those contributions. Interest crediting rates are reviewed on a semiannual basis for resetting but may not be less than 2 percent. When establishing interest crediting rates for this product, Voya considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contract and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As the contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

**Note 6 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.
