Notes to Financial Statements for the year ended December 31, 2024

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the M & H Enterprises, Inc. 401(k) Plan (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan established in 1999. Employees of M & H Enterprises, Inc., HMR&B, Inc. and M & H Operating (collectively the Company) are eligible to participate in the Plan after attainment of age 18 effective August 1, 2024. Prior to August 1, 2024, employees were eligible to participate in the Plan after attainment of age 21. Employees may participate in the Plan immediately upon meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – The Plan provides for both participant and employer contributions as follows:

- *Participant contributions* – Participants may elect to contribute up to 60% of their compensation, as defined by the Plan on a pre-tax basis, subject to certain limitations by the Internal Revenue Code (the Code). Participants who have attained the age of 50 prior to the end of the Plan year may elect additional catch-up contributions, as defined by the Plan. Participants also may elect to rollover amounts they receive as distributions from another qualified retirement plan. All new hires or rehires on or after August 1, 2024 will be automatically enrolled at 6% unless an alternative salary deferral election is made. The automatic deferral percentage will increase 1% each year on February 1 until it reaches 10%.
- *Employer contributions* – The Company makes a matching contribution to all eligible employees equal to 50% of the participant's contribution that do not exceed 6% of participant's compensation as defined by the Plan. Discretionary nonelective contributions may be made for employees who complete 1,000 hours of service and are employed on the last day of the Plan year. No discretionary nonelective contributions were made during 2024.

Participants direct the investment of all contributions into various investment options offered by the Plan.

Vesting – Participants are immediately 100% vested in all participant contributions plus actual earnings thereon. Participants become 25% vested in employer contributions after two years of credited service and vest 25% per year thereafter, becoming 100% vested after five years of credited service. Participants who are employed at time of death, disability or upon reaching normal retirement age (defined as age 65) become 100% vested in all amounts at that time.

Participant accounts – Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of the investment earnings and expenses for each fund in which their account is invested. Allocations of investment income and expenses are based on the proportion that each participant's account balance bears to the total of all participant account balances. The only benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeitures and unallocated accounts – The Plan uses any amounts forfeited to pay plan expenses or to reduce future employer contributions. During 2024, forfeitures of \$36,898 were used to reduce employer contributions. Unused forfeitures totaled \$40,566 and \$8,331 at December 31, 2024 and 2023, respectively. The Plan received revenue credits of \$17,566 for the year ended December 31, 2024, which are included in other income in the statement of changes in net assets available for benefits. Amounts received may be used to reduce administrative expenses of the Plan or allocated back to participant accounts. During 2024, revenue credits of \$18,350 were used to reduce administrative expenses. Revenue credits available for future use as of December 31, 2024 and 2023 were \$36,638 and \$35,409, respectively.

Notes receivable from participants – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding loan balance in the preceding one-year period or 50% of their vested account balance. The balances in the participants' accounts secure the loans. Participants are limited to one outstanding loan at any time. Loan terms range from one to five years, unless for the purchase of a principal residence, for which terms may be up to ten years. Interest rates are determined by the plan administrator based on prevailing interest rates.

Distribution of benefits – The Plan provides for benefit distributions to plan participants or their beneficiaries, equal to the vested balance of their accounts upon death, disability, retirement, or other termination of employment. Participants may qualify for a hardship withdrawal of their elective participant contributions, while still employed, for the purpose of immediate and heavy financial needs, as defined in the Plan document.

Plan termination – Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting – The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment valuation – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by Fidelity Management Trust Company (Fidelity). See Note 6 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions from Plan participants and employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefit payments – Benefit payments to participants are recorded upon distribution.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain investment management fees are included in net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant’s account and are included in administrative expenses. Other investment-related and recordkeeping expenses paid by the Plan are included in administrative expenses.

Estimates – Management must make estimates and assumptions to prepare financial statements in accordance with generally accepted accounting principles. These estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported amounts of additions and deductions. Actual results could vary from the estimates that were used.

NOTE 3 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020 stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Code and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

NOTE 4 – INVESTMENTS

At December 31, 2024 and 2023, certain assets of the Plan were invested in funds managed by Fidelity. These transactions qualify as party-in-interest transactions. These transactions are exempt from the prohibited transaction rules of ERISA.

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and participant account balances.

NOTE 5 – INFORMATION CERTIFIED BY TRUSTEE

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to notes receivable from participants and investments held at December 31, 2024 and 2023, and interest and dividends and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution.

NOTE 6 – FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require that certain assets and liabilities be reported at fair value. The three levels of the fair value hierarchy are as follows:

- *Level 1* – Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the reporting date.
- *Level 2* – Inputs are other than quoted prices included in Level 1, which are either directly observable or can be derived from or corroborated by observable market data at the reporting date.
- *Level 3* – Inputs are not observable and are based on the reporting entity’s assumptions about the inputs market participants would use in pricing the asset or liability.

Following is a description of the valuation methods used for assets measured at fair value. There have been no changes in the valuation methods used at December 31, 2024 and 2023.

- *Mutual funds* are valued at the net asset value (NAV) of shares held by the Plan at year end.
- *Self-directed brokerage accounts* include exchange-traded funds that are valued at the closing price reported on the active market on which the individual securities are traded.

- *Collective investment trust fund* is valued at the NAV of the shares held by the Plan. The NAV is used as a practical expedient to estimate the fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant-directed redemptions have no restrictions; however, should the Plan discontinue its contract with Fidelity, notice is required and could result in the Plan's investment being placed into an investment only account for up to 12 months. There are no unfunded commitments at December 31, 2024. The fund transacts on a daily basis.

These valuation methods may produce a fair value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate, the use of different methods or assumptions could result in a different fair value measurement at the reporting date.

NOTE 7 – SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 25, 2025, which is the date that the financial statements were available for issuance. As a result of this evaluation, no events were identified that are required to be disclosed or would have a material impact on reported net assets available for benefits or changes in net assets available for benefits.
