Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Imperial Dade Puerto Rico Profit Sharing and 401(k) Plan (the "Plan"), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Imperial Dade Puerto Rico Profit Sharing and 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Plan Description

The following description of Imperial Dade Puerto Rico Profit Sharing and 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established on June 6, 2006 and amended and restated on March 1, 2018. The Plan is a defined contribution plan covering substantially all eligible employees of Dade Paper & Bag, LLC (collectively, “Dade” or the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Eligibility

The Plan covers all employees of the Company, except for employees of the Company covered by a collective bargaining agreement and employees that are not Puerto Rico residents. There are no minimum age or service requirements to participate in the Plan.

Contributions

The Plan provides each participant with an opportunity to contribute up to 90% of eligible compensation, subject to the limitations as established by Act No. 1 of January 31, 2011, of the Internal Revenue Code for a New Puerto Rico (“IRC-NPR”) (\$15,000). Participants who have attained age fifty (50) before the end of the Plan year are eligible to make catch-up contributions of \$1,500. Participants can also make rollover contributions from other qualified retirement plans. Eligible employees are automatically enrolled in the Plan at a 6% pre-tax deferral percentage, unless the employee elects not to participate in the Plan.

The Plan Sponsor can make discretionary matching and profit-sharing contributions to employees employed on the last day of the year. For the year ended December 31, 2024, the Company elected to match 50% of a participant’s contributions up to 6% of their eligible compensation. The Company did not make any discretionary profit-sharing contributions.

Participant Accounts

Each participant’s account is credited with their contributions, employer contributions, allocation of plan expenses, and the earnings thereon. Contributions to the Plan are invested by the trustee as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their contributions and become vested in the employer contributions, based on the following schedule:

Forfeitures

Forfeited non-vested accounts are to be used to reduce future employer profit sharing and/or matching contributions and to pay administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$4,200 and \$16,400, respectively. During the year ended December 31, 2024, approximately \$4,800 was forfeited from participants. Plan forfeitures of \$10,000 were used to pay plan expenses and approximately \$7,000 were applied in conjunction with the payment of Employer contributions.

Benefits

A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to the specific guidelines as set forth in the plan document.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum term of a loan is five years and the loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1% when the loan is made. Notes receivable from participants are repaid through payroll deductions and monitored by the Plan administrator. As of December 31, 2024, the interest rates on the outstanding notes receivable from participants ranged from 4.25% to 9.50%.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments, presented in the accompanying statement of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Cost of securities sold is determined by the specific identification method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Management evaluated subsequent events for the Plan through September 25, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan’s Trustees

The following is a summary of the investments and notes receivable from participants regarding the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, including in the Plan’s financial statements and supplemental schedule, that was prepared by or derived from information provided by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees, and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustees that such information is complete and accurate.

Investment Contract with Insurance Company

The guaranteed interest account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Empower Annuity Insurance Company of America (“Empower”). The contract is reflected in the financial statements at contract value (which represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses), because it is fully benefit-responsive. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issue or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investments options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with the participants, is probable. The guaranteed interest account does not permit Empower to terminate the agreement prior to the scheduled maturity date.

Note 4. Fair Value Measurements

The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies during 2024 and 2023.

Mutual funds: valued at unadjusted quoted prices reported in an active market at the year end.

Common collective trust: the fair value of the common collective trust is determined by the trustee of the common collective trust based on the underlying assets, which present the net asset value. Participant directed redemptions can be made on any business day and do not have a redemption period. There were no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party Transactions

Certain Plan investments are managed by Empower Trust Company, LLC, the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Empower for trustee, recordkeeping and administrative services amounted to approximately \$3,000 for the year ended December 31, 2024. Fees paid to the investment advisor, auditor, and third-party administrator also qualify as party-in-interest transactions. Total fees paid to the investment advisor, auditor, and third-party administrator were approximately \$26,000 for the year ended December 31, 2024.

Note 6. Tax Status

On September 13, 2013, the Plan obtained a determination letter in which the Puerto Rico Department of Treasury (PRTD) stated that, effective January 1, 2011, the Plan is designed in accordance with applicable sections of the Internal Revenue Code for a New Puerto Rico ("IRC- NPR"), as amended, and therefore the plan is exempt from Puerto Rico income taxes.

The Plan was amended and restated effective March 1, 2018, with the adoption of Oriental Pension Consultants, Inc. Prototype Defined Contribution Retirement Plan ("Prototype Plan") and Oriental Bank Master Trust Fund ("Oriental Master Trust"). A favorable determination letter was issued on August 2, 2019 by PRTD stating that the plan is qualified under the code, and therefore exempt from taxation.

The Plan administrator has evaluated the Plan's tax positions and concluded that as of December 31, 2024, the Plan maintained its tax-exempt status and there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Note 7. Risk and Uncertainties

The Plan's investments are concentrated in mutual funds, a guaranteed investment contract and a common collective trust fund that invest in marketable securities. Such securities are subject to various risks such as interest rate, market and credit risks, which determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.
