### Note 1 - Plan Description

The following description of Ozinga Bros., Inc. Employees' Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan with a 401(k) feature available to nonunion employees of Ozinga Bros., Inc. (the "Company") who are not covered by collective bargaining agreements and who are age 18 or older.

There is no service requirement to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). In 2017, the Plan was amended to automatically enroll employees when they become eligible to participate in the Plan unless they affirmatively elect otherwise. The initial automatic deferral percentage is 3 percent of eligible compensation, which increases by 1 percent annually up to a maximum of 10 percent, as long as the participant is still in automatic enrollment status.

The Plan is administered by an administrative committee (the "Committee") that serves at the discretion of the Company's board of directors. The Committee is responsible for all matters, including, but not limited to, determining eligibility and rights to benefits, interpreting plan documents, directing the Plan's trustee, and maintaining participant accounts.

The Plan allows for participants to transfer account balances between defined contribution plans also sponsored by Ozinga Bros., Inc. and its affiliates. In 2024 and 2023, there was no net transfers into the Plan.

#### **Contributions**

The Plan provides for employee salary contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan also allows participants to contribute their compensation on an after-tax basis. Participants who have attained age 50 may make catch-up contributions in addition to their regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make an annual discretionary matching contribution, as approved by the Company's board of directors. Participants who are age 21 or older who have completed one year of service with 1,000 hours will be eligible to receive an allocation of the Company's discretionary matching contribution. There were no discretionary matching contributions made by the Company during 2024 or 2023.

The Company may also make an annual discretionary nonelective profit-sharing contribution to the Plan, as approved by the Company's board of directors. Participants age 21 and older who have completed one year of service with 1,000 hours will be eligible to receive an allocation of the Company's discretionary profit-sharing contribution. The Company made discretionary profit-sharing contributions of approximately \$8,076,000 and \$7,280,000 for the years ended December 31, 2024 and 2023, respectively. Discretionary nonelective profit-sharing contributions are allocated based on a percentage of the participant's compensation in relation to total compensation of all participants receiving a discretionary nonelective profit-sharing contribution.

Participants may direct their contributions among one or more funds. Changes in allocation of future contributions and transfers among funds of presently invested contributions are permitted pursuant to the Plan's provisions.

**Note 1 - Plan Description (Continued)**

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contribution, and allocations of the Company's discretionary profit-sharing contribution and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the highest outstanding loan balance in their accounts during the prior 12-month period or (b) 50 percent of their vested account balances. The notes receivable are secured by the balance in the participant's account and bear interest at market rates. Principal and interest are paid ratably through monthly payroll deductions over a term not exceeding 5 years or a reasonable period of time, not to exceed 10 years, determined at the time of the loan, if used for the purchase of a principal residence.

***Benefit Payments***

Upon termination of service due to death, disability, retirement, or termination of employment, a participant or his or her beneficiary may elect to receive either a lump-sum distribution or various installment options.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document.

***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts occurs over six years and is based on years of continuous service. Participants are fully vested after the earlier of six years of service or early retirement age, as defined.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used first to pay administrative expenses of the Plan. Any remaining amounts will be used to reduce future company contributions. At December 31, 2024 and 2023, forfeited account balances totaled approximately \$143,000 and \$94,000, respectively. The Company applied forfeitures totaling approximately \$160,000 and \$275,000 to fund employer contributions in 2024 and 2023, respectively.

***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in the company contribution portion of their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If participant notes receivable are deemed to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Benefit Payments***

Benefits are recorded when paid.

***Administrative Expenses***

Various administrative costs are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net realized and unrealized gains on investments.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 17, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Tax Status**

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

**Mutual Funds**

Mutual funds are valued at quoted prices reported in active markets.

**Money Market Fund**

The money market fund is valued at quoted prices reported in active markets.
