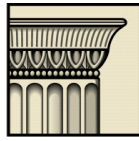

## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of 3Rivers Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following brief description of the 3Rivers Retirement Plan (Plan) provides only general information. Participants should refer to the Summary Plan Description and Plan Agreement for a more complete description of the Plan.

#### **General**

The Plan is a defined contribution 401(k) and profit sharing plan covering substantially all employees of Three Rivers Federal Credit Union (Credit Union). An employee becomes eligible to enter the Plan following the attainment of age 18. Prior to December 10, 2018, the Plan also required completion of six months of service, defined by the Plan as at least 500 hours of service.

The Plan was originally effective on September 1, 1968. The Plan provides for retirement, death, disability, and termination benefits. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### **Contributions**

Participants may defer and contribute from 1 percent up to 100 percent of their eligible compensation, as defined by the Plan, not to exceed certain dollar limitations that are set by law. An automatic enrollment feature was added to the Plan whereby eligible employees are automatically enrolled at a 8 percent deferral rate (5 percent deferral rate prior to July 15, 2019), but have the option to decline or enroll at a different deferral rate. Effective December 1, 2018, for the first day of each Plan year subsequent to automatic deferral, the automatic deferral percentage will increase by one percentage point up to a maximum of 15 percent of compensation. Participants age 50 or older may elect to defer and contribute additional amounts to the Plan up to a maximum that is set by law. Participants may also make rollover contributions of amounts representing distributions from other qualified defined benefit and defined contribution plans. Additionally, the Plan allows participants to change the amount of their contribution each payroll and to direct the investment of their funds and contributions on a daily basis. Effective March 1, 2018, the Credit Union is required to make matching contributions of 100 percent of the first 3 percent and 50 percent of the next 5 percent of eligible compensation that a participant contributes to the Plan for the plan year. The Credit Union may also provide a discretionary profit sharing contribution. No discretionary contributions were made to the Plan for the years ended December 31, 2024 and 2023.

## Notes to Financial Statements (continued)

### 1. Description of Plan (continued)

#### Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Credit Union's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participants' non-vested accounts may be used to reduce plan administrative expenses. Any remaining forfeitures will generally be used to reduce Credit Union contributions. Unallocated forfeited balances were \$5 and \$69,790 at December 31, 2024 and 2023, respectively. Forfeitures used to offset employer contributions and administrative expenses were \$204,942 and \$85,165 for the Plan years ended December 31, 2024 and 2023, respectively. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

#### Vesting

Participants are immediately vested in their contributions, including rollover contributions, and actual earnings thereon. Credit Union contributions plus actual earnings thereon vest according to a schedule as follows:

#### Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one year period ending on the day before the date of the new loan over their current outstanding balance of loans as of the date of the new loan or (b) 50 percent of the participant's vested account balance. A participant may only have one regular loan (five year maximum) and one residential loan (used to purchase his/her primary residence) outstanding at any time. If a loan is for the purchase of a participant's principal residence, the plan administrator may permit a repayment term of longer than five years. The

loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Unless approved by the plan administrator, a participant must repay their loan through payroll deduction.

#### Benefit Payments

Upon termination of service, due to death, disability, or retirement, a participant with a vested account balance exceeding \$1,000 can elect to receive a lump-sum distribution equal to the vested value of his or her account or partial withdrawals subject to the provisions of the Plan and minimum distribution rules required by law. Separated participants with vested account balances not exceeding \$1,000 will receive lump-sum distributions as soon as administratively feasible. The Plan also provides for participant loans as described above and certain hardship withdrawals. Distributions of benefits are recorded as withdrawals from the Plan and reduction of assets available for plan benefits in the period paid to the participant.

#### Administrative Expenses

Certain administrative expenses are paid by the Credit Union and excluded from these financial statements. The Credit Union also provides certain accounting, recordkeeping, and administrative services for the Plan for which it receives no compensation.

#### Plan Termination

Although the Credit Union has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### 2. Summary of Significant Accounting Policies (continued)

##### Investments

The Plan's investments are primarily reported at fair value using net asset value (NAV) as a practical expedient, with the exception of the Plan's fully benefit-responsive investment contract that is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract and is the relevant measure for the portion of assets attributable to fully benefit-responsive investment contracts. See *Note 4* for discussion of fair value measurements.

Purchases and sales of securities are accounted for on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan includes in the statements of changes in assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the unrealized appreciation (depreciation) on those investments.

The underlying investments of the pooled separate accounts consist of diverse portfolios with no significant concentration of risk by issuer, industry, or geographic locations.

##### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related loan origination and annual administration fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

### Notes to Financial Statements (continued)

#### 2. Summary of Significant Accounting Policies (continued)

##### Use of Estimates

Preparation of the Plan's financial statements requires the plan administrator to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### Reclassifications

Certain 2023 amounts have been reclassified to conform with the 2024 presentation.

#### 3. Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023 and net appreciation (depreciation) in fair value of investments and interest and dividends for the years then ended, were obtained or derived from information supplied to the plan administrator and certified as complete and accurate by the Standard Insurance Company, trustee of the Plan.

All investments held by the Plan and listed above are participant directed.

#### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 (ASC 820), *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### 4. Fair Value Measurements (continued)

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* The fair value of units held in pooled separate accounts are valued at the NAV as reported by Minnesota Life Insurance Company. The NAV is based on the value of the underlying investments, minus its liabilities, and then divided by the number of units outstanding. The NAV is quoted on a private market that is not active; however, the unit price of the underlying investments is traded on an active market. The pooled separate accounts have no unfunded commitments as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. Investment Contract

The Minnesota Life Guaranteed Return Account, a fully benefit-responsive guaranteed investment contract, is a general account product that guarantees the preservation of principal and accrued interest. The stated or accumulated value, as reported by the Minnesota Life Insurance Company, represents contributions made, plus earnings credited, and charges for withdrawals and administrative expenses. The interest crediting rate, which is reset quarterly, is based on historical contributions and withdrawals, current market conditions, the Minnesota Life Guaranteed Return Account's investment portfolio turnover, and estimated contributions and withdrawal for the upcoming quarter. The minimum crediting interest rate is guaranteed by Minnesota Life Insurance Company to be no less than 1.5 percent. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract at the accumulated value which represents fair value.

The Minnesota Life Insurance Company Guaranteed Return Account earned an average interest rate of 1.99 percent for the year ended December 31, 2024 and 1.78 percent for the year ended December 31, 2023. The credited interest rate was 1.99 and 1.78 percent for the years ended December 31, 2024 and 2023, respectively.

#### **6. Tax Status**

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020, stating that the prototype plan qualifies under Section 401 of the Internal Revenue Code (Code) and, therefore, is not subject to tax under present income tax law. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. Although the Plan has been amended since that date, the plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code, and, therefore, believes that the Plan is qualified and the related trust is tax exempt and the Plan has no income subject to unrelated business income. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for the years prior to December 31, 2021.

#### **7. Transactions with Parties-in-Interest**

The Plan invests in pooled separate accounts and the guaranteed return account managed by the Standard Insurance Company. Transactions in such investments are considered to be party-in-interest transactions. The Standard Insurance Company also provides certain accounting, recordkeeping, administrative, and other trust services for the Plan.

#### **8. Subsequent Events**

Management has evaluated subsequent events through September 16, 2025, the date on which the financial statements were available to be issued.
