### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

### Note 1 - Plan Description

The following description of Marsh Automotive Group 401(k) Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document or summary plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time, nonunion, and nonresident alien employees of Marsh Automotive Group, Inc. (the "Company"). Employees are eligible for the Plan upon completion of three months of service and attainment of age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 5, 2024, the Company sold multiple consolidated entities to Serra Automotive and approximately 45 percent of participants who were in the Plan on the effective date were terminated and given the option to transfer their funds out of the Plan, resulting in a partial plan termination at December 31, 2024. As a result of the partial plan termination, the balances of the participants that were terminated became 100 percent vested on the transfer date.

#### **Contributions**

The Plan provides for employee salary deferral contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute a percentage of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company may make a discretionary matching contribution. The matching contribution will be determined by the Company each year. Matching contributions were \$107,922 for 2024. In addition, the Company may make a discretionary profit-sharing contribution. There were no profit-sharing contributions for the year ended December 31, 2024.

During 2023, the Company remitted certain employee deferrals to the Plan after the Department of Labor's required time frame. A contribution of the lost earnings was made during 2024.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to pay administrative expenses of the Plan.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are immediately vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in company contributions 20 percent per year until they become fully vested after five years of service.

#### **Participant Notes Receivable**

Participants may borrow from their account balances. The minimum note receivable amount is \$1,000. The maximum note receivable amount is the lesser of 50 percent of their vested account balances or \$50,000. The notes receivable are secured by the balance in the participant's account and bear interest at a reasonable rate based on rates charged by other lenders for similar loans.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

Upon death, disability, retirement, termination, or other reasons, a participant will receive his or her vested account balance in a lump-sum amount.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Termination***

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain administrative expenses of the Plan were paid by the plan sponsor, Marsh Automotive Group, Inc.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### Note 2 - Summary of Significant Accounting Policies (Continued)

#### *Subsequent Events*

The financial statements and related disclosures include evaluation of events up through and including September 23, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

Charles Schwab Trust Bank (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

### Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### *Level 1*

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### *Level 2*

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### *Level 3*

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### *Mutual Funds*

Mutual funds are valued at quoted prices reported in active markets.

#### *Common/Collective Trust Funds*

The common/collective trust funds are valued at net asset value per share or its equivalent of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.
