The liability under the unit credit cost method is the value of the accrued pension benefit using service and pay as of the valuation date. The sum of the present value of the accrued benefits for all participants is the ERISA funding target. The normal cost is the present value of the benefits earned during the year. The target normal cost is the sum of the normal costs for all participants and the assumed administrative expenses.

Changes in Method from Prior Year and Rationale for Changes

Enrolled actuary, actuarial firm and valuation software were changed. Funding target liability, target normal cost and actuarial value of plan assets were compared with the prior actuary's and were within the required thresholds. IRS Revenue Procedure 2017-56 provides automatic approval for these changes.


