NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. PLAN DESCRIPTION

The following description of the North Coast Holdings Save Money and Reduce Taxes (SMART) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Effective January 1, 2024, the Plan was amended to change the Plan name from The Lewis Tree Service Save Money and Reduce Taxes (SMART) Plan to North Coast Holdings Save Money and Reduce Taxes (SMART) Plan.

General

The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (IRC), covering certain employees of Lewis Tree Service, Inc. and other related employers (the Company) who meet certain eligibility criteria. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by a Benefits Committee (the Committee) elected by the Board of Directors of the Company. The Committee is composed of at least three members of management. The Plan Administrator, as selected by the Committee, is a member of the Committee. Principal Trust Company (Principal), a member of the Principal Financial Group, is the custodian of the Plan and also provides recordkeeping and administrative services for the Plan. Principal also serves as the trustee of the Plan.

Eligibility

Employees of the Company, excluding members of a collective bargaining unit, except for the International Brotherhood of Electrical Workers (Local Union 42, Local Union 1-2, and Local Union 3), are eligible to participate in the Plan and receive an employer match upon the attainment of age 21 and completion of six months of continuous service. Participation commences on the first entry date, as defined, following attainment of the eligibility requirements.

Contributions

The Plan allows participants to contribute up to 60% of their annual compensation, subject to certain limitations of the Plan and the Internal Revenue Code (IRC). Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Plan requires matching contributions with participants who are members of Local Unions 42 and 1-2. Such matching contributions require the Company to contribute 100% of the first 3% contributed by those participants who are members of Local 42, and 50% of the first 5% contributed by those participants who are members of Local 1-2.

The Plan requires matching contributions for non-union employees in an amount equal to 100% of elective deferral contributions that are not over 5% of compensation. This matching contribution is made to the North Coast Holdings Employee Stock Ownership Plan.

The Plan also allows for discretionary matching contributions for union participants in an amount specified in the applicable collective bargaining agreement. There were no discretionary match contributions during the years ended December 31, 2024 and 2023.

1. PLAN DESCRIPTION (Continued)

Contributions (Continued)

The Plan provides an automatic enrollment provision in which all newly eligible employees are enrolled to contribute 5% of their annual salary unless the employee affirmatively elects otherwise.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions and actual earnings and losses thereon. Allocations of plan earnings, losses and administrative expenses are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, employer matching contributions and earnings thereon.

Benefit Payments

Participants generally are eligible to receive distributions of their vested benefits upon retirement, termination of employment, or due to death and disability. Additionally, the Plan provides for in-service withdrawals once a participant has reached the age of 59 ½, even if still employed.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's account under certain circumstances. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Notes Receivable from Participants

Participants may borrow from \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance in the previous 12-month period or one half of their vested account balance. Principal and interest, at the prime rate plus 2%, is paid ratably through payroll reductions for a period not to exceed five years, unless used to purchase a principal residence for which the period may not exceed 10 years. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate determined by the plan administrator.

Administration Expenses

Plan expenses primarily consist of recordkeeping fees. Certain expenses of maintaining the Plan are paid directly by the Company. Participant accounts are charged fees for processing loans and benefit payments.

Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and the Plan. In the event of plan termination, participants will be entitled to their entire amount credited to their account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investments and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. The net appreciation in the fair value of investments consists of both realized and unrealized gains and losses on the Plan's investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid, interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Fair Value Measurements – Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board Accounting Standards Codification 820 (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 – Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 – Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Benefit Payments

Benefit payments are recorded when paid.

Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risk and Uncertainties

The Plan invests in investment securities, which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with these securities, it is at least reasonably possible that changes in their values will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used during 2024 and 2023.

Mutual funds: valued at fair value based on quoted market prices.

Investments measured at NAV: Common collective trust funds and pooled separate accounts are valued at the NAV of units of the respective collective trust or pooled separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying investments held by the respective collective trust or pooled separate account.

Investments in Entities that Calculate Net Asset Value

The Plan is invested in common collective trust funds and pooled separate accounts that calculate net asset value on a daily basis.

The Plan's investments in common collective trust funds are invested in a collective trust fund as well as separate accounts and mutual funds. The net asset value of these investments is derived from the market value of the underlying investments. The unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are primarily based on observable inputs. These investments do not have any unfunded commitments. The Plan can redeem these investments daily. There are currently no redemption restrictions on these investments.

The Plan's investments in pooled separate accounts are invested in domestic stocks and mutual funds. The net asset value of these investments is derived from the market value of the underlying investments. The unit price is quoted on a private market that is not active; however, the unit price is based on underlying investments which are primarily based on observable inputs. These investments do not have any unfunded commitments. The Plan can redeem these investments daily. There are currently no redemption restrictions on these investments.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting this pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are funds maintained and managed by Principal, the trustee. The trustee qualifies as a party-in-interest and transactions involving these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 24, 2025, which is the date these financial statements were available to be issued.
