We have performed an audits of the accompanying financial statements of Hoss's Steak and Sea House Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.



Note A - Description of Plan

The following description of the Hoss's Steak and Sea House Savings Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all full-time employees of Hoss's Steak and Sea House, Inc. (Company) and its participating employers who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.
2. Contributions - Each year, participants may contribute up to their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan includes an automatic escalation provision whereas participants auto deferral rate is increased 2 percent yearly up to a maximum 11 percent of eligible compensation unless they affirmatively change such increase. The Company may match a percentage, as determined by the Company's Board of Directors, up to 6 percent of compensation that a participant contributes to the Plan based on a pay period basis. The matching Company contribution is also directed by participants. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors and are also directed by participants. Participants who are not employed on the last working day of the plan year are generally not eligible for an allocation of Company profit sharing contributions for such year. Contributions are subject to certain IRS limitations.

3. Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's matching contributions, account earnings, as well as allocations of the Company profit sharing contribution. Participant accounts are charged directly for participant requested services and an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100 percent vested after five years of credited service.
5. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Only one loan may be outstanding at a time, unless if one loan is a principal residence loan. The loans are secured by the balance in the participant's account and bear interest set at 2% above the prime rate. The interest rates range from 3.25% to 10.5%. Principal and interest is paid directly by participants via ACH to the Trustee.
6. Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or have their benefits paid in regular periodic payments or in partial distributions as requested by the participant. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
7. Forfeited Accounts - Amounts forfeited by terminated participants' nonvested account balances may first be used to pay administrative expenses then shall reduce the earliest Company contribution to be made after the forfeitures are determined. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,435 and \$1,158, respectively. Company contributions were reduced by \$-0- and \$1,091 and expenses paid were \$-0- and \$-0- in 2024 and 2023, respectively from forfeited nonvested accounts.

Note B - Summary of Accounting Policies

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Board of Trustees determines the Plan's valuation policies utilizing information provided by custodians and insurance companies. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.
5. Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction. The Plan distributed any excess contributions to the applicable participants prior to March 15<sup>th</sup> of the year following the excess, with amounts paid being \$7,236 and \$2,745 in 2024 or 2023, respectively.
6. Payment of Benefits - Benefits are recorded when paid.

7. Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to notes receivable from participants, payment of benefits, and investment advisory services are charged directly to the participant's account and are included in administrative expenses. Investment and record keeping related expenses are included in net appreciation (depreciation) in fair value of investments.
8. Subsequent Events - The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

Note C - Group Annuity Insurance Contract with Insurance Company

The Plan entered into a traditional fully benefit-responsive guaranteed insurance contract with Standard Insurance Company (Standard) in 2004 which was terminated June 15, 2022. Standard maintained the contributions in a general account named The Standard Stable Asset A. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate was reviewed on a quarterly basis for resetting.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment may apply.

The Plan did exercise an option in the contract when selecting John Hancock Trust Company LLC (John Hancock) as its new trustee in 2022. The contract with Standard provided an option that if the Stable Asset A value is transferred in 6 equal installments over a period of 5 years, the market value adjustment charge would not be assessed. Contingent on fulfilling that requirement, this option does not limit the ability of the Plan and participants to transact at contract value with the contract issuer. Participants are not limited to transact at contract value individually at any time with investments that are not a competing fund type.

In a trustee to trustee transfer, Standard transferred \$4,104,383 to John Hancock, in which the 1<sup>st</sup> installment was invested by John Hancock in the John Hancock Stable Value R11, a common/collective trust, and the balance was invested in Standard Stable Asset Fund Q, a common/collective trust. Future installments from the Standard Stable Asset Fund Q will fluctuate based on earning and participant allowed transfer activity.

Standard retains an option to transfer/disburse any remaining balance from its fund in a single lump sum.

Note D - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be activity traded.

Common/Collective trust: Valued either by the trust using a discounted cash flow methodology based on the prevailing market rates of similar instruments with comparable durations or by the contract issuer using independent pricing services for investment contracts in which the readily determinable fair value is used to estimate fair value. Participant transactions occur daily and the trust is priced daily.

Note F - Tax Status

The Internal Revenue Service (IRS) has determined and informed the pre-approved plan provider by letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan has been amended since receiving its determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Since the Plan is a pre-approved plan, it is not necessary for the Plan administrator to submit the Plan for favorable determination.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G - Concentration of Credit Risk

The Company is primarily associated with the family style restaurant business, having locations throughout Pennsylvania and surrounding states.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note J - Related-Party Transactions and Party In Interest Transactions

Certain Plan investments are with John Hancock. John Hancock is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan has an Investment Advisory Agreement with in which fees are paid through John Hancock to Heritage Seubert Financial, LLC for investment advisory services. Effective May 27, 2022, a Service Agreement with John Hancock Retirement Plan Services LLC was entered into. The Plan or Company may make a payment for administrative expenses. Investment and record keeping related fees incurred by the Plan are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. See Note B for further description on administrative expenses.

Note K - Plan Amendments

The Plan was amended effective January 1, 2023. Significant changes include changing for new participants only auto enrollment deferral to 3% from 1%, adding auto escalation of 2% up to 11%, and deferral type defaults for pre-tax or Roth based on wage levels. Participants subject to these provisions may elect their own deferral and escalation percentages, and type of deferral.
