Basis for Opinion of the 2024 Financial Statements

In preparing the 2024 financial statements, management is required to evaluate whether there are conditions or events that, considered in the aggregate, raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the 2024 financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the 2024 financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements* section of our report, our objectives are to obtain reasonable assurance about whether the 2024 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2024 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

2024 Supplemental Information Required by ERISA

The 2024 supplemental information listed in the index as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the 2024 financial statements, but is supplemental information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the 2024 financial statements. The information included in the 2024 supplemental information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the 2024 financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the 2024 financial statements or to the 2024 financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the 2024 supplemental information that is agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the 2024 supplemental information, we evaluated whether the 2024 supplemental information, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated July 18, 2025, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that is agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 – Plan Description

The following description of the iC Consult US 401(k) Plan (the “Plan”), formerly known as the iC Consult Group Americas 401(k) Plan, provides only general information. Effective December 6, 2024, the Plan was amended to change its name from the iC Consult Group Americas 401(k) Plan to the iC Consult US 401(k) Plan. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan that provides retirement savings benefits to eligible employees of iC Consult US Corp., formerly known as iC Consulting Group Americas Corp, and its participating employers: iC Consult Retirement Fund; Nextep, Inc.; SecureITSource, Inc.; and Kapstone Technologies LLC (collectively, the “Company” or “Employer”). The Plan commenced effective January 1, 2023, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodians and Trustees

Effective December 6, 2024, the Plan was amended and restated, and John Hancock Trust Company, LLC, (“John Hancock”) was appointed as the new custodian and trustee of the Plan. John Hancock Retirement Plan Services, LLC, (“JHRPS”) was appointed as the new recordkeeper. Prior to December 6, 2024, John Hancock Life Insurance Company (U.S.A.) (“JHLIC”) served as the Plan’s custodian and recordkeeper. Collectively, John Hancock and JHLIC are referred to herein as the “Custodians”. Prior to December 6, 2024, certain employees of the Company served as the Plan’s trustees.

The Custodians maintain custody of all investments held by the Plan. Among other duties, the Custodians receive contributions, hold and invest fund assets in accordance with the directions of participants, and make disbursements to participants. The recordkeeper maintains the Plan’s participant account balances and provides recordkeeping services to the Plan.

Plan Merger – Transfer of Assets to this Plan

Effective January 1, 2024, the Kapstone Technologies LLC 401(k) Plan (the “Merged Plan”) merged with and into the Plan. The formal transfer of all assets was completed on January 11, 2024, and net assets totaling \$2,368,073 were transferred from the Merged Plan into the Plan. This amount is included as transfer of assets to this Plan on the statement of changes in net assets available for benefits.

Eligibility and Plan Entrance Date

All employees of the Company, except union employees, nonresident aliens, and leased employees, are eligible to participate in the Plan after the employee has reached 21 years of age and completed 90 days of service. Effective December 6, 2024, eligible employees are permitted to enter the Plan immediately after having satisfied all eligibility requirements. Prior to December 6, 2024, eligible employees were permitted to enter the Plan on the first day of the month coinciding with or next following the date eligibility requirements were met.

Note 1 – Plan Description (continued)

Contributions

Participants may elect to contribute, on a before tax or Roth basis, up to 100% of their eligible compensation. Participant contributions are subject to certain limitations under the IRC; each participant's annual contribution shall not exceed the maximum amount allowed for deferral annually by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make additional catch-up contributions of up to the maximum amount allowed by the IRC, which was \$7,500 for 2024.

Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("rollovers").

The Plan provides for Safe Harbor Employer matching contributions. The Company made Safe Harbor Employer matching contributions to the Plan, on behalf of participants, in an amount equal to 100% of the participant's elective contributions up to a maximum level of 4% of the participant's eligible compensation. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. Participants have the option of directing their account balances to one or more investment options offered by the Plan. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. The funds vary in type of investment, rates of return, and investment risk.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions, allocations of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, Safe Harbor Employer matching contributions, and actual earnings thereon. Employer discretionary nonelective contributions and Employer matching contributions will vest at a rate of 20% per year beginning after the second year of credited service, becoming fully vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon separation of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump sum payment equal to the value of the participant's vested account balance. Vested account balances of less than \$5,000 are immediately attributable to a lump sum distribution under the terms of the Plan without the participant's consent.

A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59½.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$30,759 and \$8,131, respectively. These accounts will be used to reduce future Employer contributions or to pay administrative expenses.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold, as well as those held during the year.

Note 2 – Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses specifically incurred by, or attributable to, a participant will be paid from that participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs in the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net assets value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and classified within level 1 of the valuation hierarchy.
- **Common Collective Trust Fund** – Valued using the NAV of units held by the Plan at year end as provided by the fund administrator. Units of each fund are valued each day on which the New York Stock Exchange (“NYSE”) is open for trading in accordance with the valuation procedures established by Reliance Trust Company. The NAV per unit is calculated as of the close of trading on the NYSE and computed by dividing the total fair value of the assets of a fund, less its liabilities, by the total number of units outstanding at the time of such computation. The NAV is based on the fair value of the underlying assets owned by the fund, net of the investment management fee, and is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily, and there are no significant restrictions on participant redemptions or any unfunded commitments.
- **Pooled Separate Accounts** – Valued using the NAV of units held by the Plan at year end as provided by John Hancock. The NAV is based on the fair value of the underlying assets owned by the fund, net of an investment management fee, and is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.
- **Interest Bearing Cash** – Valued at cost, which approximates fair value, and classified within level 1 of the valuation hierarchy.

Note 4 – Information Prepared and Certified by the Plan’s Custodians

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. Effective December 6, 2024, the Plan changed its qualified institution from John Hancock Life Insurance Company (U.S.A.) to John Hancock Trust Company, LLC. Accordingly, John Hancock Life Insurance Company (U.S.A.) and John Hancock Trust Company, LLC, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Note 5 – Guaranteed Investment Contract with Insurance Company

The Plan has a group annuity contract that invests contributions in the John Hancock Stable Value Guaranteed Income Fund. The Fixed Income Guaranteed Option (the “Fixed Account”) is a general account product. Interest earned on the Fixed Account value is compounded daily to the effective annual interest rate. The interest rate to be credited to the Plan will be determined by the insurance company prior to the last day of the previous calendar quarter.

The contract meets the fully benefit-responsive investment contract criteria and are thus reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount which would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the Plan Document (including complete or partial Plan termination or merger with another plan); (b) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events that cause a significant withdrawal from the Plan; or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

Note 6 – Exempt Party-in-Interest Transactions

Certain Plan investments are managed by the Custodians. These include shares of mutual funds, units of the common collective trust, money market funds, pooled separate accounts, and a guaranteed investment contract. These transactions qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan had notes receivable from participants as of December 31, 2024 and 2023. As a result, these receivables and all transactions relating to these receivables qualify as party-in-interest transactions. These transactions are exempt from being prohibited transactions by ERISA.

Note 7 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants would become 100% vested in their Employer contributions, and all assets in the affected participants' accounts would be distributed to the participants and beneficiaries of the Plan in the order provided for by ERISA.

Note 8 – Income Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by JHRPS. The IRS has determined and informed JHRPS, by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has not filed individually with the IRS regarding the Plan's qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable IRC requirements, and thus believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 9 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.
