### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Eide Ford Lincoln Mercury, Inc. Salary Deferral 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 PLAN DESCRIPTION**

The following description of the Eide Ford Lincoln Mercury, Inc. Salary Deferral 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the sponsor – Eide Ford Lincoln Mercury, Inc.

A third-party administrator (Fidelity Management Trust Company) serves as trustee of the Plan and holds the Plan assets. Fidelity Workplace Services, LLC maintains the records for participant data.

The Plan includes the employees of Eide Ford Lincoln Mercury, Inc., Eide Auto Center, Inc., Eide Motors & RV Center, LLC, Eide Motors, Inc., EIDEAL, ALLENE, and EAGAL, Inc. (collectively the Company).

**Eligibility**

All employees of the Company are eligible to participate in the Plan after completion of 1,000 hours of service in the first year of eligibility (one year following first date of employment), and attainment of age 21, except for collective bargaining agreement employees and nonresident aliens. All employees of the Company are eligible to participate after completion of twelve months of service with no minimum hour requirement. To receive discretionary matching contributions, an employee must meet the eligibility requirements above. To receive discretionary profit-sharing contributions, an employee must either have worked at least 501 hours during the Plan year and be employed on the last day of the Plan year. Employees may enroll in the Plan at the beginning of each calendar month coincident with or next following the date the eligibility requirements are met for all contribution types.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Plan allows for a discretionary match. The Plan matches 50% of the participant's elective deferrals up to 5% of the participant's eligible compensation. Discretionary profit-sharing contributions to the Plan are also allowed and are allocated to each employee in the ratio that the compensation of the individual participant is to the compensation of all participants for the plan year. There were no discretionary profit-sharing contributions for the Plan years ended December 31, 2024 and 2023.

Participants may roll over amounts representing distributions from other qualified defined benefit, defined contribution plans, or individual retirement accounts.

**Payment of Benefits**

Upon termination of employment, death, disability, or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$1,000 or less are required to take a lump sum distribution upon termination. Terminated participants with balances between \$1,000 and \$7,000 can elect to receive a lump sum payment or rollover those funds to another qualified plan. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 and ½ to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Fidelity Management Trust Company, the trustee.

**Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death and disability. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within ten years. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

Forfeitures can be used in any permissible method, including restoring forfeitures, reducing future employer contributions, or to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,596 and \$874, respectively. During the year ended December 31, 2024, \$7,954 of forfeitures were used to reduce employer contributions. During the years ended December 31, 2024 and 2023, \$14,026 and \$14,449 were used to pay plan expenses, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management Trust Company. The non-standardized pre-approved profit sharing plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fidelity Management Trust Company serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Fidelity Management Trust Company in the amount of \$9,903 and \$7,633 respectively.

**NOTE 7 NON-EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

During 2024, the Company failed to timely remit withheld employee contributions to the Plan in the aggregate amount of \$53,740 in accordance with the plan asset provisions of the Department of Labor ("DOL") Regulation 2510.3-102, resulting in prohibited, or nonexempt transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating the required corrections to the Plan to reflect foregone earnings that would have been credited to participants' accounts if the late remittances had been made on a timely basis.

**NOTE 8 TRUSTEE TO TRUSTEE TRANSFER**

Effective January 1, 2023, the employees of Alcar, Inc. became part of a separate retirement plan. The accounts of Alcar, Inc. employees were transferred via a trustee to trustee transfer on June 1, 2023 totaling \$418,979.

**NOTE 9 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 10 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 11 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 26, 2025, which is the date these financial statements were available to be issued.

**NOTE 1 PLAN DESCRIPTION**

The following description of the Eide Ford Lincoln Mercury, Inc. Salary Deferral 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the sponsor – Eide Ford Lincoln Mercury, Inc.

A third-party administrator (Fidelity Management Trust Company) serves as trustee of the Plan and holds the Plan assets. Fidelity Workplace Services, LLC maintains the records for participant data.

The Plan includes the employees of Eide Ford Lincoln Mercury, Inc., Eide Auto Center, Inc., Eide Motors & RV Center, LLC, Eide Motors, Inc., EIDEAL, ALLENE, and EAGAL, Inc. (collectively the Company).

**Eligibility**

All employees of the Company are eligible to participate in the Plan after completion of 1,000 hours of service in the first year of eligibility (one year following first date of employment), and attainment of age 21, except for collective bargaining agreement employees and nonresident aliens. All employees of the Company are eligible to participate after completion of twelve months of service with no minimum hour requirement. To receive discretionary matching contributions, an employee must meet the eligibility requirements above. To receive discretionary profit-sharing contributions, an employee must either have worked at least 501 hours during the Plan year and be employed on the last day of the Plan year. Employees may enroll in the Plan at the beginning of each calendar month coincident with or next following the date the eligibility requirements are met for all contribution types.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Plan allows for a discretionary match. The Plan matches 50% of the participant's elective deferrals up to 5% of the participant's eligible compensation. Discretionary profit-sharing contributions to the Plan are also allowed and are allocated to each employee in the ratio that the compensation of the individual participant is to the compensation of all participants for the plan year. There were no discretionary profit-sharing contributions for the Plan years ended December 31, 2024 and 2023.

Participants may roll over amounts representing distributions from other qualified defined benefit, defined contribution plans, or individual retirement accounts.

**Payment of Benefits**

Upon termination of employment, death, disability, or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$1,000 or less are required to take a lump sum distribution upon termination. Terminated participants with balances between \$1,000 and \$7,000 can elect to receive a lump sum payment or rollover those funds to another qualified plan. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 and ½ to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Fidelity Management Trust Company, the trustee.

**Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death and disability. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within ten years. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

Forfeitures can be used in any permissible method, including restoring forfeitures, reducing future employer contributions, or to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,596 and \$874, respectively. During the year ended December 31, 2024, \$7,954 of forfeitures were used to reduce employer contributions. During the years ended December 31, 2024 and 2023, \$14,026 and \$14,449 were used to pay plan expenses, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management Trust Company. The non-standardized pre-approved profit sharing plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fidelity Management Trust Company serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Fidelity Management Trust Company in the amount of \$9,903 and \$7,633 respectively.

**NOTE 7 NON-EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

During 2024, the Company failed to timely remit withheld employee contributions to the Plan in the aggregate amount of \$53,740 in accordance with the plan asset provisions of the Department of Labor ("DOL") Regulation 2510.3-102, resulting in prohibited, or nonexempt transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating the required corrections to the Plan to reflect foregone earnings that would have been credited to participants' accounts if the late remittances had been made on a timely basis.

**NOTE 8 TRUSTEE TO TRUSTEE TRANSFER**

Effective January 1, 2023, the employees of Alcar, Inc. became part of a separate retirement plan. The accounts of Alcar, Inc. employees were transferred via a trustee to trustee transfer on June 1, 2023 totaling \$418,979.

**NOTE 9 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 10 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 11 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 26, 2025, which is the date these financial statements were available to be issued.

## INDEPENDENT AUDITOR'S REPORT

**NOTE 1 PLAN DESCRIPTION**

The following description of the Eide Ford Lincoln Mercury, Inc. Salary Deferral 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is administered by the sponsor – Eide Ford Lincoln Mercury, Inc.

A third-party administrator (Fidelity Management Trust Company) serves as trustee of the Plan and holds the Plan assets. Fidelity Workplace Services, LLC maintains the records for participant data.

The Plan includes the employees of Eide Ford Lincoln Mercury, Inc., Eide Auto Center, Inc., Eide Motors & RV Center, LLC, Eide Motors, Inc., EIDEAL, ALLENE, and EAGAL, Inc. (collectively the Company).

**Eligibility**

All employees of the Company are eligible to participate in the Plan after completion of 1,000 hours of service in the first year of eligibility (one year following first date of employment), and attainment of age 21, except for collective bargaining agreement employees and nonresident aliens. All employees of the Company are eligible to participate after completion of twelve months of service with no minimum hour requirement. To receive discretionary matching contributions, an employee must meet the eligibility requirements above. To receive discretionary profit-sharing contributions, an employee must either have worked at least 501 hours during the Plan year and be employed on the last day of the Plan year. Employees may enroll in the Plan at the beginning of each calendar month coincident with or next following the date the eligibility requirements are met for all contribution types.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows participants to allocate contributions between pretax and after tax (Roth 401(k)) deferrals.

The Plan allows for a discretionary match. The Plan matches 50% of the participant's elective deferrals up to 5% of the participant's eligible compensation. Discretionary profit-sharing contributions to the Plan are also allowed and are allocated to each employee in the ratio that the compensation of the individual participant is to the compensation of all participants for the plan year. There were no discretionary profit-sharing contributions for the Plan years ended December 31, 2024 and 2023.

Participants may roll over amounts representing distributions from other qualified defined benefit, defined contribution plans, or individual retirement accounts.

**Payment of Benefits**

Upon termination of employment, death, disability, or retirement, the participant will receive a lump sum amount, installment distributions or ad-hoc distributions equal to the value of the participant's vested interest. Terminated participants with account balances of \$1,000 or less are required to take a lump sum distribution upon termination. Terminated participants with balances between \$1,000 and \$7,000 can elect to receive a lump sum payment or rollover those funds to another qualified plan. Hardship distributions and in-service retirement distributions are also permitted for participants who have not separated from service. Participants must have attained age 59 and ½ to qualify for in-service retirement distributions. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the Company's contribution. Plan earnings are allocated based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company contributions to selected investments as made available and determined by the Plan Administrator. Participants may change their investment options throughout the year by contacting Fidelity Management Trust Company, the trustee.

**Vesting**

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of service with certain exceptions for death and disability. A participant is 100% vested after six years of credited service.

**Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account and bear a reasonable rate of interest as determined by the Plan Administrator based on the prevailing rates charged by persons in the business of lending money for loans which would be made under similar circumstances. The term of the loan cannot exceed five years, unless it is for the purchase of a principal residence, which must be repaid within ten years. Principal and interest are paid ratably through payroll deductions.

**Forfeitures**

Forfeitures can be used in any permissible method, including restoring forfeitures, reducing future employer contributions, or to pay plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$4,596 and \$874, respectively. During the year ended December 31, 2024, \$7,954 of forfeitures were used to reduce employer contributions. During the years ended December 31, 2024 and 2023, \$14,026 and \$14,449 were used to pay plan expenses, respectively.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("U.S. GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year and is reflected in the statements of changes in net assets available for benefits.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to the applicable participants prior to March 15 of the subsequent year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Certain administrative expenses that are paid by the Company are not reflected in the accompanying financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**NOTE 4 FAIR VALUE MEASUREMENT**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.  
If the asset or liability has a specified (contractual) term the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 INCOME TAX STATUS**

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management Trust Company. The non-standardized pre-approved profit sharing plan has received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service as to the plan's qualification status. This opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fidelity Management Trust Company serves as the trustee of the Plan, maintains the records of the participant data, and holds the Plan's assets. For the years ended December 31, 2024 and 2023, the Plan paid fees to Fidelity Management Trust Company in the amount of \$9,903 and \$7,633 respectively.

**NOTE 7 NON-EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

During 2024, the Company failed to timely remit withheld employee contributions to the Plan in the aggregate amount of \$53,740 in accordance with the plan asset provisions of the Department of Labor ("DOL") Regulation 2510.3-102, resulting in prohibited, or nonexempt transactions. The accompanying Schedule of Delinquent Participant Contributions discloses these transactions in accordance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The Company is in the process of calculating the required corrections to the Plan to reflect foregone earnings that would have been credited to participants' accounts if the late remittances had been made on a timely basis.

**NOTE 8 TRUSTEE TO TRUSTEE TRANSFER**

Effective January 1, 2023, the employees of Alcar, Inc. became part of a separate retirement plan. The accounts of Alcar, Inc. employees were transferred via a trustee to trustee transfer on June 1, 2023 totaling \$418,979.

**NOTE 9 AMENDMENT AND TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants become fully vested.

**NOTE 10 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 11 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan's year end. Subsequent events have been evaluated through September 26, 2025, which is the date these financial statements were available to be issued.
