We have performed audits of the financial statements of REHAU Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of REHAU Retirement Savings Plan (Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan, effective January 1, 1988, is a defined contribution, profit sharing retirement plan covering REHAU Incorporated (Company) employees and employees of members of the controlled group of corporations as defined by the Plan's Adoption Agreement, excluding those who are nonresident aliens with no U.S. income, employees covered by a collective bargaining agreement, leased employees, and an individual considered by the Company to be an independent contractor who is later determined by the Internal Revenue Service (IRS) to be an employee. All non-excluded employees of the Company who have completed six months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participant elective contributions represent amounts paid by an employer, at the election of the employee, in lieu of cash compensation and includes contributions that are made pursuant to a salary reduction agreement. Participants may contribute up to the lesser of 100% of the participant's eligible compensation for the limitation year or the maximum percentage of compensation and dollar amounts permissible under Internal Revenue Code (IRC or Code) Section 402(g) and 414(v) not to exceed the limits of IRC Section 401(k), 404, and 415. The Plan also accepts catch-up contributions, qualified participant rollovers, qualified employer safe harbor matching contributions, matching contributions, and qualified discretionary nonelective employer contributions. The Company contributes a safe harbor match equal to 100% of the participants' elective deferrals that are not over 3% of eligible compensation, plus 50% of elective deferrals which are over 3% but are not over 5% of eligible compensation. No discretionary nonelective employer contribution was made to the Plan.

Participant Accounts

Each participant's account was credited with the participant's voluntary contribution and allocations of (a) the Company's contribution, if any, and (b) Plan earnings reduced by investment expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants have a fully vested interest in their contributions and the investment earnings thereon. All safe harbor contributions and discretionary nonelective contributions are automatically 100% vested.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of the fair market value of their vested account balance. Loan repayments must be in equal monthly installments paid through payroll deductions over periods up to 60 months unless for the purchase of a primary residence. The loans are secured by the balance in the participant's account. The base interest rate used is equal to the Prime Rate (as published in *The Wall Street Journal*) plus 2%. The interest rates on current participant loans are 5.25% - 10.50%.

Payments of Benefits

All distributions from the Plan are subject to the Internal Revenue Code sections governing distributions. A participant is eligible to withdraw funds from the Plan for the following reasons:

1. Termination of employment
2. Hardship as defined by the Internal Revenue Code
3. Death
4. Disability
5. Normal retirement (Age 65)
6. Attainment of age 59 ½

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (US GAAP) requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Investment gain from pooled separate accounts and stable value collect trust, including unrealized and realized gains and losses and interest and dividends income, are included in "net investment gain from pooled separate accounts" and "net investment gain from stable value collect trust", respectively.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net investment gain from pooled separate accounts, net investment gain from stable value collective trust, net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at NAV of shares held by the Plan at year end based on quoted market price. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

Stable value fund: Valued at the NAV of the shares held by the Plan at year end, which is based on the fair value underlying investments using information reported by the investment advisor at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value.

Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are managed by Principal Trust Company. Principal Trust Company is the trustee and record keeper for the Plan and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

In addition, the Plan received revenue from Principal Trust Company for the plan years ended December 31, 2024 and 2023, related to revenue sharing, which is a return of service fees that Principal Trust Company receives from the Plan's investment funds.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

Note 7. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events and transactions through September 29, 2025, the date the financial statements were available to be issued. During 2025, the Plan experienced a partial plan termination when a division of the Company spun off, terminating participants of the Plan effective April 16, 2025. Under IRS guidelines, a partial termination may occur when more than 20 percent of the plan participants were terminated in a given year. This will result in all employees who left employment during 2025 and had an account balance to become 100% vested in all employer contributions regardless of the Plan's vesting schedule.
