Note 1. Description of Plan

The following description of the Inventus Power 401(k) (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Inventus Power, Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

An employee becomes eligible to participate in the Plan on the first day of each month following one month of service and the attainment of at least 18 years of age. Prior employees of both ICC Nexergy, Inc. and Palladium Energy, Inc. are credited with service from the previous employer to determine eligibility for the Plan.

Contributions

Each year, participants may contribute up to 60% of pretax annual compensation as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value collective trust fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a set deferral rate of 5% of compensation, unless they affirmatively elect not to participate. The Plan also provides that the Employer shall make a safe harbor matching contribution equal to 100% of the first 5% of an eligible participant’s compensation that is contributed to the Plan. In addition, the Employer may make discretionary contributions in amounts determined by the Employer’s Board of Directors; however, during 2024 or 2023 there were no such Employer discretionary contributions to the Plan.

Participant’s accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Employer contributions, (b) Plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based upon the participant’s earnings or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1. Plan Description (continued)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined by the Plan administrator. Loan repayment terms are not to exceed five years, unless the loan will be used by the participant to acquire the participant's residence. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their own contributions and the Employer's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Employer's discretionary contribution portion of their account, plus actual earnings thereon, is based on years of continuous service and is subject to the following vesting schedule:

For employees of Palladium Energy, Inc. who were hired prior to January 1, 2016, the above vesting schedule applies, except that such employees are 33% vested after one year of service and 100% vested after two years of service.

Payment of benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. In addition, participants may elect to receive hardship withdrawals, as defined in the Plan agreement.

Benefits are recorded when paid.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled to \$1,090 and \$0, respectively. Forfeitures from employer matching contributions will first be used to pay administrative expenses of the Plan and then be used to reduce future employer contributions. In 2024, forfeitures amounting to \$8,065 were used to pay administrative expenses of the Plan (\$6,250 in 2023). No forfeitures were used to reduce employer contributions in 2024 or 2023.

Note 2. Summary of significant accounting policies

Basis of accounting and use of estimates

The financial statements of the Plan are prepared using the accrual basis of accounting.

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document. During the year ended December 31, 2024, delinquent loans reclassified as benefit payments were \$9,004 (\$747 for 2023).

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Note 3. Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Note 4. Fair value measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Level 1 Fair Value Measurements*

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan and as reported by the fund. The mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are considered to be actively traded.

*Investment measured at net asset value*

The investment measured at net asset value (NAV) represents units in the Invesco Stable Value Fund, which is a stable value collective trust fund that invests in investment contracts and security-backed contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily and there are no unfunded commitments. Were the Plan to initiate a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations would be carried out in an orderly business manner. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

Note 5. Related party transactions

Certain Plan investments were shares of mutual funds managed by Fidelity, the trustee of the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee for administrative expenses were \$28,141 and \$23,924 for the years ended December 31, 2024 and 2023, respectively.

Certain other administrative expenses of maintaining the Plan are paid by the Employer on behalf of the Plan. These expenses, however, are not material to the financial statements.

A certain employee of the Employer has been appointed as Plan administrator for the Plan. This employee is also a participant in the Plan. The employee does not receive any compensation from the Plan for services performed as Plan administrator.

Note 6. Income tax status

The Employer has adopted a non-standardized pre-approved profit sharing plan offered by FMR LLC. The Internal Revenue Service has determined and informed FMR LLC by a letter dated June 30, 2020, that the plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 7. Plan termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.
