## Independent Auditor's Report

To the Retirement Plan Committee of  
Profit Sharing Plan of Cades Schutte:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Profit Sharing Plan of Cades Schutte (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting as described in Note 2.

- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our opinion is not modified with respect to this matter.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. ## 1. Description of the Plan

The following description of the Profit Sharing Plan of Cades Schutte (the Plan), a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

### a. General

The Plan was effective October 1, 1985. The Plan Administrator consists of a committee of certain partners and management personnel of Cades Schutte, A Limited Liability Law Partnership (Cades or the Plan Sponsor).

The trustee of the Plan is Empower Trust Company (ETC). The custodian is Empower Annuity Insurance Company (EAIC), an affiliate of ETC.

### b. Eligibility

Substantially all employees of Cades are eligible to participate in the Plan effective January 1 or July 1 after satisfactorily completing a year of service and attaining age 21 or older, as defined by the Plan.

### c. Contributions

Contributions to the Plan consist of the following:

- i. Pre-tax salary or Roth deferral contributions - made upon election by participants to their accounts through regular payroll deductions and subject to Internal Revenue Code (IRC) limitations.
- ii. Employer matching contributions - equal to 10 percent of the Matched Employee Contributions that are not in excess of 100% of the Participant's Plan Compensation. The total amount of the Matching Contributions allocated to the Participant in any Plan Year shall not exceed \$120.

The Plan Sponsor will only make matching contributions to participants who are employed on the last day of the plan year.

### c. Contributions (continued)

- iii. Non-elective contributions – the Plan Sponsor may, in its sole discretion, make non-elective contributions to the Plan on behalf of each Participant who (1) has completed at least 1,000 Hours of Service during the Plan Year, or (2) first became a Participant during the Plan Year and was regularly employed at the rate of at least 20 Hours of Service per week throughout the remainder of the Plan Year.

The total amount of Non-Elective Contributions shall be a discretionary amount as determined by the Plan Sponsor.

For 2024, non-elective contributions were made to the Plan at five percent of each participant's eligible compensation, to the extent that such compensation did not exceed the 2023 social security taxable wage base for the year; plus an amount not less than ten percent of each participant's annual compensation in excess of the 2023 social security taxable wage base and not more than the maximum amount that is nondiscriminatory in relation to the amount of non-elective contributions for non-highly compensated employees of the Plan Sponsor for the year.

### d. Allocation of Earnings and Losses

As of each valuation date, as defined, earnings or losses from the Plan's investments are allocated to the participants' accounts in proportion to the balances of such accounts as of the most recent valuation date, reduced by any distributions since that date.

### e. Vesting

Participants' pre-tax salary or Roth deferral contributions, employer matching, and funds rolled over from other qualified plans, plus earnings thereon, are fully vested at all times; employer profit sharing, plus earnings thereon, currently vest at the rate of 20 percent upon completing two years of service, as defined in the Plan, and 20 percent for each year thereafter.

### f. Notes Receivable from Participants

Promissory notes receivable from Plan participants are carried at their unpaid principal balances. Participants may borrow from their accounts in amounts up to the lesser of 50 percent of their vested interest or \$50,000. Loans are secured by the balance in the participant's account, bear interest at a commercially reasonable rate and are to be repaid over a reasonable period of time not to exceed five years unless the loan is used to acquire a participant's principal residence, in which case the loan term can be extended up to 30 years. Interest ranged from 4.25 percent to 7.25 percent per annum at December 31, 2024. The loans mature on various dates through November 2052.

### g. Payment of Benefits

Benefits to be paid by the Plan will vary with circumstances and will be based on contributions and amounts credited to the participant's account.

- i. Termination, Retirement and Disability - Participants who have terminated, retired or who have become totally and permanently disabled may receive the entire vested amount accumulated in their accounts in one lump-sum or in periodic payments, as defined in the Plan.
- ii. Death - The beneficiary may receive, in one lump-sum or periodic payments, the entire vested amount accumulated in the deceased participant's account.
- iii. In-Service - Upon reaching age 59½ a participant may elect to distribute from their elective account. Distributions from any rollover accounts may be made at any time. After ten years of Plan participation participants may distribute from their discretionary profit-sharing contribution account at any time.

### h. Forfeitures

The portion of a terminating participant's account that is not vested is considered a forfeiture and is used to reduce employer contributions. During 2024, terminating participants forfeited approximately \$7,000. As of December 31, 2024 and 2023, approximately \$64,000 and \$90,000, respectively, were available to reduce future employer contributions.

### i. Administrative Expenses

Investment-related fees and transaction fees are paid for by the participants. Expenses for trustee and custodian services, audit fees, and other common administrative expenses of the Plan are paid by the Plan Sponsor or the Plan.

### j. Investment Options

Participants may direct their contributions into one or more of the investment options offered by the Plan.

A participant may also create a segregated account. The participant may then direct the trustees to invest the segregated account's funds in assets the participant selects. The gains and losses of each segregated account are attributed solely to such account and such account does not share in the gains and losses of any other accounts. In addition, participants with segregated accounts have the option of paying the administrative expenses necessary to maintain the account, or have those amounts withdrawn from their accounts.

## 2. Summary of Significant Accounting Policies

### a. Basis of Accounting

As permitted by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan maintains its records on a modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP). This basis differs from U.S. GAAP in that participant and employer contributions are recognized when received instead of when earned, and administrative expenses are recognized as paid instead of when the obligation is incurred. Accordingly, the accompanying financial statements are not intended to be presented in conformity with U.S. GAAP.

### a. Basis of Accounting (continued)

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

### b. Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and the changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### c. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### d. Payment of Benefits

Benefits are recorded when paid.

### e. Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued, and it was determined that all subsequent events had been properly accounted for.

## 4. Fair Value Measurements

The modified cash basis of accounting establishes a framework for measuring fair value established by U.S. GAAP. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

### 4. Fair Value Measurements (continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2024 and 2023. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

*Mutual funds* – Valued at the quoted net asset value (NAV) of the shares held by the Plan at the reporting date.

*Common and preferred stocks (held in self-directed brokerage accounts)* – Valued at the closing price reported on the active market on which the individual securities are traded.

*U.S. government securities and corporate debt instruments (held in self-directed brokerage accounts)* – Valued using quoted prices for similar assets in active markets.

*Pooled separate accounts* – Valued using the net asset value (NAV) of units held by the Plan at year end as provided by ETC. The NAV is based on the fair value of the underlying investments. The NAV is not a publicly-quoted price in an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. As of December 31, 2024 and 2023, interest bearing cash of \$406,861 and \$544,288, respectively, are not included in the self-directed brokerage account amounts in the tables below.

### 5. Guaranteed Investment Contract

The Plan invested in the Guaranteed Income Fund (GIF) with EAIC. Guarantees are based on the claims paying ability of EAIC and not the value of the securities within the insurer's general account. The credit rating of the issuer at December 31, 2024 was Aa3 as reported by Moody's Investors Service. Deposits made to the GIF are deposited in EAIC's general account. Payment obligations under the GIF represent an insurance claim supported by all the general assets. The GIF does not operate like a mutual fund, variable annuity product, or conventional fixed rate individual annuity product. Expenses related to the GIF are calculated by EAIC and incorporated in the GIF crediting rate.

Under the group annuity contract that supports this product, participants may ordinarily direct permitted withdrawals or transfers of all or a portion of their account balance at contract value within reasonable time frames. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The contract is effected directly between the Plan and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. There are no reserves against contract value for credit risk of the contract issuer or otherwise. Given these provisions, the Plan considers this contract to be fully benefit responsive.

Interest is credited on contract balances using a single portfolio rate approach. Under this methodology, a single interest crediting rate is applied to all contributions made to the product regardless of the timing of those contributions. The average yield earned by the Plan and credited to participants was 2.14 percent for the year ended December 31, 2024. No adjustment is required to mediate between the average earnings credited to the Plan and the average earnings credited to the participants. The same crediting interest rate is applied to the entire contract value and is reviewed on a semi-annual basis for resetting. The factors considered in establishing the crediting interest rate include current economic and market conditions, the general interest rate environment and both actual and expected experience of a reference portfolio within the general account. The guaranteed minimum interest rate is 1.50 percent. As of December 31, 2024 and 2023, investment in the guaranteed investment contract amounted to \$12,172,661 and \$12,483,153, respectively.

Only an event causing liquidity constraints at EAIC could limit the ability of the Plan to transact at contract value paid within 90 days or in rare circumstances, contract value over time. There are not any events that allow the issuer to terminate the contract and which require the Plan sponsor to settle at an amount different than contract value paid either within 90 days or over time.

### **6. Plan Termination**

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue or reduce its contributions at any time and to terminate or amend the Plan subject to the provisions set forth in ERISA. In the event of termination, each participant automatically becomes vested to the extent of the balance credited in the participant's account.

### **7. Tax Status**

The volume submitter plan adopted by the Plan received a favorable tax opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has since been amended and the Plan Administrator and tax counsel believe that the Plan is currently designed and being operated in compliance with the qualification requirements of the IRC and that the Plan continues to be tax-exempt. Hawaii income tax law conforms to the IRC. Therefore, no provision for federal and state income taxes has been included in the Plan's financial statements.

## 7. Tax Status (continued)

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Plan years from December 31, 2021 are open for examination for federal tax purposes; however, there are currently no audits in progress for any tax periods.

## 8. Exempt Party-In-Interest Transactions

Certain plan investments are shares of mutual funds, pooled separate accounts and the guaranteed investment contract managed by ETC and EAIC. ETC is the trustee and custodian and EAIC is the custodian as defined by the Plan, and, therefore, these transactions qualify as exempt party-in-interest transactions.

## 9. Concentration of Credit Risk and Investment Risks

Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of the investments, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits. As of December 31, 2024 and 2023, approximately 11 percent, respectively, of net assets available for benefits were invested in a guaranteed investment contract with EAIC.
