NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - PLAN DESCRIPTION

The following description of the Community Blood Center, Inc. 403(b) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Community Blood Center, Inc. (the Company or Employer). All employees of the Company are eligible to participate in the Plan beginning on their date of hire. Employees are eligible for Company matching and discretionary contributions upon reaching age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute pretax and Roth elective deferrals. The combined pretax and Roth elective deferrals are limited to the annual Internal Revenue Service (IRS) limit. The Plan also includes a provision for automatic pretax elective deferral contributions. The automatic deferral is 4% of compensation and applies when an employee first becomes eligible to make elective deferral contributions. Employees have the right to change their deferral percentage or elect not to make contributions.

The Company is making a matching contribution of 100% of the first 3% of participants' contributions to the Plan and matches 50% of the next 6%. The Company has the option to make discretionary contributions to the Plan. The Company did not make a discretionary contribution to the Plan for the year ended December 31, 2024.

Participant Accounts

Participants' accounts are allocated to the various investment options offered by the Plan as directed by the participants.

Each participant's account is credited with the participant's contribution and the Company's matching contribution along with an allocation of Company discretionary contributions and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including rollover amounts, and earnings thereon. Vesting in Company contributions is based on years of service. Participants hired prior to April 3, 2018, become 50% vested after completing two years of service and become 100% vested after completing three years of service. For participants hired on or after April 3, 2018, participants become 25% vested after completing one year of service, 50% vested after completing two years of service, and 100% vested after completing three years of service.

Notes Receivable From Participants

Participants may borrow from their fund accounts, for financial hardship purposes, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions. The

notes receivable from participants outstanding were \$4,418 and \$0 as of December 31, 2024 and 2023, respectively. The interest rate on participant loans was 9.5% at December 31, 2024.

Payment of Benefits

Plan benefits are available at retirement, disability, death, financial hardship, and termination of employment with vested interest. Benefits are generally paid as a lump-sum distribution. The Plan also allows for inservice distributions upon attaining age 59½. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan Administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Administrator may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

The Setting Every Community Up for Retirement Enhancement Act of 2019 (SECURE Act) changed the age at which participants are required to take required minimum distributions from their accounts. Required minimum distributions are made upon the participant meeting the relevant required minimum distribution age.

Forfeited Accounts

Forfeitures are used to pay Plan expenses or allocated to reduce Company contributions. Forfeited nonvested accounts totaling approximately \$45,000 were used during the year ended December 31, 2024. The forfeiture balance was approximately \$38,400 and \$30,600 as of December 31, 2024 and 2023, respectively.

NOTE B - SIGNIFICANT ACCOUNTING POLICIES

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows.

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for expected credit losses has been recorded as of December 31, 2024.

Administrative Expenses

The Plan pays certain administrative costs which are expensed when incurred. Other expenses are paid by the Company.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds and money market fund: Valued at the quoted daily closing price as reported by the fund. Mutual funds and the money market fund held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset

value (NAV) and to transact at that price. The mutual funds and money market fund held by the Plan are deemed to be actively traded.

NOTE D - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by First Business Bank, the custodian as defined by the Plan and, therefore, transactions with the custodian qualify as party-in-interest transactions.

The Plan allows participants to take out loans, which are also considered party-in-interest transactions.

Certain Plan expenses are paid by the Company and are exempt from prohibited transactions rules under ERISA. These costs include administrative and audit fees.

NOTE E - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

NOTE F - INFORMATION CERTIFIED BY CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's custodian, First Business Bank, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

1. Investments, at fair value, notes receivable from participants, and cash as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related amounts included in the financial statements and supplemental schedule.

NOTE G - TAX STATUS

The Company adopted a volume submitter 403(b) plan, which received a letter from the IRS dated March 31, 2017, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - RISKS AND UNCERTAINTIES

Fair Value Measurement

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE I - SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were issued. The Plan Administrator is not aware of any subsequent events which would require recognition or disclosure in the financial statements.
