Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Zuppardo's Economical Super Market, LLC Employee Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. December 31, 2024 and 2023

Note 1 - PLAN DESCRIPTION

The following description of the Zuppardo's Economical Super Market, LLC Employee Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan is a defined contribution plan covering eligible employees of Zuppardo's Economical Super Market, LLC (the "Employer") who have completed one year of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by the Employer. The trustee of the Plan is Fidelity Management Trust Company.

b. Contributions

Each year, participants may contribute, by salary reduction pursuant to Section 401(k) of the Internal Revenue Code, up to 100% of pretax annual compensation, as defined in the Plan document, not to exceed statutory limits. Eligible employees may also contribute amounts representing rollover distributions from other qualified pension plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Additionally, the plan agreement provides that participants may make Roth contributions to the Plan.

The Employer will contribute to the Plan a matching contribution on behalf of each eligible employee equal to the sum of 100% of the first 3% of the employee's elective deferrals contributed to the Plan and 50% of the next 2% of employee's elective deferrals contributed to the Plan. For the year ended December 31, 2024, the Employer made matching contributions of \$120,032.

The Employer may also make nonelective contributions for eligible participants. For the year ended December 31, 2024, the Employer made nonelective contributions of \$261,666.

Note 1 - PLAN DESCRIPTION (Continued)

c. Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's matching contributions, as well as allocations of the Employer's nonelective contributions and plan earnings. Participant accounts are charged with plan losses and an allocation of administrative expenses that are paid by the Plan. Allocations are based on compensation, account balances, or specific participant transactions as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

d. Vesting

Participants are immediately vested in their 401(k) deferral contributions, rollover contributions, and matching contributions plus actual earnings thereon. Vesting in the participants' nonelective contributions portion of their accounts plus actual earnings thereon is as follows:

e. Investment Options

The Plan provides a participant-directed investment program whereby participants select the investments for their accounts. The investment options the Plan offers to participants include mutual funds and a collective trust fund. The options offered represent several different alternatives to investing with different risk and return characteristics. Participants may change their investment options daily.

f. Payment of Benefits

Upon termination of service, a participant whose vested account balance exceeds \$1,000 may elect to receive benefits in the form of a lump sum amount. Participants with balances of \$1,000 or less are subject to the mandatory cash out provisions of the Plan and will receive a lump sum amount equal to the fair value of the participant's vested interest in his or her account. The Plan also allows certain in-service withdrawals.

Note 1 - PLAN DESCRIPTION (Continued)

g. Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$102,502 and \$83,249, respectively. These accounts will be used to pay administrative expenses or reduce future employer contributions. For the year ended December 31, 2024, \$15,607 in forfeitures were used to pay administrative expenses.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are significant accounting polices followed by the Plan:

a. Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting.

b. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that effect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains (losses) on sales of investments and unrealized appreciation in fair value of investments are reported as net appreciation in fair value of investments in the statement of changes in net assets available for benefits. Related investment fees are netted against investment income.

d. Payment of Benefits

Benefits are recorded when paid.

Note 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

e. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

f. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through August 21, 2025, which is the date the financial statements were available to be issued.

Note 3 - CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value as of December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends and interest for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

Note 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

Level 2 - Inputs to the valuation methodology include inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly, as such:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- *Collective Trust Fund*: Valued at NAV reported by the fund on a daily basis. The collective trust fund is deemed to have a readily determinable fair value because the investments are equity securities in a structure similar to a mutual fund in which the fair value per unit are determined and published and are the basis for current transactions. The daily NAV is available to participants of the Plan and participants are allowed to make daily redemption requests at the current NAV. They are classified as Level 2 investments.

Note 4 - FAIR VALUE MEASUREMENTS (Continued)

The methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while plan management believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Based on re-evaluation of the criteria for concluding that an investment has a readily-determinable fair value, the fair value of the collective trust fund as of December 31, 2023, has been reclassified to Level 2 in the fair value table to conform with the current year presentation. This reclassification has no impact on net assets available for benefits as of December 31, 2023.

Note 5 - RISKS AND UNCERTAINTIES

The Plan provides for various investments in mutual funds and a collective trust fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the owners of Zuppardo's Economical Super Market, LLC, the plan sponsor, have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 7 - TAX STATUS

The Plan has adopted a non-standardized pre-approved plan sponsored by Fidelity Management & Research Company. The Plan received an opinion letter for the Internal Revenue Service (IRS), dated June 30, 2020, which stated that the plan document satisfied the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - RELATED PARTY TRANSACTIONS

The Plan invests in shares of mutual funds managed by affiliates of Fidelity Management Trust Company. Additionally, affiliates of Fidelity Management Trust Company provides recordkeeping services and other services to the Plan. Fidelity Management Trust Company is the trustee and custodian, to the Plan, and therefore, these transactions qualify as party in interest transactions. The Plan made payments totaling \$26,032 for recordkeeping and other administrative services.


