Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Note 1. Description of the Plan

General

The following description of Pepsi-Cola Bottling Company of Lincoln Salary Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by LinPepCo Partnership d/b/a Pepsi-Cola Bottling Company of Lincoln (Company) for the benefit of its employees who have at least one year of service during which at least 1,000 hours were worked and are age 21 or older. Related employers who also participate in the Plan include Pepsi-Cola of Siouxland, Inc.; Pepsi-Cola Bottling Company of Topeka, Inc.; Pepsi-Cola of Western Nebraska, LLC; Pepsi-Cola of Hastings, LLC; and First Choice Vending Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company is the plan administrator. United of Omaha Life Insurance Company (Mutual of Omaha) was the third-party administrator, Security National Bank was the trustee and Matrix Trust Company was the custodian of the Plan. Effective July 15, 2024 Vanguard became the third-party administrator and Ascensus Trust became the trustee and custodian of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100% of eligible compensation. The Plan document includes an automatic deferral feature whereby a participant is treated as electing to defer 4% of eligible compensation unless the participant makes an affirmative election otherwise. Employee rollover contributions are permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes matching contributions of 50% of employees' salary deferral amounts up to 6% of employees' compensation. Company profit sharing contributions are discretionary as determined by the Company's Board of Directors. Contributions are subject to certain limitations. Forfeitures are used to reduce Company contributions and fees incurred by the Plan. There were no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in both their voluntary and matching employer contributions plus earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of credited service.

Notes Receivable from Participant

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. All loans are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or periodic installments over a period not to exceed the participant's life expectancy as stipulated by the Plan. For termination of service due to other reasons, a participant may receive the value in his or her account as a lump-sum distribution.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are valued at estimated fair value. Quoted market prices, if available, are used to value investments.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Matrix Trust Company was the custodian for the period January 1, 2023 to July 14, 2024 and Ascensus Trust is the trustee and custodian of the plan for the period July 15, 2024 to December 31, 2024. Accordingly, the qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

Plan investments were managed by United of Omaha Life Insurance Company, third-party administrator, as defined by the Plan, for the period January 1, 2023 to July 14, 2024. Plan investments were managed by Vanguard, third-party administrator, and Wealthplan Investment Management, advisor and co-fiduciary, as defined by the Plan, for the period July 15, 2024 to December 31, 2024. These transactions qualify as party-in-interest transactions. Fees incurred by the Plan, for the period January 1, 2023 to July 14, 2024, for the investment management services provided were included in net appreciation in fair value of the investment, as they were paid through revenue sharing, rather than a direct payment. Fees incurred by the Plan, for the period July 15, 2024 to December 31, 2024, for the investment management services provided are included in fees, as they are paid through a direct payment.

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. The Plan paid \$7,553 of investment advisory fees to Wealthplan Investment Management and \$7,074 of administrative fees to The Vanguard Group, Inc. during 2024. The Plan paid \$5,027 of administrative fees to United of Omaha Life Insurance Company and \$12,715 of accounting fees to Forvis Mazars, LLP during 2023. Individually nonmaterial expenses paid to parties in interest aggregated approximately \$4,570 during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the plan.

Note 5. Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Investment Contract with Insurance Company

The Plan had a fully benefit-responsive investment contract with United of Omaha Life Insurance Company. United of Omaha Life Insurance Company maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The guaranteed investment contract was fully benefit responsive; therefore, contract value was the relevant measurement. Contract value, as reported to the Plan by United of Omaha Life Insurance Company, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There were no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator did not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, were probable.

The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary employer contributions.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Ascensus Trust. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
