Opinion

We have audited the financial statements of Prospectus Associates, Inc. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1 - Description of Plan

The following description of the Prospectus Associates, Inc. Health Plan (the Plan) provides only general information. Participants should refer to the plan agreement for more complete information.

General

The Plan was a self-insured welfare benefit plan that provided benefits to full-time employees of Prospectus Associates, Inc. (the Company), who had completed 30 days of service working at least 30 hours per week, as well as former employees who elected coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). Benefits were also provided to dependents of these individuals who elected coverage on their behalf. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was a member of Veris Benefits Consortium, LLC, which operated as a health insurance consortium under which the members negotiated and established employee welfare benefit plans for their employees. The employees were required to pay for a portion of the cost of the benefit. Some expenses of the health plan were paid through the Veris Benefits Consortium, LLC Trust (the trust).

On December 12, 2023, the trustees of the Plan signed the termination agreement to leave the Veris Benefits Consortium, LLC effective December 31, 2023. The Plan was terminated as of December 31, 2023. Activity during the year ended December 31, 2024 represents the runout of health claims that occurred prior to January 1, 2024 and monthly insurance premiums until the claims runout was completed.

Contributions

The Company would contribute such amounts to the Plan as necessary for timely payment of all claims and administrative expenses of the Plan. The Company provided stop loss insurance over a specified amount as per agreement with the reinsurance carrier through December 31, 2023, with the premiums being paid by funds deposited in the Plan. The Company was required by the termination agreement to deposit \$208,468 to cover the runout of health claims. Any remaining deposit will be returned to the Company.

Employee contributions were determined on a fixed-fee basis. The amount varied depending on the selection of individual or eligible dependent coverage.

Benefits

The Plan provided health (medical, hospital, surgical, major medical, and prescription drug benefits) through December 31, 2023. The Plan provided dental, vision, short-term disability, long-term disability, life insurance, accidental death and dismemberment benefits, and employee assistance plans through December 31, 2024. Benefits were provided to substantially all employees of the Company who met the service requirements of the Plan and to their covered dependents. The Plan also provided continuation of certain benefits upon termination of employment through COBRA as defined in the plan document.

Benefits (continued)

The Company provided most of the health insurance benefits and paid the administrative fees incurred. The Company also provided short-term disability, long-term disability, life insurance, accidental death and dismemberment, employee assistance plans, and vision coverage on behalf of their eligible employees. The employees paid a portion of their health coverage based upon the coverage elected and also could elect dental coverage through payroll deductions.

Health claims were processed through Capital Blue Cross. All other plan benefits were fully insured.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

Due to the decision to terminate the Plan during 2023, management determined that liquidation of the Plan was imminent and the financial statements for 2024 and 2023 have been prepared using the liquidation basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at liquidation value. Fair value approximates the amount the Plan expected to collect at liquidation. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on the trade-date basis. Interest income was recorded on the liquidation basis, including amounts expected to be earned through the final distribution of plan assets.

Payment of Benefits

Premiums paid by the Company or the trust were recorded as insurance premiums in the accompanying statement of changes in net assets (deficit) available for benefits when paid.

Claim payments were recorded when paid by the third-party claims processor.

Stop Loss Insurance

The Plan had a stop loss insurance arrangement whereby the stop loss insurance would cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$90,000 per covered person for the year ended December 31, 2023. Due to the plan termination, a stop loss gap policy was purchased covering the first three months of 2024. Stop loss refunds of \$-0- and \$949,716 have been netted with claims paid in the accompanying statement of changes in net assets (deficit) for the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the specific stop loss reimbursement receivable was \$-0- and \$69,935, respectively.

In addition, the Plan had an aggregate stop loss insurance arrangement whereby the aggregate stop loss insurance would cover the Plan's obligations if all claims exceeded a fixed dollar amount. Premiums for stop loss insurance were included in insurance premiums in the accompanying statement of changes in net assets (deficit) available for benefits.

Plan Benefit Obligations

Plan obligations for health claims incurred by active participants, but not reported at that date, were estimated by the Plan's management. Such estimated amounts were reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments.

Due to the plan termination, there was no benefit obligation at December 31, 2024. As of December 31, 2023, benefit obligations for claims that had been incurred but not paid totaled \$293,968. This amount was paid in the plan year ended December 31, 2024. It was the Plan's policy that deductions for claims were recorded when paid.

Administrative Expenses

The Plan paid administrative expenses that consisted primarily of administrative fees paid to third-party administrators, the custodian, and actuary. These expenses were reported on the statement of changes in net assets (deficit) available for benefits as administrative expenses. All other administrative expenses, such as professional fees, were paid by the Company on behalf of the Plan.

Note 3 - Plan Administration

The Plan had entered into a service agreement with Capital Blue Cross to provide administrative services for health and prescription drug claims. Capital Blue Cross was responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services or to the employee in accordance with the terms of the Plan. Capital Blue Cross charged a fee based on the number of employees participating in the Plan.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Due to the plan termination, there were no assets at December 31, 2024. The following is a description of the valuation methodology used for assets measured at fair value at December 31, 2023.

The interest bearing cash account was valued at cost, which approximated fair value.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Tax Status

The Plan was funded through a nonqualified trust under Internal Revenue Code (IRC) 419(a). The trust filed Form 1041 U.S. Income Tax Return for Estates and Trusts. Plan management believed that the Plan was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the U.S. Federal, state, or local tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Risks and Uncertainties

The Plan maintained cash in a bank deposit account which could, at times, exceed federally insured limits. The Plan did not experience any losses in such account.

The actuarial present value of benefit obligations was reported based on certain assumptions, applied to historical claim information, which were subject to change. Due to uncertainties inherent in the estimations and assumptions process, it was at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

Note 7 - Related Party Transactions

Certain plan investments were managed by UMB Bank, N.A., the custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management and custody services are immaterial.
