INDEPENDENT AUDITORS' REPORT

To the Administrative Committee and Plan Participants of
Boys & Girls Clubs of America
National 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of the Boys & Girls Clubs of America National 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Opinion

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

Other Matter

Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

The following brief description of the Boys & Girls Clubs of America National 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of the Boys & Girls Clubs of America National (National Organization). The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a participant in a master plan or trust (Master Plan or Trust) in which the National Organization and individual Boys & Girls Clubs have joined by executing an Adoption Agreement. This report covers the Plan of the National Organization only.

Charles Schwab Trust Bank serves as Trustee of the Plan and Milliman, Inc. is the third-party administrator.

Eligibility

For the purpose of elective deferral contributions, each employee of the National Organization becomes a participant in the Plan as soon as administratively feasible after the employees' employment commencement date. For all other purposes of the Plan, each employee of the National Organization becomes a participant in the Plan immediately following completion of one year of service with a minimum of 1,000 hours worked and attainment of age 21.

Contributions

Participants may elect to contribute a percentage of their eligible compensation, as defined in the Plan and subject to limitations of the Internal Revenue Code (IRC). The National Organization provides Safe Harbor matching contributions on behalf of eligible participants. The Safe Harbor matching contributions, which are fully vested and nonforfeitable, are equal to 3% of a participant's eligible compensation for the Plan year.

The Plan provides for eligible employees to be automatically enrolled in the Plan at a pretax withholding rate of 1% of the employee's eligible compensation, unless the employee affirmatively elects otherwise. At the beginning of each subsequent Plan year, the automatic enrollment contributions are increased by 1% of the employee's eligible compensation, up to a maximum of 4% of compensation, unless the employee affirmatively elects otherwise.

The National Organization may also elect to contribute a discretionary matching contribution on behalf of each eligible participant in an amount equal to a percentage, as determined by the National Organization, of the elective deferral contributions made on behalf of the participant during the contribution period, as defined. Discretionary matching contributions may be limited to matching only contributions up to a specified percentage of compensation. In no event may the dollar amount of the discretionary matching contribution made on behalf of an eligible participant for the Plan year exceed 4% of the participant's compensation for the Plan year.

In addition, the National Organization may also elect to make a nonelective employer contribution on behalf of each eligible participant, as defined. For 2024, the National Organization elected to contribute an additional discretionary matching contribution equal to 100% of the participant's contributions up to the first 4% of eligible compensation for each payroll period, and elected not to make a discretionary nonelective employer contribution.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's deferral contributions, the National Organization's contributions, Plan investment income, and charged with any benefit payments and allocations of Plan investment losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of a participant's account.

Investments

Participants elect to have their contributions invested in any or all of the investment options offered. Also, participants may transfer already invested monies among funds at any time.

Vesting

A participant will vest in the National Organization's discretionary matching and nonelective contributions based on a three-year cliff schedule (0% vesting until three years of service, then 100%). Credited service is calculated from the date the employee is hired and is based on 1,000 hours worked in a Plan year.

Forfeitures

Allocations of forfeitures are used to reduce future matching contributions to the Plan. For the year ended December 31, 2024, forfeitures of approximately \$70,400 were utilized to reduce employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$2,754 and \$4,450, respectively.

Revenue Sharing Account

The Plan holds a revenue sharing account (Revenue Credit Account) which is credited by the Plan's Trustee with the return of certain excess revenue generated by certain investments. The Revenue Credit Account may be used to pay reasonable Plan expenses or be allocated to participants. As of December 31, 2024 and 2023, the Plan had \$12,170 and \$9,775 in the Revenue Credit Account; these funds were held in cash at year end. During the year ended December 31, 2024, the National Organization paid approximately \$76,000 of Plan expenses out of the Revenue Credit Account.

Participant Loans

Participants may borrow a minimum of \$1,000 and up to a maximum amount equal to the lesser of \$50,000 (minus the highest outstanding balance of loans from the Plan to the participant during the one-year period ending on the day before the date when the loan was made) or 50% of the participant's vested account balance. Loans are secured by the participant's account balance and bear interest at a fixed rate over the life of the loan. Interest rates are based on the prime interest rate at the time the loan is approved. Repayments of the loans are made in substantially equal payroll deductions amortized over the life of the loan.

Payment of Benefits

Upon termination of service, retirement, death, or disability, a participant (or beneficiaries) may elect to receive the participant's vested benefits: (1) in the form of a lump-sum distribution, or (2) applied to the purchase of an annuity. Such annuity will provide payments over a period not to exceed: (i) either the life of the participant or the lives of the participant and his or her designated beneficiary, or (ii) the participant's life expectancy or the joint life expectancy of the participant and his or her designated beneficiary. All elections are subject to the application of the Qualified Joint and Survivor annuity rules except where the lump sum value of the participant's vested benefit is \$5,000 or less, in which case, only a lump sum is available. Participants may request in-service withdrawals if they are at least 59½ or have an immediate financial hardship.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates, Risks and Uncertainties

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Shares of mutual funds are valued at the net asset value (NAV) of shares of such funds held by the Plan based on quoted market prices. The valuations of the investment in the common collective trust (CCT) is based upon the NAV as provided by the custodian of the fund. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Administrative Expenses

All administrative expenses, except to the extent paid by the Plan, are paid by the National Organization. The fees paid by the Plan are a combination of participant-initiated transactional fees and recordkeeping and administrative fees paid through the Revenue Credit Account, as discussed in Note 1.

Payment of Benefits

Benefits are recorded when paid by the Plan.

3. FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement and Disclosures*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The level in the fair value hierarchy within which a fair value measurement falls is based on the lowest level input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used.

Mutual funds – Valued at the NAV of shares of such funds held by the Plan based on quoted market prices.

Common collective trust funds (CCT) – Valued at the NAV of units held by the Plan at year end. The NAV of units in the CCT is determined by the custodian of the fund based on the fair market value of the underlying assets. There are no redemption restrictions or unfunded commitments relative to the CCT. The CCT transacts on a daily basis.

The following table sets forth by level, within the fair value hierarchy, the Plan’s participant-directed assets at fair value as of December 31, 2024 and 2023. The Plan’s policy is to recognize transfers between levels as of the end of the reporting period.

4. INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee of the Plan.

5. RELATED PARTY TRANSACTIONS

Fees paid by the Plan to the Trustee for recordkeeping services and participant-initiated transactions are related party transactions. Certain fees paid to the Trustee for the year ended December 31, 2024, are reflected in the statement of changes in net assets available for benefits. Additionally, for the year ended December 31, 2024, the Plan paid certain administrative expenses of approximately \$76,000 to the Plan’s third-party administrator with the Revenue Credit Account, as described in Note 1.

6. PLAN TERMINATION

The National Organization reserves the right, by and through its Board of Governors, at any time to terminate the Plan, and from time to time to amend or modify the Plan. However, no amendment or modification of the Plan shall make it possible for any part of the Plan's trust funds to be used for or diverted to purposes other than for the exclusive benefit of participants or their beneficiaries and to cover reasonable administrative expenses of the Plan.

In the event of termination of the Plan, all participants become fully vested, which includes all contributions made by the National Organization.

7. TAX STATUS

The Master Plan that the Plan has adopted received a favorable determination letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Master Plan has been amended since receiving the favorable opinion letter; however, the Plan administrator and Plan management believe that the Master Plan and Plan are designed and are currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, including the IRS. The Plan is not currently under IRS examination for any Plan years.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure under FASB ASC Topic 855, *Subsequent Events*.
