INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees
Great Basin Institute Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Great Basin Institute Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Great Basin Institute Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1: DESCRIPTION OF PLAN

The following brief description of Great Basin Institute Retirement Plan (“the Plan”) is provided for general information purposes only. Participants should refer to the Plan’s Summary Plan Description, Adoption Agreement and Master Plan Document for more complete information.

General

The Plan is a defined contribution plan covering all employees of Great Basin Institute (“the Employer”) who meet Plan eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(k) of the Internal Revenue Code.

The employer of the plan, Great Basin Institute is an interdisciplinary field studies organization that promotes environmental research, education, and conservation throughout the West. Founded in 1998 at the University of Nevada, the Institute’s mission is to advance applied research and ecological literacy through community engagement and agency partnerships to support national parks, forests, open spaces, and public lands.

Eligibility

Employees who are not classified as seasonal or temporary are eligible to participate in the Plan if they have three months of employment and are 21 years of age. Seasonal and temporary employees must be 21 and have one year of service. Employees may enter the plan on the first day of the month following the date they satisfy the Plan’s eligibility requirements.

Contributions

Each year, participants may contribute up to 100% of their pretax annual compensation, as defined in the Plan. Contributions are subject to certain Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Employer contributes 100% of the first 4% of base compensation that a participant contributes to the plan. Additional amounts may be contributed at the discretion of the Board of Directors. No such additional discretionary contributions were made for the year ended December 31, 2024.

Participant accounts

Each participant’s individual account is credited with the participant’s contributions, rollovers, the Employer’s matching contributions, as well as the Employer’s discretionary

contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participants compensation, account balances or specific transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct his/her account and may select from mutual funds and other investment options available under the investments contract with Ascensus Trust Company/Vanguard. Participants may change their investment options daily.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. This also includes the Employer safe harbor contribution and actual earnings thereon. Vesting in the employer's discretionary contribution plus actual earnings thereon is based on years of continuous service. A participant vests at a rate of 20% after two years of service, with an additional 20% for each additional year of service completed thereafter. A participant is 100% vested after six years of credited service.

Benefit Payments

On termination of service, retirement, permanent disability or death, a participant or their beneficiary will receive a lump-sum distribution equal to the value of his or her account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$14,720 and \$10,309 respectively. These accounts will be used to reduce future employer contributions. During the year ended December 31, 2024, employer contributions were reduced by \$429 from forfeited non-vested accounts.

Loans to Participants

Loans are not allowed in this Plan.

Administrative Expenses

Administrative expenses related to the Plan as a whole are paid by the employer. Fees charged to administer individual accounts are paid out of those account balances. Administrative fees charged to individual accounts amounted to \$14,130 and \$10,558 for the years ended December 31, 2024 and 2023, respectively.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

The financial statements are prepared using the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

Valuation of Investments

Investments in mutual funds, interest bearing cash, and collective investment trusts are reported at the values reported to the Plan by Ascensus Trust, which represents approximate fair value. The market volatility of equity-based investments is expected to substantially impact the value of such investments at any given time. It is likely the value of the Plan's investments, both in total and in individual participant accounts, has changed since December 31, 2024.

Cash Equivalents

Cash equivalents are considered to be short-term, highly liquid investments with original maturities of three months or less.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements and supplemental schedule. The Plan's exposure to credit loss in the event of nonperformance of investments is limited to the carrying value of such instruments. The Plan's concentration of credit risk and market risk is dictated by the Plan's provisions as well as those of ERISA and the participant's investment preferences.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Employer's Contribution Receivables

Receivables represent Companies' nonelective contributions which have not been remitted to the Plan by the Companies at December 31, 2024 and 2023.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures about fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

NOTE 3: INFORMATION CERTIFIED BY ASCENSUS TRUST

Investment information disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and interest income for the year ended December 31, 2024 and 2023, was obtained and derived from information supplied to the Plan Administrator and certified complete and accurate by Ascensus Trust. Accordingly, as permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the certified information, except for comparing such information certified by Ascensus Trust with information included in the Plan's financial statements and supplemental schedule.

During 2024, the plan's investments (including gains and losses on investments bought and sold, as well as held during the year) appreciated in the value of \$339,238.

NOTE 4: FAIR VALUE OF FINANCIAL INSTRUMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

The three levels of the fair value hierarchy under FASB ASC 820-10 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The inputs or methodologies used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 6: CONTRIBUTIONS RECEIVABLE

At December 31, 2024 and 2023, \$890 and \$8,712 in total employer contributions were owed to the Plan. The 2024 contribution receivable was paid in full in May 2025. The Plan contribution is generally funded after every pay period. The contribution is calculated on an annual basis and adjusted to any errors at that time. Forfeitures from prior years can be used to reduce employer contribution and are adjusted at this time.

NOTE 7: PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investment are funds managed by Ascensus Trust. Ascensus Trust is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA. Fees paid by the Plan for Ascensus Trust contract administration fees amounted to \$14,130 and \$10,558 for the years ended December 31, 2024 and 2023, respectively.

NOTE 8: ADMINISTRATION OF PLAN ASSETS

The Company's contributions are held and managed by the Plan's custodian, who invests cash received, principal, and interest collected as directed by participants. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the plan. Administrative expenses for legal and accounting services are paid directly by the Company.

NOTE 9: INCOME TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

NOTE 10: PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.
