## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the  
Forward Financing LLC Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Forward Financing LLC Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **1. Description of the Plan**

The following description of the Forward Financing LLC Retirement Plan (the Plan) is intended to provide only general information regarding the Plan. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan qualified under Section 401(a) of the Internal Revenue Code (IRC or Code) which is a deferred arrangement qualified under Section 401(k) of the Code. Pursuant to the requirements of Section 401(a) 27 of the Code, the Plan is also a profit-sharing plan. The Plan covers all eligible employees of FF Holdings and Subsidiaries (FF Holdings LLC, Forward Financing LLC, ForFinDR SRL, and FF Intermediate Holdings, Inc., FF Canada, Inc. and Alcazar Capital LLC, collectively referred to as the Company or Employer), who elect to contribute to the Plan and meet the eligibility requirements of the Plan. The Plan initially became effective on January 1, 2015, for the purpose of providing benefits to participants upon retirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act 1974 (ERISA) and contains a cash or deferred arrangement under Section 401(k) of the IRC.

The Company is also the Plan Administrator. As Plan Administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal) and certain officers of the Company serve as trustees to the Plan.

***Eligibility***

For the purposes of eligibility to make elective deferral contributions, there are no minimum service requirements for employees. For employees to become eligible to receive profit-sharing contributions, completion of one year of service is required, as defined by the Plan. Employees are eligible to participate in the Plan to make elective deferral contributions upon their hire date and/or at any day during the Plan year. They are eligible to receive Employer contributions on the first day of the month following the date that the employee began participating. The Plan includes an automatic enrollment provision whereby eligible employees are automatically enrolled into the Plan unless they opt out.

***Contributions***

Participants may elect to contribute a percentage of their annual compensation to the Plan, up to 100% of eligible compensation and subject to certain limitations as allowable under Section 401(k) of the IRC. These contributions, and earnings thereon, are not subject to federal income taxes until withdrawn from the Plan. Participants may roll over amounts representing distributions from other qualified defined benefit or contribution plans.

The Employer will make safe harbor matching contributions that are equal to 100% of a participant's elective contribution up to a maximum of 3% of their compensation and 50% of the elective contribution made for the participant's benefit on the next 2% of their compensation. For the year ended December 31, 2024, a true-up of approximately \$90,800 was required. The Plan provides for discretionary matching and discretionary profit-sharing contributions from the Company. The Employer may also make qualified non-elective contributions (QNECs).

There were no discretionary matching contributions made for the year ended December 31, 2024. All contributions to a participant's account are allocated among the various investments based on each participant's elections.

The Plan also allows Roth 401(k) contributions through either participant deferrals from gross income or rollover of designated Roth contributions.

The Plan includes an automatic pre-tax deferral contribution of 3% with automatic annual increases of 1% for all contributing employees until a deferral rate of 6% is reached.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Employer's safe harbor and discretionary matching contributions and allocations of the Company's discretionary profit-sharing contribution, if applicable, and Plan earnings/losses. Plan earnings/losses and administrative revenue (expenses) are allocated to participant accounts based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's safe harbor match contribution portion of the participant accounts is based on years of service in accordance with the following schedule.

***Participant Notes Receivable***

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Principal and interest on note payments are recorded as contributions to the account from which the note was borrowed. Notes are repayable over a period of up to five years, unless used for the purchase of a primary residence.

The notes bear interest at rates commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

***Payment of Benefits***

Upon retirement from service, total and permanent disability, termination of employment or death, participants will receive the value of their account balance in a lump-sum distribution, in accordance with the provisions of the Plan. If a participant reaches age 59½, the participant may elect to receive all or a portion of his or her pre-tax contributions account. The Plan also provides for mandatory distributions to participants upon reaching age 73.

In the event of death, benefits are payable to the participant's surviving spouse or designated beneficiary. At any time, a participant may also elect to receive all or a portion of his or her rollover contributions. Terminated participants with vested account balances greater than \$5,000 may maintain their account in the Plan or receive a lump-sum distribution; vested balances equal to or less than \$5,000 will be immediately cashed out. Hardship withdrawals from the Plan are permitted, subject to the limitations imposed by the IRC.

Effective January 1, 2024, the Plan adopted certain provisions of the SECURE Act 2.0. The adoptions consisted of increasing the limit for involuntary automatic rollovers for small account balances and distributions that require spousal consent from \$5,000 to \$7,000 and eliminated the 10% early withdrawal penalty for distributions to participants with a terminal illness.

***Forfeitures***

Any balance in the Employer contribution account of a participant who has separated from service, to which he or she is not entitled, shall be administered by the trustee and subsequently used to pay administrative expenses or reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$36,058 and \$76,631, respectively. Forfeitures were used to reduce administrative expenses in the amount of \$16,596 for the year ended December 31, 2024. Forfeitures were used for Employer contributions in the amount of \$63,347 for the year ended December 31, 2024.

***Plan Termination***

The Company expects to continue the Plan indefinitely. However, the Company reserves the right to amend the Plan or contributions thereto, at any time and in any manner that it deems advisable, provided that no amendment shall have the effect of diverting Plan assets for purposes other than for the exclusive benefit of the Plan participants and any Plan termination would be subject to the provisions of ERISA. If the Plan is terminated, the participants would become fully vested and entitled to receive all amounts credited to their accounts.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Valuation of Investments and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Participant Notes Receivable***

Participant notes receivable are measured at their unpaid principal balances plus any accrued but unpaid interest and are secured by the balance in the respective participant's account. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned.

A receivable is considered past due if payment has not been received within stated terms. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

***Contributions***

Participant and Employer safe harbor matching contributions are recorded weekly when the Employer remits the payroll deductions for investment into the Plan. Employer discretionary matching and discretionary profit-sharing contributions are recorded at the end of the year, if applicable.

***Payment of Benefits***

Benefits are recognized when paid to participants or their designated beneficiaries.

***Administrative Revenue (Expenses)***

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Employer are excluded from these financial statements. Participant notes receivable set-up and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses.

Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits. Administrative revenues arise when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. There were no unallocated administrative revenues held by the Plan at December 31, 2024 and 2023.

***Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

***Risks and Uncertainties***

The Plan provides for various investment options with various investment objectives. Investment securities are exposed to various risks such as interest risk, market risk and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in three mutual funds that accounted for approximately 48% and 47% of total Plan investments as of December 31, 2024 and 2023, respectively.

***Financial Instruments with a Concentration of Credit Risk***

The Plan's investments are held by a single trustee. The Plan's exposure to credit risk is associated with the outside entity's non-performance of their fiduciary responsibilities relating to these amounts as specified in the agreements. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

***Subsequent Events***

Management has evaluated subsequent events through September 26, 2025, which is the date these financial statements were available to be issued.

**3. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts:* Valued using NAV provided by the administrator of the fund based on the valuation of the underlying investments. The NAV is used as a practical expedient to estimate fair value. The pooled separate accounts have a daily redemption frequency and no redemption notice period.

As of December 31, 2024 and 2023, the Plan’s investments in mutual funds are reported at level 1 within the fair value hierarchy.

**5. Income Tax Status**

The Plan is operating under a non-standardized pre-approved profit-sharing plan document designed and sponsored by MandMarblestone PC (MMPC). MMPC has obtained an advisory letter dated June 30, 2020 stating that the form of the Plan is acceptable under Section 401 of the IRC. Generally, the Plan Administrator and the Plan may rely on the advisory letter received by MMPC as to the form of the Plan qualifying under the IRC. The Plan has been amended since the letter was obtained. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the Plan Administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500, and these financial statements are a result of different classifications between line items and the inclusion of receivables in the accrual basis financial statements. Total Plan assets, exclusive of contributions receivable, are in agreement.

**7. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are held and managed by Principal, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to Principal for administrative services totaling approximately \$50,100 for the year ended December 31, 2024. The Plan also made direct payments to its third-party administrator, MMPC, of approximately \$5,800 for the year ended December 31, 2024. Participant notes receivable also qualify as party-in-interest transactions.

MMPC provides certain administrative services to the Plan pursuant to a MMPC Retirement Plan Service Agreement (MRPSA) between the Company and MMPC. MMPC receives revenue from Principal's mutual fund service providers for services Principal provides to the funds. This revenue is used to offset certain amounts owed to MMPC for its administrative services to the Plan. The amount used to offset administrative services to the Plan during the year ended December 31, 2024 was approximately \$7,400.
