Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Anita's Mexican Food 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Anita's Mexican Food 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Anita's Mexican Food 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Anita's Mexican Food 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan, which was adopted on January 1, 2020, is a defined contribution plan covering all full-time employees of Anita's Mexican Foods Corp. (the "Company") who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of ERISA. The plan covers the following sponsors: Anita's Mexican Foods Corp., Old Pueblo Ranch, Inc., and Five Oaks Partners Services, LLC. The trustee and the recordkeeper for the Plan's investments is Capital Bank and Trust Company ("Capital Group"). The Company is the Plan's sponsor and serves as the plan administrator.

Contributions: Each year, participants may contribute a percentage of pretax compensation as limited by the law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute (rollover) amounts representing pre-tax distributions from other qualified plans. The Plan includes automatic enrollment for each eligible participant at 5% of their annual compensation. All Company contributions to the Plan are determined at the discretion of the Company's board of directors at 20% of the first 5% of employee deferrals. The Company's matching contribution for the years ended December 31, 2024, and 2023 amounted to \$80,769 and \$88,928 respectively.

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings. Allocations may be determined proportionately based on participant earnings or account balances. Participants direct the investments of their contributions and the Company's matching contributions, if any, into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their contributions plus actual earnings or losses thereon. Vesting in the Company's contribution to the participants' accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service. Upon retirement age, death, disablement or termination of the Plan by the Company, a participant becomes fully vested.

Notes receivable from participants: Participant loans are not permitted by the Plan.

Payment of benefits: Upon termination of service due to death, permanent disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments, or partial payments. Additionally, participants may keep their account with the Plan or rollover the balance to another qualified retirement account. The Plan also allows in-service hardship withdrawals before retirement age for qualifying circumstances.

Forfeited accounts: Forfeitures of nonvested accounts may first be used to pay any administrative expenses and any remaining forfeitures will be used to reduce any Company contribution. The forfeited nonvested accounts amounted to \$54,796 and \$38,170 at December 31, 2024 and 2023, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America ("GAAP").

Use of estimates: The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition: The Plan's participant directed investments are reported at fair value as determined by the Trustee based on factors such as quoted market prices in active markets and prevailing interest rates. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contributions are invested in unaffiliated mutual funds.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits: Distributions to the participants of the Plan are recorded when paid.

Administrative expenses: Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan for the year ended December 31, 2024 totaled \$29,399.

Subsequent events: The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology are observable other than level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
Level 3	Inputs to the valuation measurement are unobservable, supported by the little or no market data, and are significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies of mutual funds used at December 31, 2024.

NOTE 3. FAIR VALUE MEASUREMENTS (continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are considered Level 1 assets. The NAV is a quoted price in an active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4. EXCESS CONTRIBUTIONS

Participants' contributions include \$13,892 and \$30,371 of excess contributions for the year ended December 31, 2024, and 2023, respectively. The 2024 and 2023 excess contributions were returned to the participants before March 15, 2025, and 2024, respectively. The required excise form and penalties were filed and paid as a result.

NOTE 5. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are made available by Capital Bank and Trust Company, who is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Fees incurred by the Plan for investment servicing are included in net appreciation (depreciation) in fair value of investments and amounted to, as they are paid through revenue sharing, rather than direct payment.

During the years ended December 31, 2024 and 2023, the Plan made direct payments of \$29,399 and \$36,693, respectively, to third party servicers for recordkeeping, trustee, and investment advisory services, which were not covered by revenue sharing. Of these payments, certain fees of \$24,271 paid to the recordkeeper are considered to be party-in interest transactions under ERISA. The Company pays directly any other fees related to the Plan's operations, other than investment management fees.

NOTE 6. CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company, a qualified institution.

NOTE 8. TAX STATUS

The Plan document is a pre-approved prototype plan that received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the favorable opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the federal or state tax authorities. The Plan's administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 10. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 11. OPERATIONAL ERROR

Plan management discovered an error during the transition to a new payroll company that occurred in 2024. An amount of \$6,442 of employee contributions were misclassified as employer contributions in 2024. Plan management intends to correct the error in 2025. The statement of changes in net assets available for benefits for the year ended December 31, 2024 reflects the correction.

NOTE 12. DELINQUENT PARTICIPANT CONTRIBUTIONS

In accordance with CFR 2510.3-102, participant contributions that have been withheld by an employer from a participant's wages for contribution to the plan are required to be remitted to the plan on the earliest date that they can reasonably be segregated from the employer's general assets, but in no event later than the 15th business day of the month following the month in which the participant contributions are withheld or received by the employer. During the year ended December 31, 2024, and 2023, the Company failed to remit employee contributions totaling \$13,478 as of December 31, 2024, which includes late remittances of \$6,135 from the year ended December 31, 2023, in a timely fashion as described by CFR 2510.3-102. The late transmissions of participant contributions constitute a prohibited transaction under ERISA section 406, regardless of materiality.
