Opinion

We have audited the accompanying financial statements of Jungle Jim's Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for plan benefits for the years then ended and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Jungle Jim's Savings Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Jungle Jim's Market, Inc. and the Jungle Jim's Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.



NOTE 1 - PLAN DESCRIPTION

The following description of the Jungle Jim's Savings Plan (the "Plan") is provided for general purposes only. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan's provisions.

GENERAL

The Plan is a 401(k) defined contribution proto-type plan sponsored by Clark, Schaefer, Hackett & Company covering all employees of Jungle Jim's Market Inc. (the "Company") who have completed one year of service (at least 500 hours as amended effective July 1, 2024 or at least 1,000 for the plan year ended 2023) and have attained 21 years of age and whom are not employees covered in a collective bargaining agreement or non-resident aliens. Each employee who has met the eligibility requirement will automatically become a participant on the first entry date which occurs after satisfying the requirements. The Plan entry dates are January 1 and July 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

CONTRIBUTIONS

The Company's contribution is determined at the discretion of the directors of the Company. The Company made matching contributions of \$103,487 and \$101,180 in 2024 and 2023, respectively, which matched 100% of employee salary deferrals up to \$500. The Company made no profit-sharing contributions to the Plan in 2024 or 2023.

Participants may contribute through payroll deduction in either a pre-tax deferral or Roth deferral (after-tax) by a specific percentage or dollar amount of the participant's compensation. Employees can contribute up to \$23,000 to the Plan annually for the plan year ended 2024 and \$22,500 for the year ended 2023. Employees over the age of 50 are allowed an additional \$7,500 to be deferred based on Internal Revenue regulations for the years ended 2024 and 2023. These amounts are treated as tax deferred compensation (if pre-tax deferral elected) and are exempt from federal taxation until they are withdrawn from the Plan.

PARTICIPANT ACCOUNTS

Each participant's account is adjusted by (a) the participant's contribution, (b) allocations of any employer's contributions, and (c) allocations of the Plan's earnings or losses (including any administrative expenses paid by the Plan). Allocations are based upon the performance of the investment funds chosen by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

FORFEITURES

Any portion of a participant's account which is not vested at the time of termination from the Plan is forfeited immediately at the date of termination. Forfeitures are used to reduce the employer's contributions. The forfeited non-vested account totaled \$400 and \$747 at December 31, 2024 and 2023, respectively. The Company utilized forfeitures of \$5,167 and \$2,542 to reduce the employer's match contributions in 2024 and 2023, respectively.

PAYMENT OF BENEFITS

The Plan provides for distribution of a participant's account upon termination of employment, retirement, death or disability under several options. If the participant's vested interest is greater than \$1,000, the participant may choose to receive his benefit in the form of a single lump sum payment in cash or in partial payments with the minimum being \$1,000. If the participant's vested interest is less than \$1,000 then the benefit may only be distributed in a single lump-sum payment.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The accompanying financial statements of the Plan have been prepared in accordance with U.S. generally accepted accounting principles with the applicable accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

A summary of the Plan's significant accounting policies consistently applied in the preparation of the accompanying financial statements follows:

BASIS OF ACCOUNTING

The financial statements are prepared on the accrual method of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan invests in a contract with John Hancock Life Insurance Company (U.S.A.) in pooled separate accounts of segregated mutual fund investments with John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) has based its contract value of its pooled separate accounts utilizing the fair market value of the underlying assets using the daily quoted market prices of publicly traded investments. The contract value is equal to the number of participation units owned under the contract in each pooled separate account times the unit value of the participation units.

Purchases and sales are recorded on a trade-date basis. Interest and dividend income are recorded on an accrual basis.

The change in the unrealized difference between cost and fair value of investments held is reflected in the statement of changes in net assets available for benefits as net appreciation (depreciation) in fair value of investments. Gains and losses on disposition of investments are recognized at the time of disposition with the amount of gain or loss determined on an average cost basis.

ADMINISTRATIVE EXPENSES

Most administrative expenses for the Plan are paid by the Company.

BENEFIT PAYMENTS

Benefits are recorded when paid.

PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one-hundred-percent (100%) vested in their accounts.

FUNDING POLICY

Effective July 1, 2024 the funding policy is, "Since the principal purpose of the plan is to provide benefits at normal retirement age, the principal goal of the investment of the funds in the plan should be both security and long-term stability with moderate growth commensurate with the anticipated retirement dates of participants. Investments, other than "fixed dollar" investments, should be included among the plan's investments to prevent erosion by inflation. However, investments should be sufficiently liquid to enable the plan, on short notice, to make some distributions in the event of the death or disability of a participant."

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The United States generally accepted accounting principles provide a framework for measuring fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The Plan has no level 1, 2 or 3 investments in 2024 or 2023.

NOTE 4 - INVESTMENT CONCENTRATIONS

Pooled Separate Account Investments that have significant concentration in the Plan are John Hancock Multi-Index Lifestyle Balanced and John Hancock Multi-Index Lifestyle Growth. As of December 31, 2024 and 2023 investments were \$4,212,310 (58.11%) and \$4,212,310 (61.95%), respectively.

NOTE 5 - INCOME TAX STATUS

The Plan is a prototype plan offered by Clark, Schaefer, Hackett & Company. Clark, Schaefer, Hackett & Company obtained its latest opinion letter on March 1, 2017, in which the Internal Revenue Service has determined and informed the Company that its' volume submitter plan is designed in accordance with the Internal Revenue Code (Code) sections 401(a). The Jungle Jim's Savings Plan adopted the Plan on July 1, 2014. The prototype plan has been amended since the determination by the Internal Revenue Service to conform with Qualified Domestic Relations Order Internal Revenue Code Section 414(p). The Plan has also been amended effective July 1, 2024 to change the year of service employee eligibility from 1,000 hours to 500 hours to comply with the Secure Act 2.0. Management believes that the Plan is designed in accordance with the Internal Revenue Code section 401(a). Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 6 - RELATED PARTY TRANSACTIONS

John Hancock Life Insurance Company (U.S.A.) the custodian of the general plan assets of the Plan also has a related party John Hancock Asset Management that manages the investment assets of the following Plan investments; Multi-Index Lifestyle Aggressive, Multi-Index Lifestyle Balanced, Multi-Index Lifestyle Conservative, Multi-Index Lifestyle Growth and Lifestyle Moderate, John Hancock Disciplined Value and John Hancock Short Term Federal as well as Target dated 2025, 2030, 2035, 2045, 2050, 2055, 2060 and 2065 Lifetime Funds. Therefore, transactions with John Hancock Life Insurance Company (U.S.A.) qualify as party-in-interest transactions. Fees paid directly to John Hancock for contract administration were \$26,737 and \$23,665 for the years ended December 31, 2024 and 2023, respectively.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various pooled investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - DATE OF MANAGEMENT'S REVIEW

Management has evaluated subsequent events through September 26, 2025, the date on which the financial statements were available for issue. There were no material subsequent events from December 31, 2024 thru September 26, 2025.
