## Independent Auditors' Report

To the Plan Participants and Plan Administrator  
General Dynamics Corporation Long-Term Disability Plan:

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of General Dynamics Corporation Long-Term Disability Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical



requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

#### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

#### *Auditors' Responsibilities for the Audit of the Financial Statements*

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information



to assess whether they are in accordance with the presentation and disclosure requirements of U.S. generally accepted accounting principles.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### *Supplemental Schedules Required by ERISA*

The supplemental schedules of Schedule H, Line 4j - Schedule of Reportable Transactions for the Year Ended December 31, 2024 and Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**(1) Description of the Plan**

The following description of the General Dynamics Corporation Long-Term Disability Plan (the Plan) provides general information only. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

**(a) General**

The Plan was established on July 1, 1979. Prior to January 1, 2002, the Plan was self-insured and funded (see Note 1(c)). Effective January 1, 2002, the Plan became a fully insured, funded welfare benefit plan covering the eligible full-time and benefits eligible part-time nonrepresented employees and specific represented employees of certain wholly owned business units of General Dynamics Corporation (the Company, the Plan Administrator and the Plan Sponsor). The Plan is funded through a Voluntary Employees' Beneficiary Association Trust, the General Dynamics Corporation Employee Long-Term Disability Trust (the VEBA Trust). The Hartford is the recordkeeper and processor of benefit payments for the Plan.

**(b) Eligibility**

Eligible employees must be active on the date the coverage is scheduled to begin; however, coverage may extend into a post-employment period pursuant to the terms of the Summary Plan Description.

**(c) Benefits**

Long-term disability benefits vary at the covered subsidiaries. Benefits are provided to participants in the amount of 50% or 60% of eligible earnings less other monthly earnings or benefits, as defined by the Plan and the participant's benefit coverage election. Effective January 1, 2002, the Plan became fully insured through The Hartford and thus, The Hartford is liable for all subsequent claims. Participants that became disabled prior to January 1, 2002, are grandfathered under the self-insured funding arrangement.

**(d) Contributions**

The Plan Sponsor makes periodic payments into the Plan for the benefit of the employees eligible to participate in the self-insured portion of the Plan. Such payments are determined by the Plan Sponsor and the actuary. The Plan Sponsor did not make contributions in 2024 or 2023, as the minimum funding requirements of the Employee Retirement Income Security Act of 1974, as amended (ERISA) have been met.

Under the terms of the full-insurance coverage, the Plan Sponsor pays monthly premiums to the coverage provider, The Hartford. Participants may contribute specified amounts depending upon the specific benefit offered and the benefit coverage that they have elected. Participant contributions for active employees are withheld from payroll checks. The costs of post-employment benefits, where applicable, are shared by the Plan and eligible participants. Participants' contributions vary based on the business unit by which the participant is employed.

**(e) *Risks and Uncertainties***

The investment is exposed to various risks such as interest rate, market, liquidity, and credit risks, as well as risks associated with global events. Due to the level of risk associated with the investment, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits and the funded status of the Plan.

In addition, the actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**(2) Summary of Significant Accounting Policies**

**(a) *Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

**(b) *Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(c) *Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date.

Interest income is recorded on the accrual basis. Purchases and sales are recorded on a trade-date basis.

**(d) *Payment of Benefits***

Benefits are recorded when paid by The Hartford.

**(e) *Administrative Expenses***

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators, the Trustee, and other professional services provided. These expenses are reported on the Statement of Changes in Net Assets Available for Benefits as administrative expenses.

**(3) Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments at fair value and interest receivable at December 31, 2024 and 2023, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by The Northern Trust Company (the Trustee of the Plan).

**(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the assets or liabilities;
  - Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Units of Common Trust Fund:* The fair value of this private investment security is determined using the net asset value as provided by the fund manager (Level 2). The investment is redeemable daily at net asset value, and there are no significant restrictions on redemptions.

**(5) Receivables from Participants**

The receivables represent excess benefit payments to participants. Receivables are recorded at the amount due and do not bear interest. The participants are reimbursing the Plan through a reduction of future benefits, direct payments, and a reduction of future life insurance benefits, as applicable, if the participant has a life insurance policy with The Hartford. Receivables are examined to determine their collectability. The allowance for doubtful accounts is based on various factors including the length of time receivables are past due, a weighted average of risk of the outstanding balances and collectability. At December 31, 2024 and 2023, the Plan has an allowance for doubtful accounts of \$0 and \$4,065, respectively.

**(6) Payable to The Hartford**

At December 31, 2024 and 2023, the Plan has a payable to The Hartford of \$9,142 and \$9,108, respectively. The liability represents benefit payments that have been made by The Hartford but have not yet been funded by the Plan.

**(7) Premium Deposit**

At December 31, 2024 and 2023, the Plan has a premium deposit of \$104,294 and \$208,590, respectively. The amount represents the market value adjustment as the result of the termination of the Deposit Fund during 2020. The amount will be applied as a reduced premium rate for the employee-paid long-term disability 60% buy-up coverage over a four-year period effective January 1, 2022. For the year ended December 31, 2024, the amount of \$104,296 was applied towards premiums and reported on the Statement of Changes in Net Assets Available for Benefits as premiums paid.

**(8) Benefit Obligations**

The future disability benefits reserve is established for the self-insured portion of long-term disability claims approved as of December 31, 2024 and 2023. This actuarial reserve represents the present value of the estimated total future benefits to be paid to disabled employees covered under a self-insurance arrangement, after taking into account interest, mortality, and recovery rates. The reserve is released upon recovery or death of the disabled employee and is reduced to zero at the end of the scheduled benefit.

**(9) Actuarial Assumptions**

The morbidity table used in calculating the benefit obligation is based on 2016 Commissioner's Group Disability Table for 2024 and 2023, with an interest discount rate of 4.572% and 4.755% for 2024 and 2023.

**(10) Tax Status**

The Plan obtained a favorable Internal Revenue Service (IRS) determination letter dated September 30, 2003, stating the trust by which the Plan is funded is a qualified trust under Section 501(c)(9) of the Internal Revenue Code (IRC) and is exempt from Federal income tax. Subsequent to the receipt of the favorable IRS determination letter, the Plan has been amended. Effective January 1, 2006, the Plan entered into a new trust agreement with The Northern Trust Company. The Plan Sponsor and the Plan's counsel believe that the Plan, as amended, and the related new trust are currently designed and are being operated in compliance with the IRC; therefore, the Plan Sponsor believes the Plan qualifies as tax exempt pursuant to Section 501(c)(9) of the IRC as of December 31, 2024 and 2023, and no provision for income taxes, other than discussed below, has been included in the accompanying financial statements.

Earnings related to the Plan assets are subject to unrelated business income tax, pursuant to Section 419(a) and Section 512 of the IRC. The Plan had an income tax receivable of \$17,000 and \$0 as of December 31, 2024 and 2023, respectively. The Plan had an income tax payable of \$0 and \$92,000 as of December 31, 2024 and 2023, respectively. A tax expense of \$173,000 is recorded for the year ended December 31, 2024, which is included in administrative expenses in the Statement of Changes in Net Assets Available for Benefits.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. Under the IRS Statute of Limitations, the Plan is no longer subject to income tax examinations for years prior to 2021.

**(11) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to suspend or discontinue contributions at any time and to terminate the Plan in whole or in part subject to the provisions of ERISA. In the event of complete or partial Plan termination, participants will be fully vested in claims incurred prior to termination. The Plan's net assets, which exceed the Plan's obligations by \$9,957,457 and \$9,820,629 as of December 31, 2024 and 2023, respectively, will be used to pay benefits to all covered employees.

**(12) Related Party and Party-in-Interest Transactions**

The Hartford is a service provider to the Plan; therefore, transactions with The Hartford qualify as exempt party-in-interest transactions. The Plan invests in units of a common trust fund managed by Northern Trust Investments, Inc., an affiliate of the Plan's Trustee, in the amounts of \$9,858,181 and \$9,798,652 as of December 31, 2024 and 2023, respectively. This investment and fees paid by the Plan to The Northern Trust Company and other service providers qualify as related party transactions.

Receivables from participants also qualify as exempt party-in-interest transactions.

**(13) Subsequent Events**

Plan management has evaluated all other subsequent events and transactions that occurred after December 31, 2024, through September 3, 2025, which is the date the financial statements were available to be issued. No events were deemed relevant for disclosure.
