### Note 1 - Plan Description

The following description of Flex Pack Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by ACW Flex Pack, LLC covering all employees, other than those covered by a collective bargaining agreement, leased employees, or nonresident aliens, of Phoenix Converting, Inc.; Valley Packaging Supply Co., Inc.; PCG/SPT Holdings, Inc. dba Precision Color Graphics; Bag Pack Holdings, Inc.; and ACW Flex Pack Management, Inc. (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to regular deferral contributions. The Plan also allows participants to make Roth contributions. Participants may make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain employee deferrals and participant loan payments in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and remitted related lost earnings to the Plan in 2024.

The Company makes safe harbor matching contributions equal to 100 percent of participant deferrals up to 3 percent of each participating employee's elective deferral, plus 50 percent of the next 2 percent of the participant's deferrals.

The Company may also make discretionary matching contributions based on a percentage of contributions made during the plan year. There were no discretionary matching contributions in 2024.

The Company may also make annual discretionary profit-sharing contributions to eligible participants employed at the end of a plan year. There were no discretionary profit-sharing contributions in 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balances. Generally, loan terms are a maximum of five years, but residential loans may be longer. Principal and interest are paid ratably through regular payroll deductions. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' and employer contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum or installment payments equal to the vested balance of a participant's account. Participants are also eligible for in-service benefit payments upon reaching the normal retirement age of 59½.

Participants may request that all or a portion of their vested account balances related to pretax deferrals or rollover contributions be distributed in the case of financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

***Common/Collective Trust Fund***

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets.

**Note 5 - Tax Status**

The Plan is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Partial Plan Termination**

During 2023 and 2024, the Company had reductions in workforce. The Company is currently working with legal counsel to determine if a partial termination of the Plan has occurred. If a partial termination has occurred, the terminated employees would become fully vested in their account balances. Participants are fully vested in their account balances at all times, and, thus, a partial plan termination would have no impact on participant vesting.

### Note 1 - Plan Description

The following description of Flex Pack Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by ACW Flex Pack, LLC covering all employees, other than those covered by a collective bargaining agreement, leased employees, or nonresident aliens, of Phoenix Converting, Inc.; Valley Packaging Supply Co., Inc.; PCG/SPT Holdings, Inc. dba Precision Color Graphics; Bag Pack Holdings, Inc.; and ACW Flex Pack Management, Inc. (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to regular deferral contributions. The Plan also allows participants to make Roth contributions. Participants may make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain employee deferrals and participant loan payments in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and remitted related lost earnings to the Plan in 2024.

The Company makes safe harbor matching contributions equal to 100 percent of participant deferrals up to 3 percent of each participating employee's elective deferral, plus 50 percent of the next 2 percent of the participant's deferrals.

The Company may also make discretionary matching contributions based on a percentage of contributions made during the plan year. There were no discretionary matching contributions in 2024.

The Company may also make annual discretionary profit-sharing contributions to eligible participants employed at the end of a plan year. There were no discretionary profit-sharing contributions in 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balances. Generally, loan terms are a maximum of five years, but residential loans may be longer. Principal and interest are paid ratably through regular payroll deductions. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' and employer contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum or installment payments equal to the vested balance of a participant's account. Participants are also eligible for in-service benefit payments upon reaching the normal retirement age of 59½.

Participants may request that all or a portion of their vested account balances related to pretax deferrals or rollover contributions be distributed in the case of financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

### Note 1 - Plan Description

The following description of Flex Pack Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by ACW Flex Pack, LLC covering all employees, other than those covered by a collective bargaining agreement, leased employees, or nonresident aliens, of Phoenix Converting, Inc.; Valley Packaging Supply Co., Inc.; PCG/SPT Holdings, Inc. dba Precision Color Graphics; Bag Pack Holdings, Inc.; and ACW Flex Pack Management, Inc. (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 may make catch-up contributions in addition to regular deferral contributions. The Plan also allows participants to make Roth contributions. Participants may make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Certain employee deferrals and participant loan payments in 2023 were paid after the time frame required by the Department of Labor. The Company remitted these contributions during 2023 and remitted related lost earnings to the Plan in 2024.

The Company makes safe harbor matching contributions equal to 100 percent of participant deferrals up to 3 percent of each participating employee's elective deferral, plus 50 percent of the next 2 percent of the participant's deferrals.

The Company may also make discretionary matching contributions based on a percentage of contributions made during the plan year. There were no discretionary matching contributions in 2024.

The Company may also make annual discretionary profit-sharing contributions to eligible participants employed at the end of a plan year. There were no discretionary profit-sharing contributions in 2024.

#### **Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balances. Generally, loan terms are a maximum of five years, but residential loans may be longer. Principal and interest are paid ratably through regular payroll deductions. Notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants' and employer contributions and related earnings are fully vested at all times and are not subject to forfeiture for any reason.

### Note 1 - Plan Description (Continued)

#### ***Benefit Payments***

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum or installment payments equal to the vested balance of a participant's account. Participants are also eligible for in-service benefit payments upon reaching the normal retirement age of 59½.

Participants may request that all or a portion of their vested account balances related to pretax deferrals or rollover contributions be distributed in the case of financial hardship, as defined in the plan document.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value except as noted below. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Various administrative costs are paid by the Company.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 25, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

***Mutual Funds***

Mutual funds are valued at quoted prices reported in active markets.

**Note 4 - Fair Value Measurements (Continued)**

***Common/Collective Trust Fund***

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets.

**Note 5 - Tax Status**

The Plan is a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

**Note 6 - Partial Plan Termination**

During 2023 and 2024, the Company had reductions in workforce. The Company is currently working with legal counsel to determine if a partial termination of the Plan has occurred. If a partial termination has occurred, the terminated employees would become fully vested in their account balances. Participants are fully vested in their account balances at all times, and, thus, a partial plan termination would have no impact on participant vesting.
