NOTE A - DESCRIPTION OF PLAN

The following description of the Precisely Software Incorporated 401(k) Plan (the "Plan") provides only general information about the Plan. Participants should refer to the Plan agreement for complete information.

General

The Plan is a defined contribution plan covering all eligible employees of Precisely Software Incorporated (the "Company") who are age 21 or older for the purposes of elective deferrals and Company contributions. The Precisely Retirement Plan Committee controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute pre-tax and after-tax contributions up to 100% of eligible compensation, as defined in the Plan document, subject to certain Internal Revenue Code ("IRC") limitations. That Plan also allows for Roth contributions. Participants may contribute amounts representing distributions from other qualified plans or individual retirement accounts ("rollovers"). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Unless a participant affirmatively elects otherwise, certain eligible employees will be automatically enrolled in the Plan at 3% of their eligible compensation.

The Plan provides for discretionary matching Company contributions, qualified nonelective Company contributions and discretionary nonelective Company contributions. Employees are eligible for discretionary matching Company contributions immediately after enrolling in the Plan. Participants must be employed on the last day of the Plan year to be eligible to receive discretionary nonelective Company contributions. Qualified nonelective Company contributions are made to eligible, non-highly compensated participants as determined by the Company. The discretionary matching Company contribution is equal to a uniform percentage or dollar amount of each participant's elective deferral each Plan year as approved by the board of directors. For the years ended December 31, 2024 and 2023, the Company made discretionary matching Company contributions equal to 50% of the employee's contribution up to 6%. For the years ended December 31, 2024 and 2023, the Company did not make discretionary nonelective Company contributions or qualified nonelective Company contributions.

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and Plan earnings and is charged with withdrawals, an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus earnings thereon. Vesting in Company contributions, plus earnings, is based on years of service according to the following schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% or \$50,000 of their vested account balance, reduced by the amount of any loans during the prior 12 months. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through monthly payroll deductions and the balance of the loan must be repaid within five years unless the loan is used to purchase a principal residence, where the repayment schedule is the discretion of the Plan Administrator and may be for a term in excess of five years.

Payment of Benefits

Upon termination of service with the Company (including termination of service due to death, disability, or retirement), participants may receive a lump-sum amount equal to the value of the vested interest in their accounts or annual installments commencing on April 1 following the later of (a) the calendar year when the participant reaches age 73 or (b) the calendar year the participant retires, and thereafter through the calendar year of the participant's date of death.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships. Following a hardship withdrawal, participants are not allowed to contribute to the Plan for a period of six months.

Forfeited Accounts

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account as defined in the Plan represents a forfeiture. However, if a participant is reinstated and fulfills certain requirements as defined by the Plan, the forfeited amount will be reinstated. Non-vested forfeitures are reallocated to the participants in the Plan. Forfeitures may be used to pay Plan expenses, used to reduce any qualified nonelective Company contributions or used to reduce any discretionary matching contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$116,418 and \$176,214, respectively. For the years ended December 31, 2024 and 2023, forfeited non-vested balances totaling \$135,156 and \$200,155, respectively, were used to reduce employer contributions. Additionally, \$62,990 and \$16,378, respectively, were used to offset administrative expenses.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan or the Company as provided in the Plan document. All investment management and transaction fees directly related to the Plan investments are paid by the Plan. All audit, legal and other administrative fees not mentioned above are paid by the Company and are excluded from these financial statements.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for a description of valuation methods.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant loan is deemed to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE C - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;

- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds - This class primarily consists of publicly traded funds of registered investment companies. The mutual funds invest primarily in international marketable equity securities and in fixed income securities within the domestic market. The fair value of mutual fund investments is determined by reference to the fair value of the underlying securities of the mutual funds. The NAV of the mutual fund's shares is the closing price as quoted on the exchange where the fund is traded.

Self-directed brokerage account - This investment option primarily consists of mutual funds, common stocks, interest-bearing cash and warrants which are considered Level 1 investments, and corporate and government bonds which are considered Level 2 investments. The fair value of the self-directed brokerage account is determined by reference to the fair value of the underlying securities within the self-directed brokerage account. The underlying Level 1 investments held in the self-directed brokerage account are valued at the closing price as quoted on the exchange where the underlying securities are traded. The underlying Level 2 investments held in the self-directed brokerage account are valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing the value on yields currently available on comparable section of issuers with similar credit rating.

Collective trust funds - Collective trust funds are valued at NAV per unit, as determined by the investment managers at the end of the year. The NAV is used as the practical expedient to estimate the fair value. There are no unfunded commitments as of December 31, 2024 and 2023. Unitholders transactions (Plan participants) are processed daily. Withdrawals from the collective trust funds for benefit payments and participant transfers to noncompeting options to be paid to Plan participants within 30 days after written notification has been received.

NOTE D - PARTY-IN-INTEREST TRANSACTIONS

Certain assets held by the Plan are shares of mutual funds managed by an affiliate of Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan. Therefore, transactions within these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Notes receivable from participants also qualify as party-in-interest transactions.

NOTE E - PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

NOTE F - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. These funds are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE G - TAX STATUS

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service ("IRS"). The volume submitter plan has received a favorable notification letter from the IRS dated June 30, 2020. The Plan has been amended since the date of this letter; however, the Plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe the Plan was qualified and the related trust was tax-exempt as of the financials statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position than more likely than not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE H - CERTIFIED INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate:

- Investments at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
