NOTE A - DESCRIPTION OF PLAN

The following description of the Genesis Technical Staffing, Inc. ("Company") 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, effective February 1, 2014, is a single employer defined contribution plan covering substantially all employees including leased employees of Genesis Technical Staffing, Inc. and Genesis Industrial Staffing, Inc. (a controlled group) who are age twenty-one or older and not covered by a collective bargaining agreement, a nonresident alien or short term employees who are on contract for less than 90 days. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to 100% of their pre-tax annual compensation, as defined in the Plan, up to the maximum allowed by law. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may modify the rate of their pretax contributions quarterly. Participants may also contribute amounts representing distributions from other qualified plans or individual retirement accounts. The Plan does not allow employer contributions.

Participant Accounts

The participant's account is credited with the participant's contributions and plan earnings (losses) which are netted with an allocation of administrative fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant has investment authority over all funds in their account and are able to diversify their account among different funds with varying levels of risk.

Vesting

Participants are immediately vested in their employee deferral account plus actual earnings thereon. The plan does not allow for employer matching.

Payment of Benefits

On termination of employment due to death, disability, retirement, or termination of employment for any other reason, a participant will receive an amount equal to the value of their vested interest in his or her account in one lump sum payment. Hardship and in-service distributions are permitted if certain conditions of the Plan are met. Distributions from rollover contributions are permitted at any time.

Forfeited Accounts

Forfeitures are not applicable as all participants are fully vested.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for a discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

The trustee did not provide a breakdown of investment income between appreciation in fair value and interest and dividends, as is required by accounting principles generally accepted in the United States of America (GAAP). The effect of this departure from GAAP is not considered to be material.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Certain expenses of the Plan are paid directly by the Company and excluded from these financial statements. Trustee and record keeping fees are paid by the Plan participants and are included in the net appreciation (depreciation) of the fair value of the investments.

Subsequent Events

The Company has evaluated events and transactions that occurred between December 31, 2024 and September 23, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

NOTE C - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE D - TAX STATUS

The Internal Revenue Service has provided the Company with a favorable determination letter dated June 30, 2020, that states the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE E - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE (UNAUDITED)

All investment information disclosed in the accompanying financial statements and supplemental schedule was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Trustee, John Hancock Life Insurance Company (U.S.A.). The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that was prepared by and certified to be complete and accurate by the trustee:

All of the assets of the Plan are participant directed within the John Hancock Life Insurance Company (U.S.A.) selection of accounts.

NOTE F - PARTY IN INTEREST TRANSACTIONS

John Hancock Life Insurance Company (U.S.A.) is the trustee as defined by the Plan and EGPS, Inc. is the third party administrator. Transactions with these entities qualify as party-in-interest transactions. No trustee fees were paid directly to John Hancock Life Insurance Company (U.S.A.) by the Plan. Trustee fees are paid by the Plan participants through a revenue sharing arrangement and are included in the net appreciation (depreciation) of the fair value of the investments. Administrative expenses paid to the third party administrator and related fees paid by the Plan amounted to \$7,735 for 2024 and \$10,206 for 2023.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G - FAIR VALUE MEASUREMENT

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level one inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level two inputs consist of observable inputs other than quoted prices for identical assets, and Level three inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. All Plan assets are valued using Level one inputs.

NOTE G - FAIR VALUE MEASUREMENT (CONTINUED)

Pooled Separate Accounts

All of the pooled separate accounts (PSAs) are included in the John Hancock Life Insurance Company (U.S.A.) contract assets. The PSAs are reported at the net asset value per share (NAV) based on the fair value of its underlying investments. The NAV for the PSAs are not publicly quoted but are available to current investors when accessing their accounts. The NAV is the basis for current transactions and the PSAs can be redeemed at NAV as of the measurement date, providing a readily determinable fair value.

The following tables present the Plan's fair value hierarchy for the assets measured at fair value on a recurring basis at December 31, 2024 and 2023.

NOTE H - RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

At December 31, 2024 balances in the JH Lifetime Blend 2025, JH Lifetime Blend 2030 and JH Lifetime Blend 2035, and at December 31, 2023 balances in the JH Lifetime Blend 2025 and JH Lifetime Blend 2030, each account for greater than 10% of the Plan's total invested assets.
