NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the 401(k) Profit-Sharing Plan for Employees of Stone Belt Arc, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees who are at least 21 years of age and have completed six months of service with Stone Belt Arc, Inc. (the Plan Sponsor). Plan entry dates are the first day of each quarter (January 1, April 1, July 1, and October 1). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute amounts up to 100% of eligible compensation, as defined by the plan document. Participants may also contribute rollover amounts from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan Sponsor contributes 100% of the first 2% of base compensation that a participant contributes to the Plan. The Plan Sponsor may make discretionary matching contributions. For 2024 and 2023, the Plan Sponsor did not elect to contribute discretionary contributions. Contributions are subject to certain limitations.

Participant Accounts

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contribution, allocations of Plan Sponsor's contribution and Plan earnings (net of certain fund management expenses). Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment account options available include various funds. Each participant has the option of directing contributions into any of the separate investment accounts and may change allocations daily.

Compensation

Participant compensation is defined by the Plan as wages, tips and other compensation reported on the Federal Form W-2, Wage and Tax Statement and excludes reimbursements, expense allowances, fringe and welfare benefits, moving expenses, and certain deferred compensation.

Retirement Benefits and Vesting

Participants are vested immediately in their elective deferrals, rollovers, and actual earnings thereon. The Plan provides that the participant is fully vested in the employer-matching contributions at the end of three years or earlier when you reach normal retirement age or termination of the Plan or if you are totally and permanently disabled or die. Upon termination of employment, the nonvested portion of the participant's account is called a forfeiture and remains in the Plan and will be reallocated to active participants pro rata based on the participant's compensation. Forfeitures available were approximately \$7,000 and \$6,000 as of December 31, 2024 and 2023, respectively. There were no forfeitures reallocated during 2024.

Notes Receivable from Participants

Pursuant to Plan provisions, participants are not permitted to borrow from their fund accounts.

Payment of Benefits

In general, on termination of service a participant may elect to receive their vested interest in the form of a lump-sum amount, an account rollover or leave the account in the Plan, subject to certain limitations and conditions as defined by the Plan. In-service distributions may be made from the Plan for certain participants based on the plan document.

Plan Termination

Although the Plan Sponsor has not expressed intent to discontinue the Plan, it may do so at any time, upon resolution by the Plan Sponsor's Board of Directors. The Plan provides that in the event of termination of the Plan, all amounts credited to the participant accounts will be fully vested and will be paid as directed in the plan document and regulations.

2. SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are maintained in pooled separate accounts and represent the number of participation units owned by the Plan. The Plan values its investments at fair value for financial reporting purposes. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in fair value of investments are reflected in the statement of changes in net assets available for benefits in the year in which such changes occur. Changes in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Funds Held in Insurance Company General Account

Funds held in insurance company general account include the Interest Accumulation Fund which represents a deposit administration contract entered into by the Plan with Mutual of America Life Insurance Company (Mutual of America), the custodian of the Plan. Mutual of America maintains the contributions in an unallocated fund, whose assets are invested with other assets in the general account of Mutual of America. The account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Mutual of America.

The deposit administration contract is included in the financial statements at contract value of approximately \$490,000 and \$488,000 as of December 31, 2024 and 2023, respectively. The deposit administration contract paid a rate of approximately 2.85% during 2024.

Payment of Benefits

The Plan records benefit payments to participants when paid.

Administrative Expenses

The Plan Sponsor provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan Sponsor and generally include audit and legal fees. The expenses paid by the Plan Sponsor are excluded from these financial statements. Administrative expenses incurred by the Plan generally include certain administrative fees charged directly to the participants' accounts. Administrative expenses were approximately \$6,000 for 2024.

Subsequent Events

The Plan evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which was September 12, 2025.

3. INFORMATION CERTIFIED BY THE PLAN CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Mutual of America, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets as of December 31, 2024, and investment related activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). However, in accordance with Subtopic 820-10, the pooled separate account investments that measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

The Plan holds investments which are exposed to various risks such as interest rate, market, and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term that could materially affect the amounts reported in the accompanying financial statements.

5. INCOME TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by Mutual of America, which has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by various federal and state taxing authorities. by various federal and state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Plan Sponsor, and certain others. The administrative expenses are paid to the Plan custodian. Additionally, the Plan held party-in-interest investments with the Mutual of America, the custodian. Blue & Co., LLC is the independent auditor for the Plan and receives payment for those services. The Plan Sponsor pays the expenses of the Plan, including administrative and accounting fees. These expenses qualify as party-in-interest transactions.
