Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Kenney Manufacturing Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Note 1 - Description of Plan

The following description of the Kenney Manufacturing Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on January 1, 1985 by the Board of Directors of Kenney Manufacturing Company (the "Employer"). The Employer is the Plan's administrator. All eligible employees (as defined in the Plan agreement) who have completed 390 hours of service during the first 13 weeks of employment or completion of a year of service ("Participants") are automatically enrolled in the Plan on the first day of the next quarter with an automatic deferral of 2% unless an alternative election is made. Participants will have their deferral rate automatically increased by 1% each Plan year until their contribution rate reaches 10%. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants direct the investment of all contributions into various investment options offered by the Plan. Substantially all investments are participant directed.

Participant Contributions

Participants may defer up to 100% of their eligible annual compensation, including bonuses, as defined by the Plan, subject to dollar limits set by Federal law. Participants who have reached the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("Participant Rollovers").

Employer Contributions

Discretionary Non-Elective Contributions

The Employer may elect to make discretionary non-elective contributions to the Plan as determined by its Board of Directors. Allocation of any Employer non-elective contribution is based on each participant's compensation in proportion to the compensation of all Participants. To date, there have been no discretionary non-elective contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of the Employer's contribution and Plan investment earnings/losses, and reduced by direct loan fees, when applicable. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes to Financial Statements

Note 1 - Description of Plan (Continued)

Vesting

Participants are immediately vested in all contributions, including Employer contributions, and the earnings thereon.

Payment of Benefits

In-service withdrawals from all participant account balances are permitted upon reaching age 59½. Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or installments as defined by the Plan. For termination of service due to other reasons, a participant may receive the value of the interest in his or her account as a lump-sum distribution. Upon termination, if a participant's account balance exceeds \$1,000 but does not exceed \$5,000, and the participant does not elect to take a distribution, the Plan administrator may make a lump-sum distribution to a direct rollover individual retirement account. If a participant's balance is less than \$1,000, and the participant does not elect to receive the distribution, the Plan administrator may distribute the account directly to the participant. Hardship withdrawals are permitted from a participant's total vested account, and are subject to a \$500 minimum amount.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may only have one loan outstanding at a time. Loan terms range from one to five years. The loans are secured by the balance in the Participants' account and bear interest at a reasonable rate of interest to be determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Forfeitures

Forfeited amounts from excess Employer contributions may be used to pay Plan administrative expenses or to reduce Employer matching contributions. At December 31, 2024 and 2023, unallocated forfeited accounts amounted to \$18,270 and \$5,689, respectively. During 2024, \$25,820 of forfeitures were used to pay Plan expenses.

Administrative Expenses

Individual participant accounts are charged directly for loan recordkeeping and benefit disbursement processing fees, if applicable. Certain administrative expenses of the Plan are the responsibility of the Employer and are excluded from these financial statements. Trustee, recordkeeping and custodian expenses are paid for by the Plan.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Unit Values

Individual participant accounts for the pooled separate investment accounts and variable rate annuities (through 2023) are maintained on a unit value basis. Participants do not have beneficial ownership in specific underlying securities or other assets in the investments, but do have an interest therein represented by units which are valued daily. The investments earn dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from each investment are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants' accounts are charged or credited with the number of units properly attributable to each participant.

Contributions

Contributions from Plan participants and the discretionary nonelective contributions from the Employer (when made) are recorded in the year in which the contributions are withheld from compensation.

Benefits Paid

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could vary from the estimates that were used.

Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Trustee and Custodians

Plan investments are held by the Plan's trustee and custodians, Empower Annuity Insurance Company of America, Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC ("Empower"). The fair value and contract values of investments as of December 31, 2024 and 2023 and all investment transactions for the year ended December 31, 2024, including interest and dividend income and net appreciation, are reported to the Plan and certified as complete and accurate by Empower. Information included in the supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year), and notes receivable from participants, have also been derived from information certified by Empower. The Plan offers several investment choices to allow Participants to create a diversified portfolio of assets based on the Participants' risk tolerance.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of observable inputs to minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

- Level 1* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2* Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Note 4 - Fair Value Measurements (Continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Investment Accounts

Units of participation in pooled separate investment accounts are reported at the daily Net Asset Value ("NAV") of units owned. The NAV, as provided by Empower, is used as a practical expedient to estimate fair value. Participant transactions may occur daily. NAV of units is based upon the quoted market values of the underlying assets in the separate accounts less its liabilities. Individual participant accounts for the pooled separate investment accounts are maintained on a unit value basis. These units are not traded on securities exchanges but are redeemable only by the issuer. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units. There are no unfunded commitments.

Variable Rate Annuities (Through 2023)

Variable rate annuities are reported at the daily NAV of units owned. NAV of units is based upon the quoted market values of the underlying assets less its liabilities. Individual participant accounts for the variable rate annuities are maintained on a unit value basis. These units are not traded on securities exchanges but are redeemable only by the issuer. Participants do not have beneficial ownership in the specific underlying securities or other assets in the funds but do have an interest therein represented by units.

Note 5 - Fully Benefit-Responsive Investment Contracts

The following is a description of the investment and valuation methodology for the fully benefit-responsive investment contract:

Guaranteed Investment Account

The MassMutual Retirement Services Guaranteed Account is a guaranteed group annuity contract backed by the general account of Great West Life & Annuity Insurance Company (acquired the retirement business of MassMutual effective December 31, 2020) and is maintained in a separate deposit fund with a term of five years. The fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the Plan's financial statements at contract value at December 31, 2024 and 2023, as reported to the Plan by MassMutual. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value represents contributions made under the contract, plus earnings, less benefits paid and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract at December 31, 2024 and 2023 was \$5,036,075 and \$8,331,081, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Guaranteed Investment Account (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendment to the Plan document (including complete or partial termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events, which would limit the Plan's ability to transact at contract value with the contract issuer, are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risk include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, Participants will become fully vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 8 - Tax Status

The Internal Revenue Service has determined that the prototype 401(k) profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC") and informed the custodian of such in a letter dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Related-Party and Exempt Party-in-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the recordkeeper and custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan received revenue credit income of \$37,940, which are netted with administrative expenses on the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2024, administrative fees incurred to Empower and other parties-in-interest that were not covered by revenue sharing amounted to \$11,051. Notes receivable from Participants are also considered to be exempt party-in-interest transactions as defined by ERISA.

CURRENT VALUE: The value of all assets in each investment option as of the last day of the plan year
