Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Seattle University Employees Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions and an agent on behalf of a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplementary information, as listed in the accompanying table of contents, is presented for purposes of additional analysis and is not a required part of the financial statements but is required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplementary information, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplementary information that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note 1 - Description of the Plan

The following description of the Seattle University Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan created for the benefit of eligible employees of Seattle University (the University) and is designed to comply with Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Fidelity Management Trust Company (Fidelity) is a custodian for certain assets of the Plan. TIAA and CREF are issuers of the Plan's annuity contracts. TIAA Trust, N.A. was a directed custodian of certain Plan assets. Fidelity Workplace Services LLC and TIAA perform recordkeeping services for the Plan.

Eligibility and Vesting - All Employees are eligible to make elective deferrals on or after their date of hire unless they are enrolled as students and regularly attending classes offered by the University. Employees of the University other than student workers, participants in plans sponsored by a religious order, and leased employees are eligible to receive employer contributions after one year of service in which the participant is credited with 1,000 or more hours of service (or equivalent as defined by the plan document). Also, employees who have completed two continuous years of full-time employment at accredited institutions of higher education prior to beginning employment at the University, and who are at least 21 years of age, are eligible to receive employer contributions on the first day of the first full month following employment with the University. Employer and employee contributions are 100% vested at all times.

Contributions - Participants may elect to defer up to 100% of their eligible compensation as pretax or Roth contributions. Participants who have attained age 50 before the end of the plan year or participants having at least 15 years of service are eligible to make catch-up contributions. Furthermore, participants may also contribute amounts representing distributions from other eligible plans (rollovers). The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 5% deferral rate unless they elect a different deferral rate or not to participate in the Plan.

The University may make discretionary matching and nonelective contributions to participants who are credited with at least 1,000 hours of service during the calendar year. For the years ended December 31, 2024 and 2023, the University elected to match 100% of the first 5% of eligible compensation that participants contribute to the Plan for participants hired after June 30, 2022. For the years ended December 31, 2024 and 2023, the University made nonelective contributions equal to 10% or 5% of participants' eligible compensation depending on whether eligible participants were employed by the University as of June 30, 2022.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, as well as allocations of the University's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined. A participant is entitled to the benefit that can be provided from the participant's vested account.

Participants were able to direct their contributions to any of the investments held by the Plan's asset custodians before June 1, 2012. After this date, participants can only direct their new contributions to the investments held by Fidelity. Participants are still able to maintain investments held by TIAA and CREF and are allowed to transfer balances between these investments.

Note 1 - Continued

Notes Receivable From Participants - Participants with investments held by Fidelity may borrow from their account a minimum of \$1,000 up to a maximum of 50% of their vested account balance or \$50,000, whichever is less. Interest is charged at a rate equal to the prime rate plus 1%. Loan terms range from one to five years, or up to 15 years for the purchase of a primary residence. Principal and interest payments on the outstanding balance are made by direct payments from participants to Fidelity. The maximum number of loans that may be outstanding per participant is three, which includes a maximum of two general and/or post-secondary education loans and a maximum of one primary residence home loan.

Plan Loans - Participants with investments held by TIAA, CREF, and TIAA Trust, N.A. may borrow from funds owned by TIAA and CREF (not directly from a participant's account). Accordingly, plan loans are not reported on the statements of net assets available for benefits and related interest income is not reported on the statements of changes in net assets available for benefits. A portion of the participant's account is held as collateral to cover 110% of the outstanding loan in case of default. The interest rate for plan loans will be variable based on the monthly average corporate yield published by Moody's Investor Service, Inc.

Payment of Benefits - Upon termination of service, retirement, death, a participant or their beneficiary is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in their account, or at the participant's election, in annual installments, except that if the participant has a balance in a Retirement Annuity contract with TIAA, the distribution of that balance can be only made in ten annual installments (a lump-sum withdrawal is not allowed). Distributions can also be made to participants during their employment with the University if they meet certain requirements as defined within the Plan document.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced and a benefit payment is recorded.

Contributions - Contributions from the University are recorded in the period in which the related employee compensation is paid. Contributions from participants are recorded in the period in which they are withheld from participants' pay.

Payment of Benefits - Benefits paid to participants are recorded when paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statements of changes in net assets available for benefits.

Investment Management and Administrative Expenses - Several of the investment fund options are subject to investment and administrative fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements. Transaction based fees for loans and distributions are charged directly to participant accounts. Fidelity recordkeeping fees are paid via quarterly deductions from participant accounts. Quarterly deductions are made in the month after the end of a quarter. The University may elect to pay other expenses related to the Plan's administration.

Subsequent Events - In June 2025 Cornish College of the Arts (Cornish) closed their college, and certain former Cornish employees became employees of the University and participants in the Plan during 2025. The Cornish 403(b) Plan will be terminated and will not be merged into the Plan.

The Plan's management has evaluated subsequent events through September 25, 2025, the date on which the Plan's financial statements were available to be issued.

Note 3 - Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

Note 3 - Continued

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices available in active markets for identical assets or liabilities;

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - Unobservable inputs that are significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuity Accounts - CREF is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. The fair values of accumulation units held in CREF accounts are based on each account's daily published NAV. NAV is based on the market value of its underlying securities determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units in CREF accounts are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

Pooled Separate Account - The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units held in the REA is published daily and based on market values of the underlying real estate properties determined by external appraisals, which are estimates of property values based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units in the REA are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

Fixed Annuity Contracts - The TIAA Traditional Annuity are fixed annuity contracts (guaranteed investment contracts) that are fully and unconditionally guaranteed by TIAA. The TIAA Traditional Annuity that is not considered fully benefit-responsive is offered through the Group Retirement Annuity (GRA) and Retirement Annuity (RA) contract types. Under GRA and RA contracts, participant initiated withdrawals or transfers may be subject to certain liquidity restrictions and/or fees. GRA and RA contracts are reported at contract value which is the aggregation of contributions, plus interest, less any withdrawals. Contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with historical crediting rates for these contracts. Fair value is determined annually for financial statement reporting purposes. When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

Note 4 - Fully Benefit-Responsive Investment Contracts

In addition to the nonbenefit-responsive TIAA Traditional Annuity described in Note 3, the Plan also holds benefit-responsive TIAA Traditional Annuities through the Group Supplemental Retirement Annuity (GSRA) and the Supplemental Retirement Annuity (SRA) contract types. GSRA and SRA contracts provide for full participant-directed liquidity and are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value is the aggregation of contributions, plus interest, less any withdrawals.

Each contract is fully and unconditionally guaranteed by TIAA. As an insurance company, TIAA is required to maintain contingency reserves to ensure that it will be able to fulfill its contractual obligations to policyholders. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with TIAA and that also would limit the ability of the Plan to transact at contract value with participants.

Notes to Financial Statements For the Years Ended December 31, 2024 and 2023

Note 5 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, TIAA, and CREF, qualified institutions. For the plan years ended December 31, 2024 and 2023, TIAA has been authorized by TIAA Trust, N.A. to certify investments for which TIAA Trust, N.A. is the directed custodian. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 6 - Tax Status

The University has adopted a Fidelity pre-approved 403(b) plan document. Fidelity received an approval letter from the IRS dated August 7, 2017, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the University has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Party-in-Interest Transactions

Plan investments include fixed and variable annuity contracts issued by TIAA and CREF. TIAA is the recordkeeper for these investments. Therefore, transactions with these investments and fees paid by the Plan to TIAA qualify as party-in-interest transactions. The Plan pays certain recordkeeping expenses to Fidelity and also issues loans to participants. These transactions are party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan provides for various investment options, which in turn invest in a combination of investment securities such as stocks, bonds, and others. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10 - Concentrations

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the fixed annuity contracts issued by TIAA and CREF. These investments represent approximately 10% and 11% of total Plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high-credit quality institutions.
