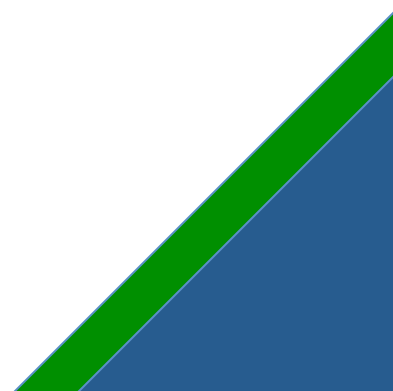

## INDEPENDENT AUDITORS' REPORT

Board of Trustees and Participants  
Post Glover Resistors, Inc. 401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Post Glover Resistors, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Post Glover Resistors, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and December 31, 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

#### NOTE 1 - DESCRIPTION OF PLAN

The following brief description of the Post Glover Resistors, Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Participants should refer to the Plan document for more complete information.

##### **General**

The Plan, established April 1, 2006, and was restated on January 1, 2021, is a defined contribution plan. All employees of Post Glover Resistors, Inc., Post Glover Lifelink, Inc., Mosebach Manufacturing Company and Rent-A-Load USA, LLC (together the "Company") who have reached age 18 and have at least six months of service are eligible to participate in the Plan. Normal retirement age is 65 years. In the event of a participant's death, any remaining balance will be paid to designated beneficiaries.

##### **Contributions**

A participant may authorize contributions up to the annual maximum amount permitted by the Internal Revenue Code ("IRC") through payroll deductions. The Company will make a safe harbor matching contribution equal to 100% of the participant's contribution up to 5% of their eligible compensation. The Company can also make a discretionary profit sharing contribution for each participant who is employed on the last day of the Plan year. Participants may allocate contributions made to their account in any of the investment options offered by the Plan.

##### **Participant Accounts**

Each participants' account is credited with the participants' contribution, and an allocation of the Company's contributions and investment income or loss. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Vesting**

Participants are 100% vested in Company safe harbor matching contributions immediately and are 100% vested in Company profit sharing contributions on the first day of the quarter following the participant's completion of three (3) years of service. Participants are 100% vested in their own contributions at all times.

##### **Participants Loans**

Participants may borrow from their fund account up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator at the time of the loan. Principal and interest is paid ratably through payroll deductions.

##### **Administrative Expenses**

The expenses of administering the Plan and the related Plan assets may be paid by either the Company or from the assets of the Plan. The Company provides the Plan with certain accounting and administrative services for which no fee is charged.

##### **Forfeitures**

Forfeitures may be used to offset Company contributions or pay administrative expenses, at the Company's discretion. Forfeited amounts of \$11,124 at December 31, 2024 and \$571 at December 31, 2023 were available to reduce employer contributions or pay administrative expenses. The 2024 employer contributions were reduced by \$0 from forfeited nonvested accounts.

### NOTE 1 - DESCRIPTION OF PLAN (Continued)

#### Payments of Benefits

On termination of service due to death, disability or retirement, a participant will receive a distribution equal to the value of the participant's vested interest in their account in a lump-sum. If the terminated participant's vested balance is less than \$5,000, then the account balance can be automatically distributed without consent from the participant.

#### Plan Operations

The Plan was amended for auto enrollment effective January 1, 2023. Participants who become eligible on or after January 1, 2023 will be automatically enrolled in the plan at 5% with an annual automatic increase of 1%, up to a maximum deferral of 10%.

### NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP") and conform to the accounting requirements of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contract, plus earnings, less withdrawals and fees.

#### Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The investments are not covered by federal insurance.

#### Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

#### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time. If the Plan is terminated, participants will become fully vested in the Company's contributions and the trustee may commence payments of benefits, pursuant to the terms of the Plan.

**NOTE 4 - INCOME TAX STATUS**

The Plan has adopted a non-standardized pre-approved profit sharing plan with CODA, which received an opinion letter dated June 30, 2020 from the Internal Revenue Service as to the Plan's qualified status. The non-standardize pre-approved profit sharing plan with CODA opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The plan administrator believes it is no longer subject to income tax examinations for the years prior to 2021. There are currently no audits for any tax periods in progress.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are in mutual fund, common collective trusts and investment contracts managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (together "Empower"). Empower is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management and administrative services amounted to \$95,354 for the year ended December 31, 2024.

**NOTE 6 - PLAN RISKS AND UNCERTANTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

**NOTE 7 - INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants at December 31, 2024 and December 31, 2023, net appreciation in fair value of investments, dividends and interest for the year ended December 31, 2024, was obtained or derived from information supplied by the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (the custodians of the Plan). The information certified includes total investments of \$25,846,362 and \$25,522,670 at December 31, 2024 and December 31, 2023, respectively, and related investment income (loss) of \$3,605,238 for the year ended December 31, 2024. The information certified also includes total notes receivable from participants of \$455,170 and \$385,983 at December 31, 2024 and December 31, 2023, respectively, and related interest on notes receivable from participants of \$29,832 for the year ended December 31, 2024.

**NOTE 8 - FAIR VALUE MEASUREMENT**

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts which are reported at contract value) in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. No Level 2 or 3 inputs were available to the Plan.

*Level 1 Fair Value Measurements*

*Mutual funds* – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 9 - INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In September 2016, the Plan entered into a traditional benefit-responsive contract with Great-West Life & Annuity Insurance Company, now known as Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value, which is an appropriate determination of fair value, of the investment contract at December 31, 2024 and 2023 was \$1,243,502 and \$1,776,437, respectively. The crediting interest rate is based on a formula agreed upon by the issuer, but may not be less than 0.00%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact a contract value with Empower Annuity Insurance Company of America. Such events include the following: amendments to the plan documents (including complete or partial plan termination or merger with another plan), changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that causes significant withdrawal from the Plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA.
