Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of MLB Network, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year), as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

December 31, 2024

1. Description of Plan

The following description of the MLB Network, LLC 401(k) Plan (the Plan) provides general information about the Plan's provisions. Participants should refer to the plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan available to all eligible employees of The MLB Network, LLC and its wholly owned subsidiaries (collectively referred to as the Company), the Plan's sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's inception date was December 1, 2008.

In accordance with the provisions of the Plan, employees become eligible to participate in the Plan if they are employees of the Company and are not covered by a collective bargaining agreement, and are not leased employees, nonresident aliens, interns, freelance employees who work less than 1,000 hours per year, or temporary employees who work less than 1,000 hours per year.

Fidelity Management Trust Company is the Plan's trustee and Fidelity Workplace Services, LLC is the recordkeeper.

Contributions

In accordance with the provisions of the Plan, participating employees may elect to make a regular contribution on a pretax basis of up to 50% of their eligible compensation per pay period, up to a maximum of \$23,000 during 2024, as defined by the Internal Revenue Code (the Code). Additionally, participants 50 years of age and older may elect to contribute catch-up contributions, which were limited to \$7,500 during 2024. Participants are also eligible to irrevocably designate some or all of their contributions as a Roth Deferral Contribution to the Plan. All contributions are subject to certain limitations of the Code.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

The Company will make matching contributions on behalf of all participants in the amount of 50% of the first 8% of eligible earnings that the participants contribute to the Plan. For purposes of determining contributions, compensation is defined as total wages and salary of an employee, excluding overtime pay, bonuses, commissions, severance pay, and compensation under the Company Salary Continuation Policy and Workers' Compensation Salary Continuation Policy.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Plan currently offers various mutual funds and a self-directed brokerage account as investment options for participants.

Participant Accounts

Each participant's individual account is credited with the participant's contributions, the Company's matching contributions, allocations of plan earnings and/or losses, and eligible rollover distributions from the participant's other qualified plans. Allocations are based on individual participant earnings or account balances, as defined in the Plan's provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting and Forfeitures

Participants are fully vested immediately in their own contributions and any rollover distributions from other qualified plans, plus actual earnings thereon. The participant's interest in employer matching contributions vests as follows:

* Years of service are determined by the elapsed time crediting method. Only whole years of service with the Company will be counted to compute years of service for vesting purposes.

1. Description of Plan (continued)

Participant account balances not yet vested at the time of the participant's termination of employment are forfeited by the participant and used by the Company to reduce future employer contributions or administrative expenses. Any remaining amounts will be used to reduce future employer contributions payable under the Plan. There were no forfeitures available at December 31, 2024 or 2023. The Company used \$55,159 of forfeitures in 2024 to reduce employer contributions paid to the Plan.

Participant Loans

Participants may borrow from their accounts in increments of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid in level payments on at least a monthly basis over a five-year period. The \$50,000 limit is reduced by the participant's highest outstanding loan balance during the preceding 12-month period. A participant may not have more than one loan outstanding at any point in time. The loans are secured by the balance in the participant's account and bear interest rates determined by the prime interest rate on the date of the issuance, in accordance with plan provisions. Prime is determined on the first business day of each calendar quarter when published in the Wall Street Journal. The interest rate on the participant loans outstanding as of December 31, 2024 ranged from 3.25% to 8.5%. If a participant terminates employment with the Company, he or she may continue to make loan payments through a pre-authorized check agreement. If the loan is not repaid within its stated period, it will be treated as a taxable distribution to the participant. These loans are classified as notes receivable from participants.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the current value of the vested portion of their account, equal annual installment payments, or more frequent equal installment payments if the balance is over \$1,000. The normal retirement age is 65. For termination of service for other reasons, a participant may receive the current value of the vested portion of their account as a lump-sum distribution, subject to the provisions of the Plan.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Withdrawals

In accordance with the Plan's provisions, participants may make withdrawals from their accounts. To qualify for a withdrawal, participants must attain age 59-1/2 or demonstrate financial hardship as defined under the Plan.

Funds available for a hardship withdrawal are limited to a participant's need and may not exceed the total of the participant's contributions, certain Company contributions, and earnings in the Plan, as defined. Eligibility for a hardship withdrawal is defined as the need for uninsured medical expenses; purchase of a participant's principal residence; payment of post-high school tuition; to prevent the loss of residence; payments for burial or funeral expenses for a parent, child, spouse, or dependent; or expenses for the repair of damage to the employee's principal residence under Internal Revenue Code Section 165.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments, which are charged to the individual participant accounts, are not shown on the face of the financial statements, but are reflected in "benefit payments" shown on the Statement of Changes in Net Assets Available for Benefits. All other administrative expenses of the Plan are paid by the Company.

Rollovers

The Plan allows rollovers by participants from their pre-existing 401(k) accounts that were established when employed by other companies. Rollover contributions are 100% vested at the time of contribution.

Plan Termination

The Company intends to continue the Plan indefinitely, but reserves the right to amend or terminate it at any time. In the event the Plan is terminated, each participant shall become fully vested in their account balances. Disbursements to participants shall be made in accordance with the plan document and applicable ERISA regulations.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance, plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are recorded when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document, and the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

2. Summary of Significant Accounting Policies (continued)

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory and certain optional provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

3. Investments

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, certain investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

4. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price).

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

4. Fair Value Measurements (continued)

- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - Quoted prices for similar assets and liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in markets that are not active
 - Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level of input that is significant to the fair value measurement in its entirety.

The following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual funds: Shares of registered investment companies are valued based on quoted market prices, which represent the net asset value (NAV) of shares held at year end.

Money market fund: Shares of registered investment companies are valued based on quoted market prices, which represent the NAV of shares held at year end. The market value per share of a money market fund is computed by adding the total market value of the fund’s investments, cash, and other assets, subtracting the fund’s total liabilities, and dividing the result by the total number of shares outstanding.

4. Fair Value Measurements (continued)

Self-directed brokerage account: Participants are able to actively manage the funds they are investing in. These investments include funds and equity that go beyond those offered in the Plan. The Plan's fiduciary neither evaluates nor monitors the investments available through the self-directed brokerage account. The self-directed brokerage account is composed of mutual funds, equity securities, and cash. The fair value of the mutual funds and equity securities are based on quoted market prices of the shares held by the Plan at year end. The Plan's investments in interest-bearing and noninterest-bearing cash are reported at carrying value, which approximates fair value.

The valuation methodology used to measure fair value as described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the Statements of Net Assets Available for Benefits.

6. Party-In-Interest Transactions

Certain Plan assets are invested in mutual funds and money market funds, which are managed by the Plan's trustee. These transactions, as well as participant loans, qualify as party-in-interest transactions; however, these transactions are exempt from the prohibited transaction rules under ERISA.

7. Tax Status

The underlying volume submitter plan has received an advisory letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code) and, therefore, the related trust is tax-exempt. The plan administrator has determined that it is eligible to, and has chosen to, rely on the current IRS volume submitter advisory letter. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 30, 2025, the date the accompanying financial statements were available to be issued.
