INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Avenues Recovery Center 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Avenues Recovery Center 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5-6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

Basis for Opinion

Responsibilities of Management for the Financial Statements

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of Avenues Recovery Center 401k Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Avenues Recovery Center 401k Plan (the “Plan”) was effective January 1, 2023, is a defined contribution plan established to encourage and assist employees in saving and investing payroll withholdings for purposes of receiving retirement benefits. Rehab Ventures, LLC (the “Company” or “Employer”) is the Plan sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). is the Economic Group Pension Services, INC (“EGPA”) is the Plan’s Administrator and John Hancock Life Insurance Company is the certified custodian and recordkeeper. Abraham Gartenhaus and Tzina Rosengarten are the trustees (the “Trustee”) for the Plan. The following participating companies under the Plan are as follows: ADD Addiction Claim Solutions, LLC; Avenues Recovery Admissions, LLC; Avenues Recovery Center Of Chesapeake Bay LLC; Avenues Recovery Center of Bucks, LLC; Avenues Recovery Center of Fort Wayne, LLC; Avenues Recovery Center of Lake Ariel, LLC; Avenues Recovery Extended Care, LLC; Browsers, LLC; DWI Services, Inc.; Kentuckiana Detox and Rehab Center, LLC; New Hampshire Detox and Rehab, LLC; Penn 123, LLC; Rehab Ventures, LLC; Sober Living Doylestown, LLC; Sober Living New Hampshire, LLC; Avenues Recovery Center of Louisiana LLC; Avenues Recovery Center at Covington, LLC

Participation

Substantially all employees over the age of 18 hired or rehired after January 1, 2023, are participants in the Plan that can make deferral contributions as of April 1, 2023. Employees hired after April 1, 2023, will need to complete 2 months of service and be over the age of 18 to be eligible and will be entered on the first day of the calendar month coincident with or next following the time eligibility criteria is met. The Plan is not open to employees covered by a collective bargaining agreement, any leased employees, and non-resident aliens participation in the Plan.

Contributions

Effective April 1, 2023, participants were enabled to start contributing to the Plan. The maximum amount \$23,000 is allowed by the Internal Revenue Service, plus Roth IRA contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor may elect to make a discretionary matching contribution. The discretionary matching and profit-sharing contributions are invested in the same investment options and allocation percentages as the participant-directed contributions. The total amount contributed to the Plan was in the amount \$428,198 and \$335,634 for the plan years ended December 31, 2024 and 2023, respectively.

Participant accounts

Each participant’s account is credited with the participant’s contributions and Sponsor matching contributions, as well as allocations of the Sponsor’s profit-sharing contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is based on the participant’s vested account.

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

Vesting

Participants are fully vested immediately in their contributions plus actual earnings thereon. Your interest in your Employer Matching Contribution Account will vest based on your Years of Vesting Service according to a 3-year cliff vesting schedule as follows:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than Three years	0%
Three or more years	100%

Investment options

Participants direct the investment of their account balance into various investment options offered by the Plan. The Plan currently offers a variety of registered mutual funds as investment options for participants. You may direct the investment of all of your Accounts in one or more of the available Investment Funds. Your elections will be subject to such rules and limitations as the Plan Administrator may prescribe. The Plan Administrator may restrict investment transfers to the extent required to comply with applicable law. The Plan is intended to constitute a plan described in section 404(c) of ERISA. This means that Plan fiduciaries may be relieved of liability for any of your losses that are the result of your investment elections.

Payment of benefits

Withdrawals from the Plan are generally permitted when an employee terminates employment, retires, reaches the age of 59 1/2, becomes permanently disabled, or has a severe financial hardship, as defined under the Plan. The Plan allows eligible participants to make an unlimited number of withdrawals, including certain in-service withdrawals, from their vested account balance, including from their self-directed brokerage account in the Plan.

This distribution can be taken in cash and is subject to appropriate tax withholding and possible penalty, or it can be rolled directly over to an Individual Retirement Account or another employer's qualified retirement plan. Participants may receive a distribution from their account based on employment termination, normal retirement age, hardship, disability, and death.

Disposition of forfeitures

If a participant's employment with the Employer is terminated and elected to receive a distribution of the entire vested portion of your Account, you will forfeit the nonvested portion of your Account. If the value of your vested Account balance is zero, you will be deemed to have received a distribution of your Account.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis in accordance with accounting policies generally accepted in the United States of America, except for benefit payments, which are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States (“GAAP”) requires the Company to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from these estimates.

Investments and Income Recognition

The investments of the Plan are stated at fair value as of the end of the year. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Notes 6-7 for information related to the Plan’s valuation methodologies. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.

For detailed information on each fund’s investments and concentrations of credit risk, the Prospectus and the Annual Report are available from John Hancock Life Insurance Company. Investments are reported at fair value.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan’s administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Payment of benefits:

Benefits are recorded when paid.

Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable and benefits paid to participants are charged directly to the participants’ accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan’s investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

Reclassifications were added to the prior year's financial statements for comparative purposes to conform with the presentation of the current financial statements.

NOTE 3 – TAX STATUS

The Internal Revenue Service issued a non-standardized pre-approved profit-sharing opinion letter to Principal Life Insurance Company dated June 30, 2020, stating that its prototype plan document was designed in accordance with applicable Internal Revenue Code requirements as of that date. Although the Sponsor has not applied for a determination letter for the Plan and although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the plan administrator believes that the Plan was qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their allocation of Sponsor contributions.

NOTE 5 – CERTIFICATION OF CONTRACT HELD BY JOHN HANCOCK

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Plan was certified by the custodian and trustee John Hancock Life Insurance Company for the period April 25, 2023, to December 31, 2024.

NOTE 6 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets:
- Quoted prices for identical or similar assets or liabilities in inactive markets:
- Inputs other than quoted prices that are observable for the asset or liability:
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 6 – FAIR VALUE MEASUREMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Pooled separate accounts: Valued at the NAV as determined by the quoted market prices of the underlying mutual funds or investments in which the pooled separate accounts invest.

NOTE 7 – INVESTMENT CONTRACT WITH JOHN HANCOCK

Notes to the Financial Statements

The Plan entered into a traditional guaranteed investment contract with John Hancock Life Insurance Company (“JH”). JH maintains the contributions in a sub-account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by JH, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

NOTE 8 – PARTY-IN-INTEREST TRANASCTIONS

As of December 31, 2024, certain Plan investments were interests in registered investment companies held by John Hancock Life Insurance Company as the Plan’s trustee and recordkeeper. The Trustee provides services to the Plan as the custodian; therefore, these investments and transactions qualify as party-in-interest transactions.

In addition, the Plan pays administrative fees to Economic Group Pension Services, INC (“EGPS”) and John Hancock Life Insurance Company in the amount of \$34,565.
