NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

NOTE 1 - PLAN DESCRIPTION

The following description of Southern Earth Sciences, Inc. (the Company) 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering non-excluded employees of the Company who are 21 years of age or older. The employee can become a participant as of the first day of the quarter following the date on which he or she met the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions. Participants may elect to defer a portion of their eligible compensation to a 401(k) savings option, subject to certain limitations and exceptions. Participants direct the investment of their contributions into various investment options offered by the Plan. For each Plan year the Company may make a discretionary matching contribution for each eligible participant employed by it. As of January 1, 2024, the Company modified its discretionary matching contribution formula under the defined contribution plan to provide a 100% match on the first 3% of eligible employee deferrals and a 50% match on the next 2% of deferrals. While this updated formula is applicable for the 2024 Plan year, the Plan does not qualify for Safe Harbor treatment for that year. During the year ended December 31, 2024, the Company amended the Plan to adopt Safe Harbor provisions effective for the 2025 plan year. Any eligible employee who is employed on the last day of the plan year and has completed 1,000 hours of service and is contributing to the Plan is eligible to participate in Company matching funds.

Participant Accounts. Each participant's account is credited with the participant's contributions, any Company contributions made to the Plan on the participant's behalf, a proportionate share of the Plan's net gains, losses, and administrative expenses, and is charged with the participant's withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions. Participants are vested in the employer contribution portion of their account balance on a graduated scale over a five-year period. Vesting occurs in equal increments in the first through fifth years of service at incremental rates of 20% per year.

Payment of Benefits. Payment of a participant's account balance is available upon death, disability or retirement. If employment terminates for reasons other than those listed above, the participant will be entitled to receive only the "vested percentage" of his account balance and the remainder of his account will be forfeited. Only employer discretionary contributions are subject to forfeiture.

NOTE 1 - PLAN DESCRIPTION (CONTINUED)

Participants are also able to make distribution elections at normal retirement age, fifty-nine and one-half (59 1/2), regardless of employment status. Funds may also be accessed prior to the date they become distributable by way of a financial hardship withdrawal. Hardship withdrawals are allowable in accordance with current Internal Revenue Service guidelines.

Notes Receivable from Participants. Participants may borrow a minimum of \$1,000 up to, the lesser of \$50,000 or 50% of, their vested account balance within guidelines established by the Plan's Trustees. Loans accrue interest at a commercially reasonable rate established by the Plan Administrator and are payable through payroll deductions over terms ranging up to 5 years. The repayment period may be extended to 10 years if the loan is issued for the purchase of a participant's primary residence.

Forfeited Accounts. As prescribed by the Plan, forfeited nonvested account balances are applied to administrative expenses with any remainder to be used to reduce future employer contributions payable under the Plan. The unused portion of forfeitures at December 31, 2024 and 2023 were \$18,162 and \$12,848, respectively. The amounts forfeited, including dividends earned on forfeited amounts, for the years ended December 31, 2024 and 2023 were \$6,639 and \$2,148, respectively. The amount used to offset plan expenses during the year December 31, 2024 was \$1,325.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, trustees, and insurance company. See Note 7 for discussion of fair value measurements.

Investment valuation and income recognition (continued)

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Investments allocated to deferred group annuity contracts are reported at contract value. The contract value represents contributions plus earnings, less participant withdrawals and administrative expenses. See Note 8 for discussion of deferred group annuity contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits payable

Net assets available for benefits include benefits due to participants who have withdrawn from participation in the Plan. Benefits are recorded when paid.

Administrative expenses

Certain expenses for maintaining the Plan are paid by the Plan Sponsor. Fees related to the administration of benefit payments are included in benefits paid to participants. Investment related expenses are included in the net appreciation in fair value of investments. Fees related to notes receivable from participants are recorded as administrative expenses and are expensed as incurred.

Subsequent events

Subsequent events have been evaluated through September 29, 2025, which is the date the financial statements were available to be issued.

NOTE 3 - PLAN ADMINISTRATION

The general administration of the Plan and the responsibility for carrying out its provisions are placed with the Plan Administrator.

Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the Trustees) were appointed by the Plan Administrator as the Plan Trustees and recordkeeper responsible for investing and reinvesting the Plan's assets. The Company is responsible for maintaining accurate books and records with respect to its employees for purposes of administering the Plan.

Global Retirement Partners, LLC serves as Investment Advisor (the Advisor) to the Plan. The Advisor is authorized to supervise and manage the Plan in accordance with the investment objectives of the Company. The Advisor's responsibilities also include advising individual participants regarding investment choices and objectives for their individual accounts.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 5 - TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase Plan with CODA which received an opinion letter from the Internal Revenue Service dated November 14, 2022, that stated that the Plan is acceptable under Code Section 401(a) and, therefore, the related trust is exempt from tax pursuant to Section 501(a) of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the IRC to maintain qualification. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's counsel believe the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEES

The investments information included in the accompanying financial statements and the supplemental schedule, in total, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, obtained or derived from information supplied to the Plan Administrator is certified as complete and accurate.

NOTE 7 - FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts reported at contract value) in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The authoritative literature for fair value measurements establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 are unobservable and inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair values of mutual funds have been valued using a market approach and are based on the daily closing price as reported by the respective fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 8 - DEFERRED GROUP ANNUITY

The Empower Investments Fixed Account is a fixed, deferred group annuity available to qualified retirement plans. It provides guaranteed protection of principal with a set rate of return. The guarantee in this contract is backed by Empower Annuity Insurance Company of America (EAICA) and supported by its general account. Participants do not participate in the performance of the general account, but the investment performance of that portfolio supports the contract's minimum guaranteed interest rate (currently 2.16%), any additional amounts, and payout obligations. The interest rates are reviewed quarterly and are subject to change. The contract does not permit the insurance company to terminate the agreement under normal circumstances.

The contract is subject to a market value adjustment if plan level events occur per conditions contained in the signed contract, which may result in a payout less than 100% of principal and interest credited. There are no penalties assessed by this stable value for benefit payments or other withdrawals taken by participants.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 8 - DEFERRED GROUP ANNUITY (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 9 - PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds and deferred group annuity contracts managed by the Trustees and, therefore, these transactions qualify as party-in-interest transactions.

The Advisor is a fiduciary because they give investment advice and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 10 - RISKS AND UNCERTAINTIES

The Plan provides for investments that are exposed to various risks, such as interest rate, credit, and market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities may occur in the near future and that changes could materially affect the amounts reported in the statements of net assets available for benefits.
