### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Mercury Financial LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Mercury Financial LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Plan management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

**1. Description of Plan**

The following description of the Mercury Financial LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan was originally effective January 1, 2015. The Plan was most recently amended and restated effective January 1, 2025 (see Note 10). Voya Retirement Insurance and Annuity Company, an insurance company, controls Voya Institutional Trust Company, the custodian of the Plan, (collectively “Voya”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Eligibility**

The Plan is a defined contribution plan covering substantially all employees of Mercury Financial LLC (the “Company”), except those employees who are members of a collective bargaining agreement and nonresident aliens. Employees are eligible to participate in the Plan on the first day of the Plan year quarter coinciding with or next following the completion of 90 days of service.

**Contributions**

Each year, participants may contribute up to 100% of pretax eligible annual compensation, as defined in the Plan document. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Contributions may also be designated as Roth elective deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan provides for safe harbor matching contributions. The Company makes safe harbor matching contributions equal to 100% of employee salary deferrals that do not exceed 3% of eligible employee compensation, plus 50% of salary deferrals between 3% and 5% of employee eligible compensation, as defined.

The Company may elect to make discretionary matching contributions. No discretionary matching contributions were made to the Plan for the year ended December 31, 2024. The Company may also elect to make discretionary nonelective contributions to the Plan based on a group allocation method. No discretionary nonelective contributions were made to the Plan for the year ended December 31, 2024.

Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

Participants direct the investment of their accounts into various investment options offered by the Plan.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions and safe harbor matching contributions as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions as well as safe harbor matching contributions. Participants vest in discretionary matching contributions and discretionary nonelective contributions over a 6 year graded schedule through which they vest 20% after 2 years with vesting increasing 20% per year thereafter up to 100% after 6 years. Participants also fully vest upon death or disability or attainment of normal retirement age (age 65, or the participant’s fifth anniversary of joining the Plan, if later).

**Notes Receivable from Participants**

The Plan does not allow participants to borrow against their vested balances.

**Payment of Benefits**

On termination of service, retirement, death or disability, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account by transfer to another qualified plan or

individual retirement account or by a lump sum payment. Partial withdrawals are also permitted. If a participant's vested account balance is less than \$7,000 (\$5,000 prior to modification allowed by the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022, "SECURE Act 2.0") upon separation, the Plan administrator may authorize the benefit payment without the participant's consent. In circumstances when a separated participant has a vested account balance less than \$60, the participant's vested account balance shall be distributed in a lump sum. In circumstances when a separated participant has a vested account balance greater than \$60 but less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act), if the participant does not elect to have such distribution paid directly to an eligible retirement plan specified by the participant in a direct rollover or to receive the distribution directly, then the Plan administrator will pay the distribution in a direct rollover to an individual retirement account designated by the Plan administrator.

In-service withdrawals of a participant's vested account balance may be made by participants who have attained age 59½. Additionally, distributions of up to \$5,000 are permitted for childbirth or adoption expenses. In addition, required minimum distributions must begin subject to Internal Revenue Service ("IRS") guidelines. Hardship distributions are not permitted.

## **2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and their activity on a contract value basis (see Note 5).

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and safe harbor matching contributions as well as discretionary matching contributions from the Company, if any, are recorded in the year in which the employee contributions are withheld from compensation. Discretionary nonelective contributions from the Company, if any, are recorded in the year in which the related participant compensation was earned.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Administrative Expenses**

All reasonable administrative expenses and fees necessary to operate and administer the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. A participant's account may be charged for expenses associated with a specific optional feature, elected by that participant, and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

**3. Information Certified by a Qualified Institution**

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Voya Retirement Insurance and Annuity Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, and fully benefit-responsive investment contract, at contract value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments and interest and dividend income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for the pooled separate accounts and the fully benefit-responsive investment contract listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedule.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

*Pooled separate accounts:* All the Plan's assets that are measured at fair value are pooled separate accounts that invest directly in designated mutual funds. Pooled separate accounts are valued at their accumulation unit value ("AUV") by the custodian on a daily basis. The calculation utilizes the net asset value ("NAV") of the underlying fund as well as separate account charges. Given that the separate account charges are not readily available in the market and are a significant component of the valuation, the pooled separate accounts are viewed as level 2 assets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Fully Benefit-Responsive Investment Contract

The Plan holds the Voya Fixed Account (the "Fixed Account"), a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. As of December 31, 2024 and 2023, the contract value amount of the fully-benefit responsive investment contract was \$474,432 and \$884,068, respectively. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

The Fixed Account is a group fixed annuity contract and is backed by the general account of Voya. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The Plan owns a promise to pay interest at crediting rates which are announced in advance and guaranteed for a specific period of time as outlined in the group annuity contract. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Such events may include but are not limited to: transfers from the Fixed Account may not be made directly to a

competing fund as transfers from the Fixed Account will prevent transfers to a competing fund for 90 days; and premature termination of the contract which could result in surrender charges and/or market value adjustments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with participants.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. There are no reserves against the group fixed annuity contract values for credit risk of the contract issuer or otherwise.

## **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## **7. Related-Party and Party-In-Interest Transactions**

Plan investments include pooled separate accounts and a fully benefit-responsive investment contract managed by Voya. Certain expenses are paid to Voya. Voya is the recordkeeper and custodian of the Plan. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

## **8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions for which they were not already fully vested.

## **9. Tax Status**

Effective October 1, 2020, through the adoption of a Nova 401(k) Associates non-standardized defined contribution pre-approved plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the non-standardized defined contribution pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## **10. Subsequent Events**

Effective January 1, 2025, the Plan was amended and restated to remove the 90 day service requirement, change the entry dates from the first day of the Plan year quarter to the first day of the month upon meeting the eligibility

requirements, permit hardship withdrawals up to a maximum amount of \$1,000, and make other general administrative changes to the Plan.

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued.
