Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the A.W. Chesterton Company 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements on the modified cash basis.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of the Plan

The following description of the A.W. Chesterton Company 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan with a cash deferral arrangement established by A.W. Chesterton Company (the "Company") and its affiliate, Chesterton International, Inc. (collectively, the "Companies" or "Employer"). In accordance with the trust agreement, the Employer administers the Plan. The Plan covers all employees who have completed thirty days of service, as defined (the "Participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Substantially all investments are participant-directed.

For the plan year 2022, the plan name was changed from A.W. Chesterton Company Profit Sharing Retirement Plan to A.W. Chesterton Company 401(k) Plan.

Participant Deferral Contributions

Participants may defer up to 75% of their compensation for a Plan year, subject to certain limitations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Subject to approval by the Plan Administrator, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("Rollovers").

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 4% of compensation in a designated balance fund (until changed by the participant) unless they affirmatively elect not to participate in the Plan.

Employer Matching Contributions

The Employer contributes 50% of the first 6% of eligible compensation that a participant contributes to the Plan. For the Plan year ended December 31, 2024, the Company contributed \$1,357,430 to the Plan, which is net of forfeitures of \$170,570.

Employer Profit Sharing Contribution

The Employer may make discretionary profit sharing contributions to the Plan. The contribution shall be allocated as a uniform percentage of the compensation of all participants who earned compensation during the Plan year. A participant is entitled to an Employer profit sharing contribution on the first day of January or July after completion of two years of service and must be employed on the last day of the Plan year. A participant who had a break in service, as defined, or whose employment has terminated at any time prior to the last day of the Plan year, except for normal (age 65) or early (age 55) retirement, disability or death, will not be entitled to any allocation for that Plan year. Participants are always fully vested in the Companies' profit sharing contributions. For the year ended December 31, 2024, the Companies elected not to make a profit sharing contribution, and since an election was made not to have a 2023 profit sharing contribution, there was no Employer profit sharing contribution contributed during the 2024 Plan year.

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and Plan earnings, and reduced by loan fees and an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions and Employer profit sharing contributions and earnings thereon. Participants become vested in Employer matching contributions on the earlier of (a) the last day of the Plan year in which the participant first became eligible to share in the profit sharing contribution, (b) the participant's completion of three years of vesting service (c) the Participant's attainment of his or her normal retirement date, (d) the date of the Participant's death, or (e) the date the participant becomes disabled.

Forfeitures

A participant who leaves the employ of the Employer forfeits any non-vested balance at the earlier of five consecutive one-year breaks in service or when the participant receives a complete distribution of their vested account. The Plan uses forfeitures to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,914 and \$29,245, respectively. During 2024, \$170,570 of forfeitures was used to offset a portion of the Employer matching contributions.

Payment of Benefits

In-service withdrawals from participant vested accounts are permitted only due to financial hardship or upon reaching age 59½. The minimum hardship withdrawal allowed is \$500. Upon termination of employment, a participant may elect to receive either a lump-sum payment or installment payments equal to the vested account balance. In addition, upon termination, if a participant's vested account is less than \$1,000, the Plan administrator, after notification and without consent, may distribute a participant's entire vested account balance.

Notes Receivable - Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. A participant may have up to three loans outstanding at a time. Loan terms are generally up to five years (up to ten years for the purchase of a primary residence). The loans are secured by the vested balance in the Participant's account and bear interest at a reasonable rate of interest to be determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America ("U.S. GAAP"). The principal difference between the modified cash basis and U.S. GAAP is that the Plan recognizes the Companies' profit sharing contributions when received rather than when earned.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the contributions are withheld from compensation.

Use of Estimates

The preparation of financial statements in accordance with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could vary from those estimates.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Unit Values

Individual participant accounts for the common/collective trust are maintained on a unit value basis. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units which are valued daily. The fund earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the participants' accounts are charged or credited with the number of units properly attributable to each participant.

Benefits Paid

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Plan management has evaluated subsequent events through August 8, 2025, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Trustee and Custodian

Plan investments are held primarily in mutual fund accounts and a common/collective trust by the Plan's corporate directed Trustee and custodian, Fidelity Management Trust Company ("Fidelity"). The fair value of the mutual funds and the common/collective trust as of December 31, 2024 and 2023, and all investment transactions, including interest and dividends, and net appreciation in fair values for the year ended December 31, 2024 are reported to the Plan and certified as complete and accurate by Fidelity. Information included in the supplemental Schedule of Assets (Held at End of Year) (Modified Cash Basis) and notes receivable from participants have also been derived from information certified by Fidelity.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level I) and the lowest priority to unobservable inputs (Level III). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level I – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level II – Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level II input must be observable for substantially the full term of the asset or liability.

Level III – Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Common/Collective Trust

A stable value fund that is composed primarily of indirect fully benefit-responsive investment contracts is valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 6 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Market risks include global events such as international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 7 - Related-Party Transactions and Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Management Trust Company is the corporate-directed trustee and custodian of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the year ended December 31, 2024, net direct fees paid by the Plan to Fidelity for administrative services amounted to \$229,346. The Plan also received revenue sharing credits of \$126,726 for the year ended December 31, 2024, which has been offset as a reduction to administrative expenses. Certain employees of the Company are also trustees of the Plan. Notes receivable from participants also qualify as exempt party-in-interest transactions.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Employer may determine.

Note 9 - Tax Status

The Plan uses the Fidelity Volume Submitter Defined Contribution Plan prototype Plan document. The Internal Revenue Service (the "IRS") has determined that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC") and informed Fidelity of such in a letter dated June 30, 2020. The Plan has been amended since receiving the opinion letter. However, the Plan administrative committee believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes is included in the Plan's financial statements.

The modified cash basis of accounting requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
