During our audit procedures, we noted that the employer matching contributions for two participants were not calculated in accordance with the Plan's stated formula. These discrepancies appear to have resulted from data input or reconciliation issues. We understand that the Company is in the process of reviewing and correcting the affected match amounts.

To promote accuracy and consistency in future periods, we recommend that the Plan's sponsor implement a formal reconciliation process that compares calculated employer matching contributions to participant W-2 wages. Maintaining detailed records of individual matching contributions, including gross compensation data, will support the integrity of annual compliance testing performed by the third-party administrator and help ensure alignment with the Plan's provisions.

Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of the Plan as of and for the year ended December 31, 2024, in accordance with GAAS, we considered the Plan's internal control over financial reporting (internal control) as a basis for designing our audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Management has determined it is permissible in the circumstances and has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, as permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements of information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

A *deficiency in internal control* exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A *material weakness* is a deficiency or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the Plan's financial statements will not be prevented, or detected and corrected, on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event, or events, occurring is more than remote but less than likely.
- *Probable.* The future event, or events, are likely to occur

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be significant deficiencies or material weaknesses and, therefore, there can be no assurance that all deficiencies, significant deficiencies or material weaknesses have been identified. We did not identify any deficiencies in internal control that we consider to be material weaknesses.

However, as discussed below, we identified a matter involving internal control and other operational matters that is presented for your consideration. This letter does not affect our report dated September 29, 2025 on the financial statements of the Plan. We will review the status of this comment during our next audit engagement. Our comment and recommendation, which has been discussed with appropriate members of management, is intended to improve the internal control or result in other operating efficiencies. Our comment is summarized as follows:

Employer Match

The Company may elect to make discretionary matching contributions and discretionary profit-sharing contributions each Plan year. For the Plan year ending December 31, 2024, the Company matched 50% of the first 8% of the participants' deferred compensation, that is not in excess of \$5,000. During our audit procedures, we noted that the employer matching contributions for two participants were not calculated in accordance with the Plan's stated formula. These discrepancies appear to have resulted from data input or reconciliation issues. We understand that the Company is in the process of reviewing and correcting the affected match amounts.

To promote accuracy and consistency in future periods, we recommend that the Plan's sponsor implement a formal reconciliation process that compares calculated employer matching contributions to participant W-2 wages. Maintaining detailed records of individual matching contributions, including gross compensation data, will support the integrity of annual compliance testing performed by the third-party administrator and help ensure alignment with the Plan's provisions.
