## Independent Auditors' Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of PPG Health 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## 1. Description of Plan

The following description of PPG Health, (the “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan available to all full-time employees of the Company who have one (1) year of service and are age nineteen (19) or older. The Plan was formed on January 1, 2017 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code (IRC).

### Eligibility

Any employee who is nineteen (19) years of age is eligible to become a participant in the Plan on the first day of the Plan year quarter coinciding with or the next following date he or she completes one (1) year of service.

### Employee Salary Reduction Election

A participant may elect to defer up to ninety percent (90%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitations imposed by the IRC.

### Contributions

#### *Elective Contributions*

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan’s trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15<sup>th</sup>) business day after the month of receipt of the voluntary contribution.

#### *Employer Safe Harbor Matching Contributions*

The Company makes a safe harbor matching contribution in an amount equal to one hundred percent (100%) of the participant’s deferred compensation not in excess of four percent (4%). This safe harbor matching contribution is one hundred percent (100%) vested. The Company may make a discretionary matching contribution in amounts to be determined by the Company.

**Contributions (continued)**

*Rollover Contributions*

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless whether such employee has met the age and service requirements of the Plan.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are 100% vested in their individual deferral, rollover contributions, employer matching contributions, and the allocated earnings thereon.

*Forfeited Accounts*

Forfeitures represent the portion of non-vested employer contributions remaining in the Plan for terminated employees and may be used to reduce the employer matching contribution and to cover the costs of administration of the Plan. Forfeited account balances at December 31, 2024 and 2023 were \$396 and \$0, respectively. There were no forfeitures applied toward employer contributions for the year ended December 31, 2024.

**Distribution of Benefits**

*Upon Retirement*

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Distributions may be deferred until a participant reaches age sixty-five (65) if that participant continues to be employed by the Company. Payment may be in the form of a single lump-sum payment or partial withdrawals.

*Upon Termination of Employment*

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. However, if the value of the vested account balance does not exceed \$7,000, then a distribution will be made regardless of whether a consent was obtained or not.

*Hardship Distributions*

A participant may withdraw money for financial hardship if he or she satisfies certain conditions. Hardship distributions can only be made from salary deferral and rollover accounts which are 100% vested and a participant must be employed with the Employer at the time of the hardship distribution.

**Distributions (continued)**

*Upon disability*

A participant's account is distributable upon a participant's disability. Payment may be in the form of a lump-sum distribution or partial withdrawal.

*Upon Death*

Distributions upon the death of a participant shall be made to his or her designated beneficiary in a single lump-sum payment or partial withdrawals.

**Administrative Fees**

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

**Investment Options**

Upon enrollment in the Plan, a participant may direct his or her elective deferrals to a variety of investment. If a participant does not direct his or her investment, then his or her account will be invested in accordance with the default investment alternatives established under the Plan. Participant accounts are segregated for purpose of determining the earnings or losses on his or her investment options.

**Participant Loans**

Participants may borrow from his or her account with a maximum loan amount not to exceed the lesser of (a) \$50,000 reduced by the excess, if any, of the participant's highest outstanding balance of loans from the Plan during the one-year period or (b) one-half ( $\frac{1}{2}$ ) of a participant's vested account balance. The minimum amount of a loan is \$1,000. A participant may only have one (1) loan outstanding at any time. Principal and interest are repaid by the participant's payroll deductions or checks (only for prepayments). Loans are secured by the balance in the participant's account and bear interest at two percent (2%) over the prime interest rate.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting.

### Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

### Benefit Payments

Benefit payments to participants are recorded upon paid.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Pooled Separate Account*

Pooled separate account ("PSA") invests mainly in domestic stocks or mutual funds. The majority of the underlying securities have observable level 1 quoted pricing inputs. The net asset value ("NAV") of the pooled separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the PSA can be redeemed at NAV as of the measurement date.

*Stable Value Funds*

Share Prices/NAV's reported on the financial statements for stable value funds are generally obtained directly from the fund house or other investment provider.

**4. Information Prepared and Certified by Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (“John Hancock”), a qualified institution, has certified the following investments and notes receivable information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments and notes receivable from participants information included in the accompanying Schedule of Assets (Held at End of Year) as of December 31, 2024.

The Plan’s independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule

**5. Related-Party Transactions and Party in Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$70,843 of recordkeeping fees to John Hancock Life Insurance Company, \$2,200 of third-party administrator fees to NOVA 401k Associates and \$2,916 of investment advisory fees to USI Securities, Inc. during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statement of net assets available for benefits.

**8. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. Date of Management's Review**

Subsequent events have been evaluated through September 4, 2025, the report issuance date.
