## NOTES TO FINANCIAL STATEMENTS

### EnviroScience, Inc. 401(k) Plan

#### 1 Description of Plan

The following description of EnviroScience, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### ***General:***

The Plan, which began January 1, 1997 is a defined contribution plan covering all employees of EnviroScience, Inc. (the “Company”) who meet service time and age requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Plan was amended to allow seasonal employees to participate in the Plan.

Effective September 3, 2024, the Plan Trustee and recordkeeper is T. Rowe Price Trust Company.

Effective January 1, 2025, the Plan was amended and restated to add a safe harbor matching contribution in an amount equal to 100% of the first 3% of compensation contributed by the employee and 50% of the next 2% of compensation contributed by the employee and to allow in Plan Roth rollovers.

##### ***Eligibility:***

All employees of the Company age twenty-one and older are eligible to participate in the Plan, except for employees covered by a collective bargaining agreement, leased employees, non-resident aliens, and temporary employees. Employees must be employed by the Company for one month to be eligible for all contributions.

##### ***Contributions:***

Employee Contributions - New employees are automatically enrolled at 6% of compensation unless they opt out. Participants may elect up to 100% of their compensation to be contributed to the Plan by the Company. Catch-up and Roth employee contributions are allowed by the Plan.

Employer Contributions - The Company matches 50% up to 6% of eligible compensation to each eligible participant's account by matching a percentage of the Participant's elective deferral for the plan year.

Employer Discretionary Contributions - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each Participant in proportion to his or her compensation for the calendar year.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

EnviroScience, Inc. 401(k) Plan

**1 Description of Plan, Continued**

***Contributions, Continued:***

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer matching contributions, employer discretionary contributions, earnings and losses thereon.

***Vesting:***

All participants are 100% vested in elective deferrals, qualified non-elective contributions and rollover contributions made to the Plan.

Vesting in the participant's account balance is based on years of service. A participant is vested in employer contributions as follows:

<u>Years of Service</u>	<u>Vested %</u>
1	20%
2	40%
3	60%
4	80%
5	100%

***Forfeitures:***

Forfeitures due to termination from the Plan before a participant is 100% vested can be used to reduce employer contributions or pay allowable administrative expenses. Forfeitures used for the years ended December 31, 2024 and 2023 were \$30,508 and \$35,169, respectively.

Forfeited non-vested accounts totaled \$5,027 and \$306 as of December 31, 2024 and 2023, respectively. Future employer contributions will be reduced by these amounts.

***Notes Receivable from Participants:***

Loans are permitted under certain circumstances and are subject to limitations. Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans are repaid over a period not to exceed 5 years with exceptions for the purchase of a primary residence. Loans are valued at unpaid principal plus accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

## NOTES TO FINANCIAL STATEMENTS

### EnviroScience, Inc. 401(k) Plan

#### 1 Description of Plan, Continued

##### *Notes Receivable from Participants, Continued:*

The loans are secured by the balance in the participant's account and bear interest at rates established by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

##### *Other Plan Provisions:*

Normal retirement age is 65. After reaching age 59-1/2, participants are able to withdraw from their accounts while still employed by the Company without penalty.

##### *Payment of Benefits:*

Upon termination of service by reason of separation of service, retirement, death or total and permanent disability, a participant receives a lump sum amount equal to the value of his or her account. If a participant's vested account balance is \$5,000 or less, he or she will receive a distribution upon termination as soon as administratively possible. Benefits are recorded when paid.

##### *Investment Options:*

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

#### 2 Summary of Significant Accounting Policies

##### *Basis of Accounting:*

The Plan's transactions are reported on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

##### *Valuation of Investments:*

Investments held in the Plan include mutual funds and money market funds. Marketable securities are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as held during the year.

## 2 Summary of Significant Accounting Policies, Continued

### *Use of Estimates:*

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

### *Administrative Fees:*

Plan expenses are fees for services that are provided on a regular basis, such as recordkeeping and general plan administration. Substantially all administrative fees are paid by the Company.

### *Plan Termination:*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

### *Risks and Uncertainties:*

The Plan's investment holdings include investments in mutual funds common collective trust, and a money market fund with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

The Company adopted a volume submitter profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated August 19, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC") and is, therefore, not subject to tax under present income tax law. The Plan has been amended since the date of the opinion letter. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

## NOTES TO FINANCIAL STATEMENTS

#### 3 Tax Status, Continued

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets.
- \* Quoted prices for identical or similar assets or liabilities in inactive markets.
- \* Inputs other than quoted prices that are observable for the asset or liability.
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

##### ***Mutual Funds and Money Market Fund:***

The fair value of the mutual funds and money market fund are based on quoted market prices. The mutual funds and money market fund are classified in Level 1 of the valuation hierarchy.

**4 Fair Value Measurements, Continued**

*Common Collective Trust:*

The fair value of the Common Collective Trust fund held by the Plan is based on the net fair value of the underlying assets. The underlying investments are valued at fair value based on commercial quotation services. The fair value is allocated among the contract holders based on a unit value. Short-term securities with remaining securities of 60 days or less, are valued at amortized cost. This falls into the Level 2 category of the valuation hierarchy.
