Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of United States Bakery Profit Sharing and 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Note 1 - Description of the Plan

The following description of the United States Bakery Profit Sharing and 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

United States Bakery and Affiliates (the Company) is the Plan Sponsor. The Plan was established to provide a tax-deferred retirement plan for the nonunion employees of United States Bakery, Salt Lake City Bakery, Central California Baking Company, and Gluten Free Baking Company LLC. The Plan is a defined-contribution profit-sharing and 401(k) plan and is administered through a retirement committee chosen by the Board of Directors of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees are eligible to participate in the Plan on the date the employee first performs an hour of service, except employees who are members of the union, leased, or on-call as defined by the Plan. Employees must be employed on the last day of the Plan year to be eligible to participate in the Plan. Employees covered by a collective bargaining agreement may not participate in the Plan, unless the collective bargaining agreement requires participation.

Contributions

Each year, participants may contribute pretax or after tax Roth contributions up to 100% of annual compensation, subject to limits of the tax law as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants are automatically enrolled at a deferral rate of 3% of eligible wages. After automatic enrollment, the participant may elect to change the deferral percentage. Additionally, participant's deferrals are automatically increased by 1% annually on January 1 to a maximum of 10%.

For 2025, the Company has elected to operate as a safe harbor 401(k) plan; as such they made non-elective safe harbor contributions to eligible participants.

The Company may also make discretionary profit sharing contributions which are determined by the Company's Board of Directors. For the year ended March 31, 2025, the Company made profit sharing contributions. The account of each participant who has at least one hour of service in the Plan year and who is employed on the last day of that Plan year is eligible for a profit share contribution. Participants over the age of 60 that retire in a Plan year are eligible for a contribution in that Plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are made in a manner which recognizes each participant's account balance, investment selection and timing of contributions and withdrawals. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Elections

Participants direct the investment of their contributions into various investment options offered by the Plan. Participants have the opportunity to change their investment combinations on a daily basis. The accounts of employees who do not choose among these options are automatically invested in the T. Rowe Price Target Date Funds based on their projected retirement dates.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Additionally, participants are 100% vested in their nonelective (safe harbor) and rollover contributions.

For profit sharing contributions prior to April 1, 2007, a participant would become fully vested in their account after seven years of employment (see vesting schedule below). On April 1, 2007, the Plan was amended to allow a participant to become fully vested after six years (see vesting schedule below) for tier 1 profit sharing contributions. If the participant's request or termination occurred prior to April 1, 2007, the original vesting rules apply. For all participant requests and terminations occurring after April 1, 2007, the amended rules apply.

For tier 2 profit sharing contributions, participants are fully vested after one year of service. The tier 2 vesting schedule applies to eligible employees of Salt Lake City Bakery, who do not report directly to the Company's corporate officers and any other category of eligible employees, as determined by the Board.

In the event of death, disability, or retirement, a participant's account becomes fully vested. In the event that a participant terminates employment prior to completion of the vesting period, the nonvested portion of the participant's account will be forfeited. Such forfeitures can be allocated to remaining participants based on their proportionate compensation or can be used to pay Plan expenses.

Forfeited Accounts

Forfeited accounts are allocated to first pay any administrative expenses of the Plan. Any remaining forfeitures will be used to reduce any employer contributions. The following summarizes the forfeiture activity at March 31:

Subsequent to year end, the Company used \$391,005 of forfeitures to offset the profit-sharing contribution related to the year ended March 31, 2025 (\$177,258 for the year ended March 31, 2024).

Payment of Benefits

In the event of death, disability, retirement, or termination of service for any other reason, benefits may be distributed in a lump-sum amount equal to the value of the account, rolled over into an individual retirement account, or maintained, if over \$5,000, without the ability to receive additional contributions. Accounts with balances less than \$5,000 shall have their funds distributed no later than 120 days after the end of the Plan year in which service terminates.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP), requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. These estimates involve judgments with respect to numerous factors that are beyond management's control. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan permits the payment of Plan expenses to be made from the Plan's assets. Fees are charged to participants on a pro rata basis, equally to participant accounts, or specifically to a participant account for transactions specifically related to that participant.

Risks and Uncertainties

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events

The Plan has evaluated subsequent events through September 18, 2025, which is the date the financial statements were available to be issued.

Note 3 - Information Certified by Trustee

The Plan's investments are held by Matrix Trust Company, the Trustee of the Plan. The Plan Administrator has obtained a certification from the Trustee as of March 31, 2025 and 2024, and for the year ended March 31, 2025, that the following information provided to the Plan Administrator by the Trustee is complete and accurate:

- Noninterest bearing cash
- Fair value of investments
- Net appreciation in fair value of investments
- Dividends and interest income

Note 4 - Fair Value Measurements

Fair value is the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

The Plan follows a fair value hierarchy to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Three levels of inputs may be used to measure fair value:

Level 1 - Quoted prices in active markets for identical assets or liabilities.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 31, 2025 and 2024:

Common Collective Trusts: Units held in collective investment trusts (CIT) are valued using the net asset value (NAV) of the CIT, as reported by the CIT managers, and is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the CIT, minus its liabilities, and then divided by the number of units outstanding. The NAV of a CIT is calculated based on a compilation of primarily observable market information.

Money Market Funds: Valued at cost plus accrued interest, which approximates fair value.

The methods previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6 - Party-In-Interest Transactions

Milliman, Inc. provides third-party administration services to the Plan; Milliman Investments and Morgan Stanley Global Bank provide investment advisory services to the Plan; and Matrix Trust Company provides trustee and custodian services to the Plan. Transactions with these entities qualify as party-in-interest transactions and are exempt from the prohibited transaction rules under ERISA.

Note 7 - Tax Status

The Plan obtained its latest determination letter dated December 15, 2023, in which the Internal Revenue Service (IRS) stated that the Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receipt of the determination letter, but the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirement of the IRC; therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements at March 31, 2025. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
