NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Phreesia, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a single-employer defined contribution retirement plan covering all full-time employees of Phreesia, Inc. (the Company, Plan Sponsor, or Employer) who are not excluded employees, as defined in the Plan document. Employees are eligible to participate in the Plan upon date of hire, as there is no age or service requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan was established on October 1, 2007, and was amended and restated effective January 1, 2015, for regulatory and certain Plan changes. The Plan was last amended and restated effective January 1, 2023, for certain Plan changes.

As of January 1, 2024, Fidelity Workplace Services, LLC (Fidelity) is the Plan's recordkeeper and custodian. Prior to that date, Nationwide Trust Company (Nationwide) was the Plan's recordkeeper and custodian, and The Pension Service was the third-party administrator who provided consulting and advisory services to the Plan.

Contributions

Each year, participants may make pre-tax contributions up to the greater of the amount allowed by the Internal Revenue Code (IRC) or participant's eligible compensation for the Plan year. For the 2024 Plan year, participants may contribute up to 100% of eligible compensation limited to \$23,000, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. All newly eligible employees can elect to enroll in the Plan.

The Company may make matching contributions equal to a discretionary percentage of each participant's elective deferrals. This percentage is to be determined by the Company on a uniform basis for all employees. For the 2024 Plan year, the Company elected not to make matching contributions. Additional profit-sharing amounts may be contributed at the option of the Company's owners. For the 2024 Plan year, the Company did not make any profit-sharing contributions to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. For the 2024 Plan year, the Company made corrective contributions of \$18,474.

Participant Accounts

Each participant's account is credited with the participant's contributions and any Company matching contributions, as well as allocations of the Company's profit-sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's profit sharing and matching contribution portion of their accounts is based on years of continuous service, as follows:

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of application, is in accordance with rates charged by representative commercial banks in the local area, unless the Plan Administrator sets forth a different method for determining loan interest rates in its written loan procedures. All loans had interest rates ranging from 5.25% to 10.50% per annum as of December 31, 2024 and 2023. Principal and interest are paid ratably through monthly payroll deductions over a five-year period, unless it is for the purchase of a principal residence, in which case, the loan repayment period may not extend beyond 30 years from the date of the loan.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum account equal to the value of the participant's vested interest in his or her account, or annual installments over a period that does not extend beyond the joint and survivor life expectancy of the participant and his or her beneficiary. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

Mandatory distributions will be made for participants with vested accounts of \$200 or less, of which the distribution will be rolled over to an individual retirement account if an affirmative election is not made by the participant as to where the distribution should be rolled over.

Minimum required distributions for participants who have reached age 72 also apply, per IRS regulations (70½ if the participant reached 70½ before January 1, 2020).

Forfeited Accounts

The Plan allows for the use of forfeited non-vested amounts to reduce employer contributions or pay for Plan administration expenses. For the years ended December 31, 2024 and 2023 there was \$11,092 and \$0, respectively, available in forfeited account.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the period.

Benefits Payments

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

NOTE 3 - CERTIFIED INFORMATION BY TRUSTEES

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 4 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits.

NOTE 5 - FAIR VALUE MEASUREMENTS

U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that inputs that are most observable be used when available. The input hierarchy is broken down into three levels based on the degree to which the exit price, or the price at which an investor sells an investment and leaves a market, is independently observable or determinable, as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the methodology include:

- Quoted prices for similar assets and liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds (registered investment companies) - These assets are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. The Plan's mutual funds are considered to be Level 1 securities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 7 - RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments of the Plan are managed by Fidelity and, therefore, these transactions represent party-in-interest transactions. Purchases and sales of these funds are open-market transactions at fair market value. Fees paid to Fidelity and The Pension Service are included as part of administrative expenses and qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations,

are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 8 - TAX STATUS

The IRS has determined, through an opinion letter dated March 31, 2014, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

In accordance with U.S. GAAP, Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - NON-EXEMPT TRANSACTIONS

An operational error was identified relating to the calculation of employee contributions during the 2022 Plan year. The Plan Administrator has evaluated the extent of this error and has remediated it as required, during the 2024 Plan year, making a Qualified Non-Elective Contribution to affected participants of \$699. Additionally, in the 2024 Plan year, an error was identified concerning contributions for certain terminated employees. The Plan Administrator resolved this issue in the 2025 Plan year by remitting \$16,872.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued. No material items noted that should be disclosed.
