Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Summary of Significant Accounting Policies

A summary of the major accounting policies followed by the Newmark Homes 401(k) Plan ("Plan") in the preparation of the accompanying financial statements is presented below:

The Plan was initiated on January 1, 2010 as a prototype plan. The financial statements of the Plan are prepared under the accrual method of accounting.

The 401(k) Plan is qualified under Section 401(a) of the Internal Revenue Code and is exempt from Federal Income Taxes under 501(a) of the Internal Revenue Code.

The Company adopted a Volume Submitter Profit Sharing Plan (VSPS Plan) with CODA sponsored by a Third Party Trust Company. The Internal Revenue Service has determined and informed the VSPS Plan Sponsor by a letter dated June 30, 2020 that the VSPS Plan and related trust are designed in accordance with applicable sections of the IRC. The VSPS Plan's opinion letter is being relied on by the Plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. For federal income tax purposes the tax returns essentially remain open for possible examination for a period of three years after the date on which those returns are filed.

The Plan's investments in mutual funds are reported at fair value based on quoted market values of underlying assets. Purchases and sales of securities are recorded on a trade-date basis. The Money Market Fund is valued based on similar instruments.

The participant loans are classified as notes receivable and measured at their unpaid balance plus any accrued but unpaid interest.

The presentation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

2. Investments

The Plan's investments are held by a trust company and are composed of money market and mutual funds. Mutual funds are comprised of stocks, bonds and real estate investments.

3. Plan Participants' Equity

The net assets available for Plan benefits are composed of the trust fund established by the Plan's Trustee for the benefit of the plan participants.

4. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of the company who have completed one month of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

The trustee of the Plan is the plan administrator, who is the managing member of the plan sponsor/Company. Among other duties, the trustee is responsible for overseeing the Plan and evaluating plan management and service providers. Fidelity Management Trust Company serves as the custodian of the Plan's assets. The custodian's duties include receiving contributions, holding and investing fund assets in accordance with the directions of the participants, making distributions as directed by the third party plan administrator, recordkeeping, and transaction processing, including maintaining complete and accurate account records for all plan participants, allocating contributions and earnings, posting distributions and forfeitures to participant accounts, and preparing participant statements and reports. Fidelity Investments Institutional Operations Company, Inc. serves as the third party administrator responsible for plan administration, compliance, maintaining records for participants, and preparing the Plan's annual form 5500.

Contributions

For 2024 and 2023 participants may contribute a percentage of their annual wages up to the federal mandated limit of \$23,000 and \$22,500, with an additional \$7,500 catch-up contribution for employees at age 50 by the end of the year. Participants may also roll over amounts into the Plan from other qualified plans.

The Plan provides that the Company will contribute matching contributions of 50% of the employee's deferral up to 8% of the employee's plan wages during each pay period. The maximum combined contributions for employer and employee are not to exceed \$69,000 in 2024 and \$66,000 in 2023.

4. Description of Plan (Continued)

The Plan also allows for discretionary employer profit sharing contributions that are determined and funded on an annual basis. For the years ended December 31, 2024 and 2023, the Company did not make a contribution.

Participant Loans

Loans are treated as participant directed investments. Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum cannot exceed limits specified by the Internal Revenue Service (IRS) for the outstanding balance of all other loans made to the participant by any other plan maintained by the Employer or a related company. Loan terms may not exceed 5 years, except for the purchase of a primary residence, and principal and interest is paid weekly and semimonthly through payroll deductions. The loans are collateralized by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the plan administrator. At December 31, 2024 and 2023, interest rates on outstanding loans range from 5.25% to 10.50%.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always 100% immediately vested in amounts contributed from their salary deferrals and from employer contributions.

Forfeitures

Forfeitures result from nonvested benefit payments remaining in the Plan for all terminated employees. Upon reaching the break-in service requirement as defined by the Plan agreement, forfeitures generated are added to the forfeiture reserve balance and can be used to reduce future employer contributions or plan administration expenses. Total forfeitures for 2024 and 2023 was \$-0- and \$343, respectively. At December 31, 2024 and 2023, the total forfeited non-vested accounts that have not been applied totaled \$2,401 and \$2,289, respectively.

Administrative Charges

All administrative expenses of the Plan, except amounts paid for certain investments, advisory services and bank charges, are paid by the Company.

Payment of Benefits

On termination of service, a participant will be entitled to receive 100% of their account balance in either a lump sum amount or in annual installments over a specified period of time.

A participant may at any time file for a hardship distribution based on account of an immediate and heavy financial need.

In-Service distributions may be made to a Participant who has not separated from service provided the participant has attained the age of 59 1/2.

5. Continuation of the Plan

The Company plans to continue the Plan indefinitely, but has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

6. Participant Directed Investments

Investments held by the Plan represent participant-directed accounts where individual participants decide how funds held in trust for them are allocated among various investments. Participants should see the Fidelity Investment's website for the available investment choices.

7. Party-in-Interest Transactions

Certain plan investments are in funds managed by Fidelity Management Trust Company, an entity that is a party-in-interest with respect to the Plan. These transactions are exempt and covered by the Prohibited Transaction Exemption provisions of ERISA and the Code.

The Company provides certain accounting, administrative, and investment management services to the Plan for which no fees are charged.

8. Fair Value Measurements

The Plan's mutual fund accounts are reported at fair value in the accompanying statement of net assets available for benefit. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs are other than quoted prices that are observable; and Level 3 inputs are unobservable inputs used for valuing the asset and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

9. Certification Information

As permitted by 29 CFR2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, information prepared and certified by a qualified institution, which is regulated, supervised and subject to periodic examination by a state or federal agency, need not be audited. The plan administrator has obtained certification from Fidelity Management Trust Company (custodian) that all information provided by them is complete and accurate. Information included in the accompanying financial statements and notes to financial statements as to investments, net appreciation (depreciation) in fair value of investments, interest income and all information in the Supplemental Schedule H, line 4i, Schedule of Assets (held at year end), is presented solely upon reliance on those certifications. The independent auditors did not perform auditing procedures with respect to this information except for comparing such information to the related information in the financial statements, notes to financial statements, and supplemental schedule.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, credit and overall volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. Subsequent Events

Subsequent events were evaluated by management through September 22, 2025 which is the date the financial statements were available to be issued. No additional disclosures were considered necessary.
